Southern Interior Local Government Association Annual General Meeting
Councillor Coomber reported that she attended the virtual SILGA Annual
General Meeting. She reported that there are three resolutions of interest to
Council. The first of these was a resolution regarding Flood Mitigation
Response put forward by the Okanagan Similkameen Regional District. It
was asking UBCM lobby the Province to develop programs that take a
proactive approach to flood mitigation rather than continuing to try to
download additional responsibilities on local governments that are illequipped and lacking in financial capacity to address these situations in a
proactive manner that best respects the residents and the environment.

The second resolution of interest was the Vacant Land Property Tax Resolution brought forward by the District of Lillooet that UBCM request the Province to conduct a review of the *Community Charter* to amend the legislation to grant municipal councils' authority to add a 'vacant land' property tax.

The third resolution of interest is related to Fire Apparatus Maintenance for Small Geographic Fire Departments. It asks the Provincial Government to urge the Fire Underwriters to allow small municipalities with small geographic areas to operate their well maintained and low mileage fire apparatus beyond 20 years as their first response apparatus.

## H) Landfill Advisory Committee

## 1) <u>Landfill Advisory Committee Meeting</u>

Councillor Coomber reported that the landfill gas and leachate have been declining since their peak in 2017. Belkorp has purchased 15 new B trains and are looking at shredding garbage at the source so they can transport more volume of waste at a time. In 2020 they brought 4,252 tonnes of municipal solid waste to the landfill. They hope to increase that volume moving forward.

Councillor Peters reported that the snowpack appears to be gone for the Creek and the risk of flooding should be done in terms of melt. The Bonaparte is still being watched.

## 9. **QUESTIONS FROM THE PUBLIC:**

A member of the public asked if the Village plans to fix the path in the park and when will the public washrooms at the park be open? Mayor Talarico responded that CFO Martini will look into it.

A member of the public asked how much the Village is paying for the Tesla Chargers? CFO Martini responded that the only cost to the Village associated with the installation of the Tesla Chargers was some wages associated with staff time in the office and with Public Works, all other costs are being paid by Tesla.

A member of the public asked when Council will have a code of conduct and if the Village has a Bullying and Harassment Policy? Mayor Talarico responded that that would not be discussed.

A member of the public asked what the amount allocated to recreation is used for as the pool is closed, the park is in disrepair and the washrooms are not open. CFO Martini

responded that the detailed version of the budget will be available at a later time and the public will be able to see the breakdowns of each budget item.

A member of the public asked how council intends to spend the COVID-19 restart monies. Mayor Talarico reported that there has been some discussion on the spending of the COVID-19 restart fund and it was thought it would be good to keep in the bank in the even that COVID-19 persists into the future for any extended time so that money can be used when needed. Some has been spent on some Fire Department safety equipment but the remainder will be kept until COVID-19 is under control.

A member of the public asked when a new CAO will be hired and why CFO Martini is acting CAO when she is stating she is too busy to apply for grants. CFO Martini responded that the Village is in the process of recruiting. The posting closed on Friday, April 30<sup>th</sup> so now the applications will be reviewed and Council will make a decision.

A member of the public asked could the COVID-19 fund have been used for the pool? CFO Martini responded that no, they could not.

A member of the public asked for clarification between the 20% municipal tax levy increase in the slide show and the 30% increase listed in the agenda. CFO Martini responded that it is a 10% increase in assessed value and a 20% municipal levy increase for a total of a 30% increase.

- (e) the acquisition, disposition or expropriation of land or improvements, if the council considers that disclosure could reasonably be expected to harm the interests of the municipality;
- (f) law enforcement, if the council considers that disclosure could reasonably be expected to harm the conduct of an investigation under or enforcement of an enactment;

- (g) litigation or potential litigation affecting the municipality;
- (h) an administrative tribunal hearing or potential administrative tribunal hearing affecting the municipality, other than a hearing to be conducted by the council or a delegate of council;
- (i) the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;
- (j) information that is prohibited, or information that if it were presented in a document would be prohibited, from disclosure under section 21 of the Freedom of Information and Protection of Privacy Act;
- (k) negotiations and related discussions respecting the proposed provision of a municipal service that are at their preliminary stages and that, in the view of the council, could reasonably be expected to harm the interests of the municipality if they were held in public;
- discussions with municipal officers and employees respecting municipal objectives, measures and progress reports for the purposes of preparing an annual report under section 98 [annual municipal report];
- (m) a matter that, under another enactment, is such that the public may be excluded from the meeting;
- (n) the consideration of whether a council meeting should be closed under a provision of this subsection or subsection (2);
- (o) the consideration of whether the authority under section 91 [other persons attending closed meetings] should be exercised in relation to a council meeting.
- 91 (2) If all or part of a meeting is closed to the public, the council may allow a person other than municipal officers and employees to attend,
  - (a) in the case of a meeting that must be closed under section 90 (2), if the council considers this necessary and the person
    - (i) already has knowledge of the confidential information
