 Fire Department Member Recognition Mayor Talarico wished to recognize the service of Cache Creek Fire Department members Dale Fitzgerald and Ed Gidinsky for their years of service. Both have moved out of town and so have had to resign from the Fire Department.

G) Intergovernmental Relations

- 1) <u>Meeting with Minister of Transportation and Infrastructure</u>
 - Councillor Coomber reported that she, along with Councillor Peters and CAO Dalsin had a Ministerial Meeting the Morning of September 14th, with Claire Trevena, Minister of Transportation and Infrastructure. Discussions included the need for a bridge to replace the culvert under Highway 97 and the need to give the Cache Creek more room to flow without affecting our roads. Her response was that the government will monitor the situation. The second concern brought up was the potential to make the north end bridge four lanes wide. Minister Trevena stated they did not have plans to do anything to the bridge but they may be able to help in a relocation of the sewer line that crosses the Bonaparte River.
- 2) Town of Comox Request for Letter of Support

MOVED by Councillor Coomber SECONDED by Councillor Peters THAT Council receive and file the letter from the Town of Comox. CARRIED UNANIMOUSLY

3) <u>Ashcroft Terminal Working Group</u> Mayor Talarico reported that the outcome of the working group is two recommendations to be presented to the PSA Group: that they pursue enhanced walking trails or a public access boat launch. The Slough Society will continue to pursue continued access to the Slough outside of the Working Group.

8. **NEW BUSINESS:**

A) School Zone Signs

Councillor Pittman asked for an update regarding school zone signs for Quartz Road and Stage Road. CAO Dalsin reported that he spoke to Public Works and the signs have been ordered but have not arrived yet.

B) <u>Shared Bylaw Enforcement</u>
 Mayor Talarico reported that the Village of Ashcroft is hoping to engage with the
 Village of Cache Creek and The Village of Clinton with a shared responsibility and

shared cost Bylaw Enforcement Officer.

9. QUESTIONS FROM THE PUBLIC:

Barbara Roden asked if Councillor Pittman had produced her tax reminder letter. Mayor Talarico responded that a letter that was different was not submitted, the letter that was submitted was the same as that sent to all tax payers with outstanding balances on their accounts.

In regards to the Cannabis Legislation project, Barbara Roden asked what the status of the Wander Inn is. Mayor Talarico responded that it is ongoing.

Barbara Roden further asked why it is so difficult to find the status of a business in the middle of town. Do they have a business license? Mayor Talarico responded that they do not have a business license. CAO Dalsin further responded that the Village cannot prove there is a business operating in the building. Mayor Talarico responded that it is a topic we hope to be able to deal with through developing cannabis and hemp legislation for the community. Barbara Roden further asked if the RCMP are able to go in and ask to see a copy of any of their licenses. Mayor Talarico responded that there is ongoing work happening to deal with the Wander Inn.

Barbara Roden asked if it will be advertised that members of the public may request to attend Council meetings and these applications will be evaluated on a case by case basis. Mayor Talarico responded yes that is the intention.

Gareth Smart asked that, in regards to the Community Foundation, what would happen if the interest rate dips below 3%. Councillor Peters responded that they are required to pay 3% interest and must continue to do so even if the rate is reduced. Gareth Smart further asked if the money could be removed at a later date if Council so chose. Councillor Peters responded that the money is an endowment to the foundation and so cannot be taken back out.

Gareth Smart asked if the Mayor has the authority to remove Councillor Pittman from the acting mayor rotation. Mayor Talarico responded that yes, he has that authority, and further that Councillor Peters would take over as deputy mayor in the place of Councillor Pittman for the term of December 2020 to November of 2021.

- (f) law enforcement, if the council considers that disclosure could reasonably be expected to harm the conduct of an investigation under or enforcement of an enactment;
- (g) litigation or potential litigation affecting the municipality;
- (h) an administrative tribunal hearing or potential administrative tribunal hearing affecting the municipality, other than a hearing to be conducted by the council or a delegate of council;
- (i) the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;
- (j) information that is prohibited, or information that if it were presented in a document would be prohibited, from disclosure under section 21 of the Freedom of Information and Protection of Privacy Act;
- (k) negotiations and related discussions respecting the proposed provision of a municipal service that are at their preliminary stages and that, in the view of the council, could reasonably be expected to harm the interests of the municipality if they were held in public;
- discussions with municipal officers and employees respecting municipal objectives, measures and progress reports for the purposes of preparing an annual report under section 98 [annual municipal report];
- (m) a matter that, under another enactment, is such that the public may be excluded from the meeting;
- (n) the consideration of whether a council meeting should be closed under a provision of this subsection or subsection (2);
- (o) the consideration of whether the authority under section 91 [other persons attending closed meetings] should be exercised in relation to a council meeting.
- 91 (2) If all or part of a meeting is closed to the public, the council may allow a person other than municipal officers and employees to attend,
 - (a) in the case of a meeting that must be closed under section 90 (2), if the council considers this necessary and the person
 (i) already has knowledge of the confidential information
