The remaining 20% is often a crippling amount for small communities with small tax bases. Councillor Coomber requested a change in definition for rural communities and adjust the percentage of responsibilities for communities with populations below 5000. The response was that Disaster Financial Assistance is regulated at 80% but the

Emergency Program Act is being updated and new legislation is planned for October 2022.

Councillor Coomber made a verbal report regarding a call the Ashcroft Village Council had with Minister for Health Adrian Dix that she was able to take part in. They spoke about staffing challenges at the Ashcroft Hospital and elsewhere in the Province. There were discussions regarding the urgent primary care model that the Interior Health Working Group is working on with representatives from Ashcroft and other health care departments. Minister Dix reiterated that the NDP are committed to team-based care.

Councillor Coomber submitted a report outlining all of the workshops and meetings she took part in during the 2021 UBCM Virtual Conference. She stated that the Pathways to Truth and Reconciliation session was very good. Councillor Coomber stated that the September 30th Truth and Reconciliation Day gives an opportunity for local government to use their voices and add to the push forward.
