LANDSCAPING

Our landscaping survived monsoon season well! Spring tree trimming helped prevent any unexpected tree damage. An irrigation valve needed to be replaced for \$300.

WALK-AROUND

The annual walk-around will be coming up in February. Now is the time to spruce up your homes. If you need paint chips or have any questions, please call the property manager.

BOARD MEMBERS

There are currently 2 Board members. The Bylaws require a Board of 3-5 people. We need 1-3 people to volunteer to be on the Board of Directors. The strength of a community is in the people who are willing to work together to make it a great place to live - 1 or 2 people cannot do it alone.

SOLAR PANELS

Solar panels are structural additions to a residence. Per the DCC&Rs, this requires approval by the Board of Directors/ARC committee PRIOR to installation. The installer needs to ensure that all electrical boxes, wiring, tubing, etc is placed on inside walls (ie, inside garage walls). Please contact the property manager if you are considering solar panel installation to help clarify this.



DUES INCREASE

In 2011, monthly dues were decreased from \$47.50 to \$45 when the Board hired a part-time property manager to replace the full-time manager. Dues have stayed the same for over 5 years even though maintenance fees have increased (utilities, waste management, landscape, general maintenance). We have also returned to a full-time property management company. Therefore, the Board has approved a dues increase beginning January 1, 2017. The new fee will be \$50/month.

COUPON BOOKS

CADDEN charges \$5.25 for each coupon book they provide. The HOA has previously absorbed this cost. Since coupon books are not a necessity (the information can be printed on the check), and not all homeowners use them (many pay electronically), it was approved for CADDEN to charge the homeowners for coupon books; they will only be provided upon request. As an alternative, a printable coupon sheet is attached to the newsletter. If you would like to arrange for electronic bill pay, please call Dean Kelsey at CADDEN for assistance.
