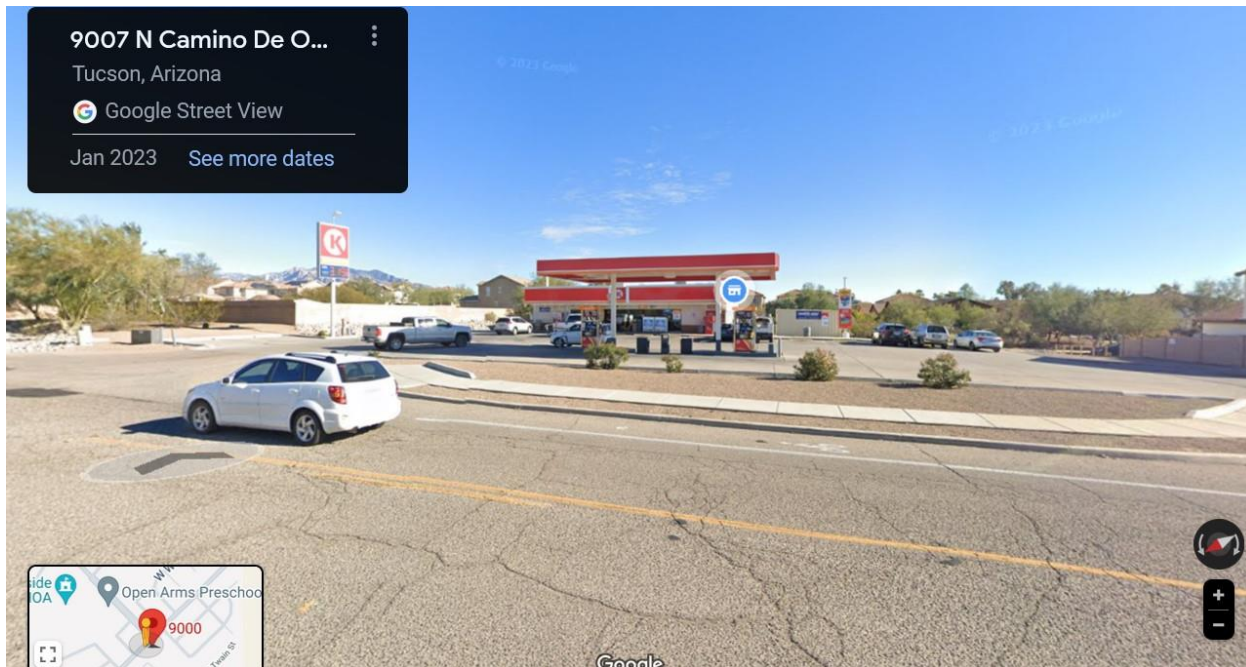


## REPORTS SENT INTO PIMA CLICK N FIX: May 7, 2024

### Requesting cross walk or stop light to safely cross Camino de Oeste

#### Description

On behalf of the 4 subdivisions in this area we request there be either a light or a stop with a crosswalk for pedestrians (near 9000 N Camino de Oeste and N Bald Eagle Ave).

Camino de Oeste (between 4954 W Doria Drive, 9000 N Camino de Oeste, up to Linda Vista Blvd) was basically a farm road; pedestrians and horses safely crossed, as it had very little vehicle traffic. Now 35 years later with the addition of new subdivisions, Camino de Oeste has become a major thoroughway--many driving 40-50 mph with no where for pedestrians to safely cross.

We applaud PIMA Roads addition of the new bicycle lane, but there's no solution for pedestrians traveling by foot. No safe crossing for pedestrians walking to access the elementary school, community center, and Circle K.

We suggest a light or cross walk at 9000 N Camino de Oeste (possibly between the two driveways of Circle K) or another location you suggest, or possibly between at N Bald Eagle Ave 85742. (N Bald Eagle Ave is across the street from Circle K).

Years ago (circa 2008) a lady was killed in the morning by a hit and run driver while she was trying to cross Camino de Oeste after getting a coffee at Circle K at 9000 N Camino de Oeste. Now 16 years later and traffic is more increased and impossible to cross Camino de Oeste safely.
