We are heartbroken to share the sad news of the passing of our Manager, friend, and colleague, **Belinda Taylor of BT Taylor Enterprises**. Belinda was a vital part of our community, serving as Countryside Villas HOA Manager spanning over 14 years, from March 2011 to October 2015; and from December 2022 to December 2025.

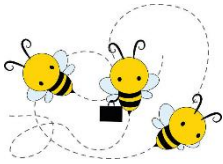

## The Transition to New Management: Starting Feb 1, 2026

*Ensuring Continuity and Professionalism for Countryside Villas*

Due to the sudden and tragic passing of **Belinda Taylor**, the Association is in a period of transition from **January through February 2026**. This plan ensures community operations remain stable while the new management team gets fully acclimated.

### Interim Management

Until our new management is officially in place, the Board of Directors will continue to oversee essential operations. Citizens Bank has assured us that all current deposit procedures remain **unchanged** until the transition is complete. **The bank will continue to deposit checks into the community's secure lockbox account without disruption.** Additionally, all monthly bills (Trash, Water, Electric, Landscaping) are on auto-pay so there won't be any disruption of services.

**For Dues Payments: NOTE:** We are keeping the same bank [Citizens Bank]

- **Continue to make your payments in the same manner as before**
- **Same Bank [Citizens Bank]:** Our banking relationship with Citizens Bank will remain unchanged
- **Same Payment Mailing Address:** Countryside Villas, PO Box 63215, Phoenix AZ 85082
- **Same Online/Debit Format:** No changes to your current online portal or debit processing
- **Monthly Statements** are on pause until the transition is completed, please just continue to make your payments as usual
