In 2021, the Alturas Rotary Community Foundation (ARCF) celebrated seven years of service to our community. In the financial year ending December 31, 2021, the ARCF distributed over \$20,000 for community projects and educational scholarships. This report highlights our 2021 fundraising, charitable giving, and status of the John Wall Estate funds.

2021 HIGHLIGHTS

- Received \$14,658 from donations, raffles, and earned income
 - Direct Public Support \$4,831
 - Raffles \$1,380
 - Investments \$8,447



Honoring John Wall's gift to our community

- Donated \$20,346 to our community
 - \$8,130 Rotary Club of Alturas: Community projects and educational scholarships.
 - \$12,216 (John Wall Trust) Ballfields: Backstop wall, scoreboard, and entrance poles. As of June 1, 2021, the work at the Youth Park by the Rotary Club of Alturas is complete; further work is at the discretion of the City of Alturas.
- Status of John Wall Funds
 - The John Wall Estate gifted 28% of his estate, \$2,487,539, to the Rotary Club of Alturas for the construction, repair, and maintenance of the Youth Park.
 - Rotary invested \$2,683,060 in three significant elements of the Youth Park: Junior Livestock Show Grounds, Alturas Skate Park, and the Rotary Ballfields.
 - ARCF investing strategies produced more than \$320,000 of income, which allowed spending an additional \$195,521 on the Youth Park project.

 - Edna Brown Trust (restricted) \$80,700
 - Rotary Club of Alturas \$134,822
