Securities and mutual fund shares that are actively traded on recognized stock exchange in the United States may be accepted as gifts to ARCF.

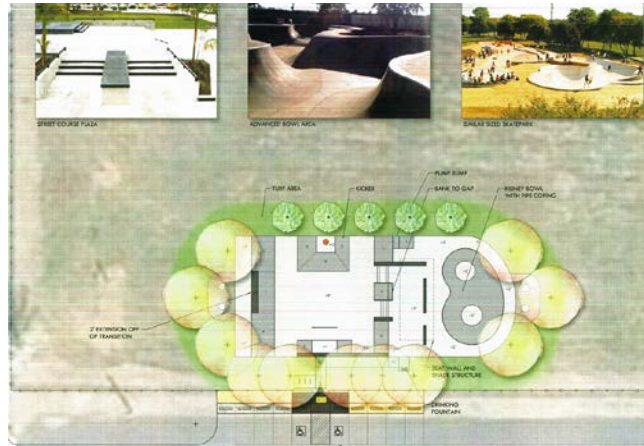
Other Assets
