- An interactive meeting shall be considered to be held on the day that the interactive activity is posted.
- 3. (c) Change of Meeting. For good cause, the board may change a regular meeting to any day between the preceding and following regular meetings, to a different time of the regular day, or to a different place.
- 4. (d) Cancellation. The board may cancel a regular meeting for these reasons:
  - 1. (1) a holiday, or during a week that includes a holiday;
  - 2. (2) in observance of the death of a member;
  - 3. (3) an epidemic or a disaster that affects the whole community; or
  - 4. (4) an armed conflict in the community.

The Board may cancel up to four regular meetings a year for causes not listed here, but may not cancel more than three consecutive meetings.

Until the California "Stay at Home" Order is lifted we will not be holding our regular weekly meetings. We do however have business to conduct. - 1. The reallocation of the \$50,000 Maintenance Fund, therefore moving those funds into the remaining (budgeted) Funds making the amount available \$100,000.
- 2. Transferring \$80,000 unrestricted club funds to meet the final payment of the Youth Park Completion.

#### Fellow Rotarians,

The Youth Park Operations Committee can see the finish line in sight. We are coming to the end of the project and we find that we are short 2% of the approved budget. A few of the reasons are:

- JLS Grounds Additional \$15,000 for drainage at the wash rack and the Public address (PA) system.
- West C Street Additional \$18,000 for base rock and replacement of the high school field main water line.
- West C and 4<sup>th</sup> Streets Parking Additional \$5,000 for dirt work and base rock.
- Alturas Skate Park Additional \$10,000 for an 8" water mainline.
- Nagle and 4th Streets Additional \$20,000 for curb and gutter, sidewalk, drainage, and ADA requirements.
- Youth Park Additional \$6,000 for electrical work.
- Youth Park Additional \$10,000 (as per Joe Picotte, City of Alturas Public Works Director), drain inlets.

The numbers presented below are rounded. The Committee has:

- +\$50,000 remaining approved funds
- +\$50,000 maintenance fund
- +\$140,000 unrestricted club funds (March 25, 2020)
- =\$240,000 total available funds
- -\$180,000 will finish up the project
- \$60,000 remaining unrestricted club funds

In addition to the remaining \$60,000 funds the club has:

\$50,000 Edna Brown

#### The \$180,000 will fund:

- Paved asphalt pathway, cement, seed, irrigation, and labor.
- Discussion/Action: The Committee requests permission to divert the \$50,000 allocated for maintenance into the project.
  We feel, while working closely with the City of Alturas, we have been able to reduce the maintenance requirements for the park. The City is entering into a fee for usage schedule for users which will help offset the City's expenditures. We also believe the Rotary Club of Alturas has worked on this area for 30 years and will continue to do so in the future.
- 2. Discussion/Action: The Committee requests the Club allocate \$80,000 of unrestricted club funds to finish the project.

We need a decision as soon as possible and suggest a club vote initiated by Club President Sandy via email/text messages. It is imperative to get this vote ASAP so that we have clarity on how to proceed with final closeout of this project.
