- **Patient journey (Cash Pay Clinical Services):**

Initial patient-provider async intake (primary pathway) or prescheduled sync visit (secondary pathway) to complete intake review, order labs, order initial medication (as appropriate)

- For overweight individuals (BMI: ≥ 27): Assuming patient is eligible and there are no indicators that labs are immediately necessary, labs can be done after starting on medication. A compound GLP-1 can be prescribed (as appropriate). Labs will be ordered for patient.
- Note: current age limits for initiating new patients (18-74), may remain on program >74 based on individual patient evaluation

30 Day async intake and review of labs and process refill if eligible, with clinician/patient option for prescheduled sync video consults as merited

- Thereafter, async monthly review until steady state dosing is reached, with clinician/patient option for prescheduled sync video consults as merited
- Once steady state dosing is reached, async visit (with pre-filled async follow-up intake) at a quarterly cadence, with clinician/patient option for prescheduled sync video consults as merited

**In most cases depending on the medication used, patient profile, and provider discretion, CMP/TSH/lipid panel/A1c will be repeated at 12 month intervals in normal patients. However, if baseline labs reflect an abnormality or based on provider discretion, certain labs will likely be recommended at a more frequent interval.*

** If prescribing a GLP-1, also prescribe an optional supply of ondansetron for nausea that patient can pickup from retail pharmacy if they choose.*

- **Patient journey:**

- Initial Medical Weight Loss Care Coaching session scheduled during initial patient signup for the MWL program, for ~14 days (ie. first 1-2 doses of medication)
- Each follow up session is scheduled at the end of current session for 2 weeks later unless patient desires different cadence.
- Concierge and care coach team outreaches to patients to offer support and maintain appointment rhythm for patients- all at patient's discretion and according to patient's personal preferences, including if the patient wants to pause participation.

- **Care Coaching Components:**

- MWL Care Coaching is medically-centered around the patient's medical treatment and non-medication goals, and provided by Certified Medical Assistants
- Each patient's personal Care Plan is crafted and evolves over time through live discussion between the patient and their Care Coach, and is documented in their personal medical record for both the patient and supporting doctors' reference. This allows the most current version of the Care Plan and charting notes to be surfaced to patients in the Rewaken's member interface.
- The feel is "supportive and caring" while being "attentive and action-oriented."
- The goal is for patients to feel that someone truly cares about their MWL journey and is able to share helpful information across the patient's full journey while helping the patient set and work towards goals that they personally set for themselves.
- Each session has three core elements:
 - Review of underlying MWL program: side effects, medication adherence, progress on weight and bio-markers.
 - Review of prior Care Plan and goals with updates reviewed.
 - Introduction of new Care Coaching Module, and how it layers into the existing Care Plan and goals set by the patient.
- Following each session, easy to digest summary material is provided to patient from the new Module reviewed.
- Modules evolve over time, but have core components including: side effect mitigation and management techniques for GLP-1 patients, multiple modules around different aspects of nutrition as it relates to GLP-1 patients, lifestyle and exercise from medical weight loss perspective, emotional over-eating and strategies to manage, stress management and how it interplays with MWL, sleep hygiene and strategies as they relate to MWL, social strategies and impacts on MWL including approaches to holidays, entertaining, eating out, etc.

Patient journey (Cash Pay Clinical Services):

- Step 1: patient completes comprehensive intake which is reviewed by Rewaken Life expert clinician (async primary), or as merited prescheduled video consult for example in states that require), order initial medication (as appropriate)
- Step 2: Month 1 (or sooner if patient requested based on symptoms and side effects) async intake review to complete refill intake, adjust medication levels (with patient/clinician option for prescheduled sync visit)
 - Note: any time there is a medication change, and refill intake review will be required four weeks later

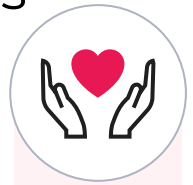
