## **Privacy Policy:**

**Governing Law And Jurisdiction**: The provisions of these Terms and Conditions shall be governed by and construed in accordance with Indian law. All disputes, if any, arising out of or in connection with, or because of these Terms and Conditions or otherwise relating hereto, shall be subject to the exclusive jurisdiction of the competent courts/tribunals in India only.

**Severability**: If any one or more of the terms and conditions mentioned here are for any reason held to be invalid, illegal, or unenforceable by a court of competent jurisdiction, the remaining terms and conditions will be unimpaired and will remain in force and effect.
