# HOW TO DEAL WITH THE POLICE?

Police officers can stop you and ask you questions, but unless they are arresting you or detaining you for the investigating of a crime they will have to let you go after questioning. If you are pulled over or stopped by the police in connection with driving under the influence of alcohol or drugs, you can potentially face arrest for a criminal offence if you refuse to blow into a breathalyzer (an ASD - "Approved Screening Device").

One of your main rights when being investigated or facing an arrest is the right to consult and retain a lawyer. The police have a duty to arrange for you to speak with a lawyer. If you want to make a statement, you should wait until you have talked to a lawyer.

If you are concerned about your immigration status and interaction with police you should seek legal advice from an immigration lawyer.

## YOUR RIGHTS AS AN EMPLOYEE

Your rights are protected under the Employment Standards Act, which deals with matters such as:

Minimum Wage Hours of work

If you believe your rights have been denied, you can file a claim under the Employment Standards Act within 2 years of the abuse of your rights. It is against the law for your employer to harass you after the filing of your claim.

# LANDLORD AND TENANT ISSUES

As a Tenant, you have Rights. If you are unsure or are having issues with your Landlord, Sukhmani Haven can provide guidance.

#### SIGNING A LEASE WITH A LANDLORD

When leasing, ensure that you sign a Contract with your Landlord stating:

- How long you will be renting (i.e. 1 Year)
- The amount of Rent in Canadian Dollars
- Services that are included in the rent
- Services you will be paying during the rental period

#### **DEPOSITS AND LANDLORD VISITS**

Do not pay a Security Deposit. Landlords must provide 24 hour notice to visit the rental unit.

### **RENT INCREASE**

- Landlords can increase rent once a year
- The yearly rent increase guideline is set by the Ontario Government
- The 2025 rent increase was 2.5%
- Landlords must provide a written notice of rent increase 90 days before the increase takes place

### **EVICTION**

Landlord can only evict for a few reasons:

- Requires personal possession
- Tenant did not pay rent

You do not have to move out if you feel the eviction is unlawful.

If you are facing wrongful eviction you can file an application with the Landlord Tenant Board and they will decide if the eviction will proceed.
