As used herein the following shall apply:

- A. Words in the text which are underlined indicate additions to the present text.

- C. Whenever an ellipsis (. . .) appears in the text this indicates that this portion of the present text remains intact to the point where the next typewritten material appears.

Article XI, entitled, "Provisions Relating to Sale or Rental or Other Alienation or Mortgaging of Condominium Units", of the Declaration of Condominium, A. is further amended as follows:

Any attempt to sell, rent or lease said unit without prior offer to the Association shall be deemed a breach of this Declaration and shall be wholly null and void, and shall confer no title or interest whatsoever upon the intended purchaser, tenant or lessee.


The resale of any unit for speculation purposes is prohibited. No unit may be purchased for the sole purpose of renting as an income property. Rentals by resident unit owners complying with the provisions of the first paragraph of Article XIII of this Declaration, will be permitted on a 4-month consecutive basis, once annually, will be permitted, based on hardship and approval by the Board of Directors, once only, for a minimum of four (4) months, maximum one (1) year. Personal interview of prospective purchasers, occupants, (or lessees, where applicable) by the Board of Directors, will be required, except where such interview will create an undue hardship.

WE HEREBY CERTIFY that the above amendment does not affect the interests of the lessor of the long-term recreational lease. We further certify that said amendment was duly and properly presented to the unit owners of this Condominium at a duly called meeting wherein in excess of three-fourths (3/4) of the total membership voted to approve said amendment.


