**Please read this contract carefully. It will cover any and all questions. This contract is followed strictly.**

**The parties hereto agree that the fostering parties shall abide by the following conditions;**

1. agrees that the dog will not be tethered outside for more than 1 hour a day
2. The dog will have yearly vaccinations and monthly heartworm preventative and flea medication
3. If there is a change in address, phone number or other information you will notify Frenzy Animal Rescue ASAP, so the information can be changed.
4. You are not allowed to sell, give away or surrender this dog to any other rescue or shelter or person. If for some reason you can't keep the dog you will have to return to Frenzy Animal Rescue.
5. You agree that you will not hold Frenzy Animal Rescue or any of its volunteers liable for any actions of the dog once contract is signed.
6. You understand that Frenzy Animal Rescue has told you everything they know about the dog and they are not responsible for any health or behavior issues once this contract is signed.
7. You agree that if Frenzy Animal Rescue has to forcefully retrieve the dog back you will have to pay a \$100.00 surrender fee plus any court cost and lawyer fees.
8. You understand that Frenzy Animal Rescue stays owner of the dog until an adoption occurs
9. You agree to return the dog \_\_\_\_\_ or adopt by \_\_\_\_\_.

**Failure to comply with any of the above provisions will be a Breach of Contract and result in forfeiture of the dog to Frenzy Animal Rescue. If forfeiture goes to court you will be liable for all Lawyer and court cost.**
