WA&PD and the 27

As would be expected the other 27 EU Member States officials were provided with much more information about the WA&PD Treaty than we have been given in the UK - and from a totally different perspective - the perspective of those who are not yet leaving - though some may plan to do so.

Of course, the information given to them would also be mixed with EU propaganda and talk of getting back at Britain etc. - and how the situation could be manipulated towards the EU's advantage - and to the furtherance on "Ever Closer Union"

In an article on "The Europrobe" website* though, the other 27 Member State leaders were given much more information - about how the Angela Merkel had set a trap for the UK - with the help of the UK Prime Minister Theresa May and our Civil Service.

Below is an excerpt from article - the full article and a follow-up are included below. A further assessment of the May Surrender Treaty has also been added.

- *"The Chancellor had the transcript of that meeting circulated secretly to EU and key German embassies."*

"Conclusions"

"Documents make it quite clear that Prime Minister May was negotiating with Germany, not the EU."

"Key EU heads were actually briefed in full the day before the Cabinet meeting at Chequers."

"Chancellor Merkel briefed May on tactics to force Cabinet approval."

Summary

The articles confirm the euexit.com position relating to the Withdrawal Agreement and Political Declaration Treaty (WA&PD) - that the UK is being sold - out by its own Prime Minister, Civil Service and, as we have seen in the Parliamentary debates and votes - by most of our elected representatives in all Political parties, including their leaders.

Further evidence of collusion between Theresa May and Angela Merkel can be derived from the peculiar behaviour of May at Chequers in July 2018 (Chequers comprises 80% of WA&DP Treaty) - when she forced her Cabinet to agree to the core of a new Treaty, that she had been given by Merkel. May is using similar techniques to get the new Treaty through Parliament - but they cannot be controlled as easily as she was able to do with the Cabinet - even with Merkel's tutoring and backup.

This Treaty must now be completely rejected - the voting must show a rise in opposition to it being ratified - not a gradual reduction in opposition to it - as MP's are threatened with a General Election or bribed with the trinkets of power - position, Knighthoods and ennoblement.

Our politicians must realise that the voting public are not stupid - and that they have learned much as they looked on, in astonishment, at the treachery of those in the Houses of Parliament - there will be no return to Parliament of any of those - not May, not Corbyn, nor any others that have used treachery to further their own ambitions.

Please make your MP aware of the allegations of May's deception - don't let them claim that they did not realise what they were voting for - more questions need to be asked in Parliament.
