

Hello neighbor, my name is Michael Barden. I am a victim of organized stalking and harassment. It happens right here in this neighborhood and just about everywhere I go. If you have never heard of this, you should go to my website BARREDIN.US. There you can find interviews with former CIA, NSA, Dr's, Scientists, etc covering the topic so you can further understand what I am talking

about. Perpetrators of this crime try to use the defense of “the person is delusional” to cover their crime when they are confronted. That no longer works as we have more proof, government documents, and sworn affidavits from credible people with knowledge of this program than ever before. Many intelligent people are researching and tracking the methods used on targets right here in this

area. These methods are known as “Standard Operating Procedures”. Standard operating procedures can be tracked, documented, and used in court as proof beyond the shadow of doubt by using statistics. That being said, Avondale and our little neighborhood Glenhurst are starting to become known worldwide. Yes, people around the world know exactly what is going on

here. Approx 4 million people so far if not more. It will double within a few months. That's just my videos. There are thousands of other people doing the same thing. People that aren't going to let this happen anymore. You might have no idea what I'm talking about, or this might be starting to sound familiar. and deprivation of rights under color of law). Also US code 2261 (stalking). Also the 1st, 4th, and 13th amendments. Even if you have a government clearance that states you can legally take part in these psychological operations, you are not protected by your National

Security Letter. It is still a crime against humanity. A classified clearance does not protect crimes against humanity. The Nuremberg trials proved that once already. You should also research the Nuremberg trials if you don't know what happened there. Basically the people taking part in the Stasi Policing system were eventually brought before a judge and prosecuted for war crimes. By the way the

Geneva Conventions state that psychological warfare is illegal, and is considered a war crime. The people arrested and charged were “just doing their job”, and “keeping the neighborhood safe”. It’s much more than that, and if you choose to listen to the information I am providing, you will be fully aware of the entire program you could be taking part in.

In December of 2017

Executive Order 13818 was introduced to eradicate government corruption, and seize all assets from unconstitutional government infiltrators. It specifically states that human trafficking is the main objective to eradicate. Organized stalking and harassment or gangstalking is 100% Human trafficking. If citizens are earning profit from another citizen without their consent, that is trafficking. Plain and

simple. It's not that hard to understand. That is the reason I am reaching out to my neighbors. You might have been fooled by our government. Imagine that? That's never happened before right? I've seen this while serving 15 years in the United States Air Force. Sometimes the government lies to the troops. They tell us we need to go fight for freedom, then realize we're fighting for Oil or Opium.

Pure profit, not for freedom. I don't want to see my fellow Americans fooled in this same fashion. Our country is being divided now like never before, and I want to do everything I can in my power to help bring us back together. Again, the EO states that all perpetrators of government corruption will be prosecuted and all assets will be stripped. That means that everything a gangstalker has earned will be seized.

On March 1, 2018 the Uniform Code of Military Justice (UCMJ) was updated

to allow the United States Military to legally arrest and detain American Citizens. This Executive Order went into place on Jan 1st, 2019. Are you starting to see what's happening?

No what you want to do is go to [PACER.GOV](https://www.pacer.gov) and notice how many sealed indictments are going to be served this year. On average the United States serves around 1,000 of these

indictments. This year there are over 70,000 and growing. Each of these 70,000 sealed indictments can have up to 94 co-defendants on them. Pull out your calculator and see what that adds up to. Mind blowing isn't it? How would they arrest this many people all at once? The answer is with a Military Tribunal. Our troops and supplies from several bases around the world have been Brough

back to the US for “deployment”. Why would they be sending gear and troops back to the US to “deploy”? For a military tribunal of course. It’s all right in front of your face if you choose to be aware and do a little research. If this is the first time you are hearing of this crime, I know it’s tough to absorb. It sounds like a weird movie. Just remember that reality is stranger than fiction
