Mp2Planning Presentation: Mr. Larry Strange provided a presentation of the Arenac Public Transit Authority Transportation Needs Study and Service Plan. (See attachment of presentation). The presentation was comprised of Bus Fleet Data, Fare Summary, 4 Year Performance Indicators, 2022 Passenger and Cost Data and Community Survey Data. CONCLUSIONS:

- APTA System has evolved serving entire county.
- Costs are generally lower than surrounding transit systems.
- APTA is operating efficiently based on MDOT criteria.

Using the survey data, discussion was had on possible grants for "grant ready projects" and how to attract new ridership. Discussion on preparation to put a millage request on the August 2024 election ballot.

The current millage was passed in the 2020 August Primary at .60 mills, for 5 years (2020-2024). With increased operation costs (fuel, drivers, wages, etc.) discussion on an increase to the millage proposal.

Motion, Bowers, to present a millage proposal, for APTA, to the Arenac County Commissioners, in the amount of 1.2 mills, for four (4) years (2025-2028); to be placed on the August 2024 Primary; support, Adams; 5 yeas, 0 nays; motion carried.
