NATIONAL & STATE TRAIL TOURNAMENT RULES:

2024-2025 High School Fishing State Championship, Open and Challenge Event NATIONAL & STATE Rules:

1. INTERPRETATION & ENFORCEMENT • These rules will remain unchanged during the 2024-2025 High School Fishing season. Interpretation and enforcement of these rules will be left exclusively to the tournament director. Decisions of the tournament director are final in all matters and are not subject to appeal. Each contestant, coach and boat captain agree to report any suspected rule violation to the tournament director immediately upon discovery. Failure to report a violation may be cause for disqualification. The violation of a tournament rule may result in, but is not limited to, disqualification from the event, weight loss (in whole or in part, for part of a day or for one or more days, for a heaviest bag, single fish or largest fish, or any combination thereof) or ineligibility to participate in future tournaments. Protests and/or alleged rule violations are to be documented in writing by a witness or boat captain within 30 minutes of the check-in time of the final flight of each tournament day. Tournament officials, in their sole discretion, reserve the right to consider rule violations reported or discovered at any time for any reason, by any persons, before or after a tournament has ended and assess penalties for any past or future event including denying entry to compete. **(REF: TRAIL RULE 1A BELOW)**

2. PARTICIPATION & ELIGIBILITY • Participation is open to all 9th, 10th, 11th and 12th grade high school students. Participation by one (1) seventh or eighth grade student per team is permitted. Each team will consist of two contestants and one coach. **(REF: TRAIL RULE 2A BELOW)**

Pursuant to federal law guidelines under the Safe Sport Authorization Act of 2017, there MUST be three people to a boat at all times. No exceptions. No angler may register or plan to fish alone. In the case of a verifiable, unplanned emergency, where one partner is unable to attend and no time is left to find another partner, only then may a tournament official, at their sole discretion, allow an observer in the boat in place of a fishing partner. The observer may not fish. If this benefit is approved, however, it can only be used once per season, including any championships and regardless of reason. For state championships, each team must compete in the state in which their school is located. Teams from all states can participate in open tournaments and challenge events. If a contestant fishes multiple qualifying events, only the first paired team that qualifies will advance to the National Championship. A contestant cannot qualify for the National Championship as a member of two different teams. With prior approval from the tournament director and mutual consent by both members of a team, a team may forfeit their entry into the National Championship and try to requalify. Contestants must be Student Angler Federation members. There is no entry fee to participate for SAF members in the World/National Tournaments.

(REF: TRAIL RULE 3A BELOW)

Contestants registering onsite, however, will be charged a \$20 late fee. Contestants must have the signature of a parent or legal guardian in the provided space on the entry form. Contestants must have in their possession a valid fishing license for the waters they fish if required by law and a current student identification card from the school they represent or other proof of grade level. Random checks will be conducted at each tournament. Failure to provide proof of a valid fishing license within a reasonable amount of time when requested will result in disqualification for that day and any preceding days in which the license was required for the tournament. Contestants are required to follow all applicable federal, state and local regulations and laws. Any violation of such regulations and laws may result in disqualification.

Entries for state championships and challenge events should be made at highschoolfishing.org or by calling TBF at 580.765.9031. Entries for opens should be made at majorleaguefishing.com or by calling MLF at 270.252.1000. Please do not make entry by more than one method. TBF and MLF reserve the right to review team names and reject any names that are deemed inappropriate for any reason. There is no limit to the number of teams accepted into a tournament from each school or club. Accepted teams will be confirmed and notified via e-mail prior to each tournament. Tournament officials reserve the right to reject any application to compete for any reason whatsoever. **(REF: TRAIL RULE 4A BELOW)**

3. PURCHASING OF INFORMATION • The purchasing of, or bartering for, information about locating or catching fish on tournament waters, including but not limited to GPS waypoints (other than through commercially available sources) and the hiring of fishing guide services is not permitted by contestants, coaches, boat captains or anyone working on a team's behalf within 10 days of the start of any tournament. Violation of this rule may result in disqualification. A team may not pay a boat captain for their services. A team may reimburse a boat captain for actual fuel and travel expenses related to the tournament. However, a team or anyone acting on a team's behalf, may NOT pay or "hire" a Boat Captain for their time or knowledge. Contestants, coaches, boat captains, parents (anyone acting on a team's behalf) may not buy or barter a fishing location from anyone.

4. OFF-LIMITS, PRACTICE & COMPETITION (REF: TRAIL RULE 5A BELOW)

• There is no practice period or off-limits period prior to the start of onsite registration. There are, however, specific rules defined below that govern practice within 10 days of each tournament. Contestants, coaches and boat captains may be on tournament waters until the start of onsite registration. Contestants, coaches and boat captains may not enter tournament waters to locate bass or potential fishing waters or sightsee after the start of onsite registration except during tournament hours. Testing equipment on tournament waters after the start of onsite registration is permitted only with prior approval from the tournament director. Within 10 days of the tournament no contestant, coach or boat captain may practice with, hire, barter for, or engage in services with, for the purposes of locating or catching bass on the tournament waters, any person who has been a bass guide for hire on the tournament waters within the last 12 months unless such person is the parent or documented permanent legal guardian of a contestant on a team in the event. Written proof of permanent legal guardianship to the satisfaction of tournament officials may be required. Within 10 days of the tournament contestants may only practice with another SAF member that is confirmed in the tournament, their coach, their boat captain or an immediate family member (mother, father, brother, sister or grandparent) who also meets the above criteria concerning guides or be a registered active participant in a another TBF or MLF sanctioned event during this time frame. Nobody else, except a media representative or official approved by the tournament director, is allowed in the boat. Within 10 days of the tournament and extending through competition, contestants, coaches and boat captains may not solicit and/or receive information about locating or catching fish on tournament waters from anyone except contestants, coaches and boat captains confirmed in the tournament and through publicly available sources. Unsolicited information received at MLF and/or TBF weigh-ins is considered a publicly available source. Quasi-public websites, blogs and/or social media pages, including but not limited to Facebook, Instagram, Snapchat and Periscope, set up for the specific purpose of sharing information with individuals or a small group of individuals are not publicly available sources. Within 10 days of the tournament and extending through competition, contestants, coaches and boat captains may not follow a

noncontestant's boat or participate in the placing of markers, brush or other physical fish attractors by noncontestants or the practice of "hole sitting" by anyone. During competition days, contestants, coaches and boat captains may not place brush or other physical fish attractors, including chum of any kind, in tournament waters. Flights over tournament waters, including drones, for the express purpose of locating fish or fishing locations are not permitted on competition days. Violation of this rule may result in disqualification.

5. REGISTRATION & PRETOURNAMENT MEETING • Unless prior approval is received from tournament officials, both contestants comprising a team and their coach or boat captain must register and check-in at the designated registration site at the times listed in the tournament confirmation. Contestants and/or coaches or boat captains who fail to notify the tournament director and are more than 15 minutes late for registration check-in may not be entered in the tournament. It is mandatory that all contestants and their coaches or boat captains attend the pretournament meeting at the time and place set forth in the tournament confirmation unless prior approval is received from the tournament director. Contestants and/or coaches or boat captains not present for the pretournament meeting may not be entered in the tournament. Virtual pretournament meetings may be held in place of in-person meetings when such meetings are not possible.

6. BOAT ASSIGNMENTS • Takeoff order (boat number) is determined by tournament officials. Most events, including all opens, are random draw. Some events may be based on date and time of entry. Onsite entries may receive the last available boat numbers. Each team must be accompanied on the water by a coach or boat captain who will supply a boat but is not permitted to fish. **(REF: TRAIL RULE 6A BELOW)**

7. SAFETY • Safe boating must be observed at all times. Each contestant, coach and boat captain on the water is required to wear a fastened U.S. Coast Guard-approved chest-type personal flotation device anytime the combustion engine is running from boat check until weigh-in each day of the tournament. All boats must be equipped with an emergency ignition-shutoff device that must be securely attached to the driver's body whenever the combustion engine is running. All persons in a tournament boat shall remain seated in a manufacturer-recommended on-plane seating location with a driver behind the steering wheel or at the tiller in full control of the boat whenever it is on plane or the combustion engine is running and in gear. Sitting on pedestal seats while the combustion engine is in operation and in gear is not permitted. Contestants are not permitted to drive the boat when the combustion engine is running. Safe boat conduct must be observed at all times by contestants, coaches and boat captains. At the discretion of the tournament director, tournament days may be shortened, postponed or canceled due to unsafe weather or water conditions. Contestants, coaches and boat captains may leave their boat and seek shelter in bad weather or when danger is imminent. Violation of this rule may result in disqualification.

(REF: TRAIL RULE 7A BELOW)

8. SPORTSMANSHIP • All contestants, coaches and boat captains are required to follow high standards of sportsmanship, courtesy and conservation and to conduct themselves in a manner that will be a credit to themselves, TBF, SAF, MLF, tournaments sponsors, the school the team is representing, the sport of fishing, and our combined efforts to promote the sport. Conduct not complying with these standards includes, but is not limited to, the following: • Violation of, or failure to comply with, any of the rules for the 2023-2024 High School Fishing season. • Consumption and/or possession of alcoholic beverages or cannabis products

or any kind of mind-altering substance during registration, the pretournament meeting or during tournament hours extending through the weigh-in procedure. • Abuse of, or addiction to, mind-altering substances. • Conviction of a felony within the past 36 months. • Suspension/disqualification, probation or ban from any tournament or fishing organization. • Boat operation in an unsafe or unsportsmanlike manner. • Violation of a posted no-wake area. • Publicly criticizing or questioning the integrity of TBF/SAF or MLF or their officials, including but not limited to any rules, policies and procedures. • Dissemination of disparaging content or content that one should reasonably know would harm the reputation of TBF/SAF and/or MLF companies, officials and sponsors. • Any other words, conduct or actions reflecting unfavorably upon efforts to promote safety, sportsmanship, fair competition and compliance with tournament rules, or which fail to comply with the standards set forth in the first sentence of paragraph 8. In case of any conduct not complying with the standards outlined above, tournament officials have the right to refuse an application to compete, to deny a confirmed application to compete, to disqualify a contestant or impose any penalty outlined herein.

9. BOAT OPERATION • Coaches will supply and drive boats for their teams or arrange boat captains to supply and drive boats for their teams. To qualify as a coach or boat captain, the person or persons accompanying a team must be at least 19 years old and reside in the same state as the students comprising the team or be an immediate family member (mother, father, brother, sister or grandparent) that is at least 19 years old regardless of residence. For students living near state borders, coaches or boat captains may reside in a neighboring state so long as they reside within 60 miles of one of the students comprising the team. In the event of boat or engine failure after a team is onsite for a tournament, the tournament director may, at his sole discretion, arrange for a volunteer boat captain to assist a team. Bass guides who operate or have operated for hire at any time during the previous 12 months from the tournament date on the designated tournament waters are not permitted as coaches or boat captains unless they are the parent or documented permanent legal guardian of one of the contestants on a team in the event. A guide is defined as anyone who is paid for their time and knowledge to take someone fishing. Written proof of permanent legal guardianship to the satisfaction of the tournament director may be required. The use of a guide as defined above will result in disqualification. Contestants may operate the trolling motor. Coaches and boat captains may provide assistance, including information about locating and catching fish, but are not permitted to fish on competition days. Contestants, coaches and boat captains may not use mobile communication devices of any kind, including but not limited to, phones, tablets, radios, etc., to communicate with anyone about locating or catching fish on tournament waters during tournament hours. Mobile communication devices may be used during tournament hours to communicate with lockmasters about locking, or to communicate with designated tournament officials. Contestants, coaches and boat captains may use smart phones and/or tablets during tournament hours for GPS, mapping, weather, power generation, barge traffic updates, tidal charts, personal fishing notes and related data. At no time during tournament hours may contestants, coaches and boat captains read or discuss social media posts from other contestants. If a special circumstance arises that inhibits a contestant's ability to compete, the tournament director may allow the contestant to withdraw from competition and maintain the weight caught to that point.

10. BOAT & HORSEPOWER REGULATION • All boats must be propeller-driven and a minimum of 16 feet in length. No barges or similarly cumbersome craft will be permitted. Pontoon and tritoon boats that meet all

other requirements under this rule are permitted. Each boat must have all required U.S. Coast Guard safety equipment. Boats must contain a properly aerated livewell space to maintain alive a limit catch of bass. Maximum horsepower for all outboards used in tournament competition shall not exceed the horsepower capacity set forth on the "Maximum Capacities" placard described below. Each boat must have a clearly legible "Maximum Capacities" (or comparably titled) placard that includes a maximum horsepower rating affixed to the boat by the manufacturer. The horsepower of the outboard engine must not exceed the maximum horsepower capacity specified on this placard. By signing the entry form, contestants, coaches and boat captains agree to submit their boat and/or motor to an inspection by tournament officials. Falsifying information on entry forms or altering the horsepower numbers on the motor or rating placard will be cause for disqualification from the tournament and may result in ineligibility to compete in future High School Fishing tournaments. Fishing platforms must be factory-installed equipment or commercially available aftermarket equipment that is permanently installed in the boat. No portable platforms may be used in tournament competition. Fuel may be carried only in factory-installed (built-in) fuel tanks or auxiliary fuel tanks that are securely strapped or otherwise fastened to the boat. Any additional fuel used during the tournament day must be purchased from a retail facility open to the public and pumped through a hose with a nozzle. The use of generators, other than solar or wind-powered generators, is prohibited in contestant boats during tournament hours. **(REF: TRAIL RULE 8A BELOW)**

11. PERMITTED FISHING METHODS • Fishing is defined as having a lure attached to a line and a rod and reel with the rod in hand. All bass must be caught alive in a conventional sporting manner. All lures must adhere to state regulations. Only artificial lures may be used, with the exception of pork trailers and biodegradable soft baits. Alabama rigs and similar umbrella-type rigs are limited to a maximum of five wires with a maximum of five spinners, five lures and three hooks (single or treble) unless state regulations are more restrictive, in which case state regulations prevail. Only ONE fishing rod may be used at a time. Trolling as a method of fishing is strictly prohibited. Trolling is defined as operating any combustion engine to extend a cast or lengthen a retrieve or using any mechanical propulsion device to move the boat as the sole means of imparting action to the lure. All bass caught while visibly-fishing for bass must be hooked inside the mouth and immediately shown to your coach or boat captain for verification.

12. PERMITTED FISHING LOCATIONS & BOUNDARIES • Teams may fish anywhere on tournament waters within the boundaries defined by the tournament director that are available to the public and accessible by boat except areas designated as "off-limits," "no boats," "keep out," "restricted," "no trespassing" or "no fishing" (or similar language or markings intended to restrict public access) by tournament officials, commercial property owners and/or local, state or federal officials, or within 50 yards of a contestant's boat that was first anchored. An anchored boat is a boat held in a stable position by a line attached to a weight or by a Power-Pole, Talon or similar shallow water anchor with the trolling motor in the up position. All fishing must be conducted from the boat. At no time may a contestant leave the boat to land a fish or to make the boat more accessible to fishing waters. The cutting of trees, bushes and/or logs after the start of onsite registration and/or the removal of official commercial, local, state or federal barricades at any time to make an area more accessible by boat or gain access for fishing is strictly prohibited and may result in disqualification from the tournament. The use of cables, ropes, chains or any type of block and tackle system to maneuver a boat into fishing waters is strictly prohibited and will result in disqualification from the tournament. Teams must leave and return to the check-in by boat. The boat must remain in the

tournament waters during the tournament day. No tournament boat may be loaded on a trailer before the team using the boat presents their catch for weigh-in, except with the permission of the tournament director. In the event of equipment failure or emergency, the tournament director must be notified as soon as it is safe to do so. There are then three permitted methods of returning to the check-in: (1) by both contestants remaining in their boat and being towed by water, (2) with permission from the tournament director, by one contestant entering the boat of another team or (3) both contestants entering a rescue boat so designated by the tournament director. Under these three conditions the team's catch may be counted without a penalty (except for late penalties, dead-fish penalties or other penalties pertaining to other tournament rules) provided each team's fish are adequately marked or separated so as to provide clear distinction of each catch to the tournament director. Teams that elect to return to the check-in by any other means than cited above will forfeit their day's catch to that point in time of the tournament day. Abandoning a boat and leaving it adrift without proper tie-off or anchoring after a mechanical failure may result in disqualification of that day's weight. Any team returning to the check-in point will be eligible to restart and resume competition under the supervision of the tournament director or his designated tournament official. It is the sole responsibility of teams to locate the tournament director to request a restart. Teams must remain together at all times and within sight of their coach or boat captain until check-in. The momentary condition of being out of sight of each other for restroom breaks is permitted. Violation of this rule may result in disqualification.

13. CHECKPOINTS • There will be only one checkpoint for boat check in the morning and one check-in point in the afternoon. Failure to go through boat check and checkout in the morning or failure to check in at the check-in point will result in disqualification. All fishing must cease upon check-in.

14. LATE PENALTY • Teams that are not at the designated afternoon checkpoint at the appointed time will be penalized 1 pound per minute, deducted from the total weight. Teams more than 15 minutes late will lose credit for that day's weight. **(REF: TRAIL RULE 9A BELOW)**

15. LIVE FISH • Every effort must be made to keep bass alive through the use of a properly aerated livewell. Eight ounces will be deducted from the total weight for each dead bass presented for weigh-in.

16. SCORING • Scoring is determined by the pounds and ounces of each team's catch during each tournament. Only largemouth, spotted, redeye, shoal or smallmouth bass are accepted species. No regurgitated forage or other foreign matter may be placed in a bass. The daily limit will be five bass per team unless conditions dictate a reduced limit or the state or lake limit is less than five, in which case those limits will prevail. After possessing the daily limit, teams must cull immediately upon their next catch. Teams possessing more than the daily limit must notify the tournament director immediately upon discovery of the infraction and reduce their catch to the daily limit by releasing live bass. Teams possessing more than the daily limit will be penalized 2 pounds for each bass over the limit. The minimum length limit for bass will be 12 inches unless the state or lake limit is more than 12 inches or tournament officials set a longer limit for a specific tournament, in which case, the state or lake limit or longer limit set by tournament officials for the tournament will prevail. Bass presented for weigh-in that fail to measure the prescribed length limit will be penalized at the rate of 1 pound for each short bass presented. Bass presented for weigh-in with weight clips attached will be penalized at the rate of 4 ounces for each clip. After competitors check in at the official checkpoint, they must present all fish in possession that meet the tournament size

limit to tournament officials to be counted, measured and weighed. Once a team's catch has been presented to tournament officials, that day's catch is final. No one may return to a boat to retrieve a bass mistakenly left behind. After being weighed, each team's catch must be turned over to tournament officials unless otherwise instructed. Each team's catch must be presented in an official weigh-in bag. The winning team is determined by the day's heaviest catch. The top 10 percent of teams in each state championship and open tournament advance to the High School Fishing National Championship. Tournaments held June 12, 2023, through June 9, 2024, will advance teams to the 2024 National Championship. Tournaments held June 10, 2024, through June 9, 2025, will advance teams to the 2025 National Championship. All participating SAF teams automatically qualify to compete in the High School Fishing World Finals that runs concurrently with the National Championship and has a separate prize pool. **(REF: TRAIL RULE 10A BELOW)**

17. TIES • Total number of fish for the tournament will break ties followed by the total number of live fish. If a tie remains, it will be broken first by earliest entry for the tournament and then by lottery.

(REF: TRAIL RULE 11A BELOW)

18. LOGO DISPLAY & MEDIA COVERAGE • Contestants, coaches and boat captains may wear their own apparel. Tournament officials reserve the right, in their sole discretion, to prohibit any contestant, coach or boat captain's apparel that is determined to be offensive.

19. ALCOHOL & TOBACCO • During all days of competition any and all alcohol and tobacco logos are prohibited and may not be worn or displayed. Contestants, coaches and boat captains may not smoke or use tobacco products during tournament hours, including weigh-in, at any event.

20. TRUTH VERIFICATION TEST • Each contestant and coach agrees to submit, by signature on the tournament entry form, to a polygraph or voice stress analysis examination and to abide by its conclusion. Failure to pass an examination will result in disqualification from the tournament. Truth verification tests will be used at the sole discretion of tournament officials, and the determination of the meaning of the results will be made solely by tournament officials.

21. INSURANCE • Liability insurance with coverage in reasonable amounts is required on all boats used in High School Fishing tournaments. Proof of insurance must be with the boat being used and must cover all passengers in the boat. Random checks will be conducted. Failure to provide proof of insurance when requested by the tournament director may result in disqualification. **(REF: TRAIL RULE 12A BELOW)**

22. CAPTIONS • The captions at the beginning of each paragraph are intended to facilitate convenience in referring to the various rules. The captions are not part of the substance of the paragraph and should not be used in construction of any paragraph or of this overall set of rules.

OFFLIMITS

Tournament waters shall be off limits to Student Anglers & Boat Captains from official SUNSET Sunday preceding the tournament until official SUNRISE the Friday before tournament.

NO launching of boats during the official Off Limits.

TEAMS MAY NOT SOLICIT INFORMATION FROM ANYONE WHO HAS BEEN ON THE TOURNAMENT WATERS WITHIN 10 DAYS OF OFFICIAL PRACTICE & TOURNAMENT HOURS.

OFFICIAL PRACTICE DAY

Friday and/or Saturday BEFORE scheduled Tournament Day, Official SUNRISE to Official SUNSET.

NO NIGHT FISHING! NOTE: Tournament Practice is voluntary by ALL registered Teams ONLY.

Anglers & Boat Captains can NOT practice with anyone NOT registered in the scheduled Tournament.

Student Anglers are NOT covered under the Tournament Day Insurance Policy on Official Practice.

Safe boating & fishing practices should always be maintained when on the water.

OFFICIAL TOURNAMENT HOURS

7AM3PM

Tournament Officials have the right to delay, shorten or cancel the start of an official tournament due of bad weather or other factors that would endanger the safety of the competitors, equipment & volunteers associated with the scheduled event.

BLAST OFF ASSIGNMENTS

Set by using the Random Number Generator (RNG) app based on completed online registration or tournament entry forms. Blast off / Flight Positions & Tournament Info will be emailed to team coaches and uploaded on the SC TBF / SAF Youth Bass Fishing Tournament Trail Facebook page.

SAFETY

SAFETY IS TOP PRIORITY: Boat Captain is RESPONSIBLE for operating boat at a safe speed during tournament hours. Boat Captain should inspect ALL US Coast Guard APPROVED PFD for overall condition, fit & proper use. IF inflatable Vest PFD are in use, Boat Captain should make sure that the vest is armed and/or charged.

NOTE: INFLATABLE WAIST BELT PFD ARE NOT ALLOWED.

Boat Captain & Student Anglers are REQUIRED to be seated in the boat cockpit area ONLY with FULLY secured PFD on @ ALL times the combustion engine is running. This includes, Idling, Forward & Reverse operation. NO EXCEPTIONS!!!!!! This includes BEFORE & AFTER tournament hours.

Boat Captain is REQUIRED to have Emergency Ignition Shut-Off Device properly secured to his/her PFD or body @ALL times combustion engine is in use. This includes, Idling, Forward & Reverse operation. NO EXCEPTIONS!!!!!! Student Anglers CAN assist with launching & loading of boat using combustion motor. ALL PFD & Emergency Ignition Shut-Off Device rules apply.

ALL NO WAKE ZONES MUST BE OBSERVED.

**** FAILURE to comply with safety rules, will result in immediate DISQUALIFICATION from competition. ****

****ALL boat breakdowns and/or repairs during tournament hours must be reported and approved by Tournament Director IMMEDIATELY. All circumstances are unique and will be handled accordingly****

INCLEMENT WEATHER SAFETY POLICY

ALL Team Coaches will be notified via email and will be posted on the SC TBF/SAF Youth Bass Fishing Trail social media Page. If a scheduled tournament MUST be POSTPONED or CANCELLED due to inclement weather, the tournament will be rescheduled or scratched from the scheduled based on timing.

MINIMUM 16' with steering wheel. Outboard Motor HP can NOT exceed rating as listed on US Coast Guard Maximum Capacity tag inside boat. ALL boat's MUST be seaworthy, have working Navigation Lights, Emergency Ignition Shut-Off Device & Live Well. Boats that do NOT meet these REQUIREMENTS will NOT be launched until issues are corrected! NO EXCEPTIONS!!!! (TILLER HANDLE ENGINES & STICK STEERING BOATS ARE ALLOWED)

TOURNAMENT AFTERNOON CHECK IN

AFTERNOON TOURNAMENT CHECK IN WILL BE @ THE REN TENT TANK COMPOUND. . A Staff member will be set up to record afternoon check in time & fish count. ALL Teams must acknowledge to staff member they are checking in at the REQUIRED check in time. Late check-In time penalties apply.

****ALL Teams have 30 minutes from check in time to get their fish in bags and report to the Red Holding Tank Tent. Late check in time penalties apply. ****

ALL boat floats MUST be turned in to staff member at the RED HOLDING TANK TENT regardless if team has fish or no fish. NO EXCEPTIONS!!!!

ALL BOATS REQUIRED TO HAVE FISH BAG ONBOARD!

Student Anglers are REQUIRED to have adequate water level in their bags to completely cover the fish while transporting fish to the check in area. Transporting fish WITHOUT water bag is UNACCEPTABLE and will be addressed with Student Anglers, Boat Captains & Team Coaches.

Student Anglers are encouraged to check their fish for legal length WITHOUT PENALTY at the courtesy tank BEFORE submitting fish to be weigh master.

NOTE: BUMPMASTER is an official Staff Member and has FINAL ruling on legal fish length and/or dead fish rule. ALL fished become property of the tournament trail once they pass the bump masters inspection.

ALL UNDERSIZE FISH SUBMITTED FOR WEIGH IN WILL BE DISQUALIFIED AND THE TEAM WILL BE GIVEN A 1 POUND PENALTY PER FISH.

Once Student Anglers have checked in, they are REQUIRED to get in line to have fish officially measured, placed into a mesh bag, and get mesh bag into the holding tanks. NO Student Angler will be allowed to leave the holding tank area once they have checked in until they have been called to the stage for official Weigh In.

Once Weigh master has weighed fish and total weight is recorded WITHOUT dispute, fish creel will not be reweighed.

NO TRAILERING OF BOATS ALLOWED BEFORE WEIGH IN UNLESS TOURNAMENT DIRECTOR MAKES ACCOUNCEMENT BEFORE THE START OF TOURNAMENT.

ALL School Clubs **RESPONSIBLE** for maintaining signed Student Angler & Boat Captain Liability Waivers and for verifying **REQUIRED** boat insurance coverage!

ALL Student Anglers **REQUIRED** to be enrolled in school in good academic standing for the entire school year. **MINIMUM "C"**

ALL Student Anglers **REQUIRED** to have a signed Liability Waiver on file with School/Club and/or Tournament Trail.

Underage Student Anglers **REQUIRED** to have parent signature on Liability Waiver

ALL Student Anglers aged 16 and over, **REQUIRED** to have a valid SC Fishing License.

RULES/REGULATIONS

ALL **2024-2025** NATIONAL TBF/SAF JR. & High School Rules, SCDNR Fishing Rules/ Regulations & SC TBF/SAF Youth Bass Fishing Trail Rules apply while competing in any of the SC TBF/SAF Youth Bass Fishing Trail Tournaments.

ALL rule infractions & penalties, upon full review are at the desecration of Tournament Directors and/or Tournament Coordinator. Student Anglers, Boat Captains & Team Coaches **RESPONSIBLE** for knowing & **UNDERSTANDING** the rules.

CELL PHONE POLICY:

Student Anglers are **PROHIBITED** to use cell phones during tournament hours **UNLESS** in an emergency.

Team Coaches & Boat Captains may **NOT** use **ANY** mobile communication devices of **ANY** kind, including but not limited to cell phones, radios, tablets, etc., to communicate with **ANYONE** for the purpose of locating or catching fish on tournament waters during official practice & tournament hours.

Mobile Communication devises **MAY** be used by boat captain to communicate with tournament officials & lock-masters during official tournament hours.

Boat Captains **CAN** use mobile communication devices during official tournament hours for GPS mapping, weather updates & Tidal Charts.

Posting tournament related pics on **ANY** social media platform during official tournament hours by contestants, boat captains and /or team coaches is **PROHIBITED**. Inner team chat groups is **PROHIBITED!**

Failure to abide by the rules will result in **DISQUALIFICATION**.

RESTROOM BREAKS

ALL Student Anglers & Boat Captains are **ALLOWED** to exit the boat to take a private restroom break if needed. **ONLY** one person can be out of the boat at any given time. **NO** fishing is allowed if boat is parked on land during restroom breaks.

BOAT CAPTAIN RULES

REQUIRED age 18 or older, **CAN NOT** be a Full Time High School Student! College Anglers are **APPROVED** Boat Captains.

REQUIRED to pass a SLED Background check **IF REQUIRED** by School/Club.

REQUIRED to have a signed Liability Waiver on file with School/Club or Tournament Trail.

CAN NOT be a Professional Fisherman or Licensed Guide **UNLESS**, they are an immediate family member or Legal Guardian of the student angler. Immediate Family Member described as Father, Mother, Brother, Sister or Grandparent.

NOTE: ANY boat captain caught deliberately cheating during competition will be suspended from his / her boat captain duties for the remainder of the scheduled tournament season. NO appeals will be granted.

TBF/SAF rules, Boat Captains **MUST** always remain in boat during tournament hours. CAN coach, make location & technique suggestions during tournament hours, CAN assist in keeping equipment organized on the deck of the boat to eliminate any safety related hazards during scheduled tournament hours, CAN retrieve ANY equipment from the possibility of going overboard, CAN assist student anglers in the culling process providing BOTH student anglers are NOT fishing & assist in hook removal from fish once fish is landed inside boat as a safety measure.

****BOAT CAPTAINS CAN NOT FISH OR STAND WITH ROD/REEL IN HAND DURING TOURNAMENT HOURS. ****

JR. Division Boat Captain

MAY net fish.

MAY assist with hook removal from fish, tree's, docks & underwater snags for safety concerns.

MAY assist with back lash removal.

MAY run a trolling motor.

HS Division Boat Captain

Can NOT net fish, UNLESS, student angler is fishing solo, then Boat Captain can assist in netting of fish for safety concerns

Can NOT run a trolling motor, UNLESS, neither student angler is trained to run a trolling motor safely or in an emergency situation where safety would be compromised causing personal or property damage.

Can NOT remove back lashes, hook snags in trees, docks, or underwater snags.

NOTE: HIGH SCHOOL DIVISION BOAT CAPTAINS ARE ENCOURAGED TO TEACH STUDENT ANGLERS PROPER RUNNING OF THE TROLLING MOTOR & NETTING OF FISH AS THIS TASK WILL BE REQUIRED IN ALL STATE & NATIONAL CHAMPIONSHIP TOURNAMENTS.

SUBSTITUTE BOAT CAPTAINS ARE ALLOWED PROVIDING A LIABILITY WAIVER IS SIGNED AND ON FILE. School Coaches or Team Advisors are RESPONSIBLE for advising Tournament Officials when a Substitute Boat Captain is participating in a tournament. Failure to comply and a Boat Captain Launches without notice will result in DISQUALIFICATION!

ALL Boat Captains should model cooperation, honor, integrity, perseverance, and honesty. Any boat captain who fails to promote these ideals may be removed from the SC BASS NATION YOUTH SERIES by the Executive Director and/or Advisory Staff.

USE OF DRONES/ MAGNIFYING DEVICES:

The use of Personal Aircraft including Drones is PROHIBITED by Contestants, Coaches & Boat Captains during OFFICIAL Practice & Tournament Hours. Contestants, Coaches & Boat Captains can NOT receive outside information from ANYONE using such devices for the purpose of locating and catching fish during OFFICIAL Practice & Tournament hours.

The use of magnifying devices listed as binoculars and/or spotting scopes by boat captains & contestants is ALLOWED for the

purpose of locating schooling fish.

Failure to abide by the rules will result in DISQUALIFICATION.

TOURNAMENT MORNING CHECK IN

Begins @ 5AM on Tournament morning,

ALL teams will be issued a Numbered Boat Float OR Numbered Staging card.

BOAT FLOAT AND/OR STAGING CARD MUST BE TURNED IN AFTER TOURNAMENT, Lost or damaged staging cards will assess a \$50 replacement fee by team and /or school. NUMBERED Boat Staging cards are for the purpose of boats lining up in numerical order in their perspective flights. Boats not following directions will be sent to the tail end of the blast off line.

BOAT CAPTAINS, PLEASE DO YOUR PART TO HELP MAKE BLAST OFF SMOOTH AS POSSIBLE!

LIVE WELL CHECK

Properly working Live wells will be checked during blast off procedures. Any boat coming to tournament site by water, boat captain is responsible for checking their team in and advising a staff member that live well needs to be checked.

DOCK PARKING

DO NOT TIE UP TO ANY DOCK!!! Docks are used for loading & unloading of Student Anglers & Boat Captains ONLY. In the mornings, once everyone is onboard, boats must move away from the dock to allow ample use of the dock by other teams for the same purposes.

THIS RULE APPLIES TO THE AFTERNOON USE OF DOCK AS WELL!

SAFETY MEETING

MANDATORY Rules / Safety Meeting followed by Prayer & National Anthem @ ALL SC TBF / SAF Youth Bass Fishing Trail Tournaments.

BLAST OFF PROCEDURE

ALL boats MUST be staged in flight area based on blast off positions. ALL Flights will consist of 30 boats. Tournament Coordinator will conduct blast off procedures at which time ALL boats MUST drive by at NO WAKE speed either by the dock or Blast Off Boat to verify ALL safety REQUIREMENTS listed as Emergency Engine Cut Off Switch, Navigation Lights & Live Well is working properly. Boats that do NOT meet these REQUIREMENTS will NOT be launched until ALL issues are corrected!

BLAST OFF MINIMUM 50 YARDS FROM DOCK, BLAST OFF BOAT OR NO WAKE BOUYS THAT MAY BE IN PLACE

TOURNAMENT CREEL

JR. Division - 3 Fish per Boat

JR. Division should not possess more than 3 fish at any given time during tournament hours.

Extra fish MUST be culled immediately.

HIGH SCHOOL Division - 5 Fish Limit per Boat

High School Division should not possess more than 5 fish at any given time during tournament hours.

Extra fish MUST be culled immediately.

ALL fish must be Largemouth, Small Mouth, Spotted or Redeye Bass. MUST be a MINIMUM 12 Inch Length, UNLESS the State Lake Length Rule is longer (14" Greenwood, Marion, Moultrie, Murray, Wateree or Wylie). Fish will be measured with mouth closed & tail fanned using the Golden Rule. NOTE: PINCHING OF TAIL IS PROHIBITED. Students Anglers are encouraged to check their fish for legal length BEFORE placing in live well.

****BEDDING FISH MUST BE HOOKED IN THE MOUTH. NO EXCEPTIONS! ****

DEAD FISH RULE

Dead fish CANNOT be culled. Dead fish MUST be kept and weighed in as part of the tournament fish limit. A 4-ounce penalty (8oz. = .50) for each dead fish will be assessed. This penalty WILL also apply to big fish, in the event the big fish is deceased.

PIERCING CULL TAGS

PROHIBBITED per TBF / SAF Jr. & High School Rules. Penalty for use of piercing type cull tags is loss of that fish from daily creel.

CONSERVATION

Dead fish can NOT be culled or released back into the water during tournament hours. Fizzing of fish is REQUIRED when needed.

EMERGENCY CONTACT

If an emergency occurs, the Boat Captain or Student Angler should call 911 first, and then notify the Tournament Trail Director, Tournament Coordinator Tony Gray @ 803-534-1720.

TBF JR NATIONAL CHAMPIONSHIP TOURNAMENT

Per TBF/SAF, National Championship spots will be awarded by season ending points for High School Division ONLY and is based on one (1) National Championship berth per 100 ACTIVE memberships (8th-12th Grade Students ONLY)

TOURNAMENT RESULTS

TOURNAMENT RESULTS ARE CONSIDERED UNOFFICIAL UNTIL ALL PENALTIES (DEAD FISH & CHECK IN TIME) IS REVIEWED AND DOCUMENTED.

FINAL TOURNAMENT RESULTS WILL BE POSTED ON MONDAY AFTERNOON AFTER EACH TOURNAMENT.

RULES VIOLATION

Violations of a tournament rule by Boat Captain OR Student Anglers may result in weight loss, the loss of weight up to a particular time in the tournament day (eligible for a restart), loss of weight for the entire day, disqualification for the entire tournament or, in an extreme circumstance, ineligibility to participate in future events. If a team is disqualified from a tournament their weight will be recorded as 0 lb.

However, they will still receive tournament points as if they had just caught no fish. If the director feels that their violation was a willful attempt to gain an unfair advantage or to intentionally cheat, the Tournament Director has the right to refuse entry from that team or team members in the future and will inform all members of the situation.
