- Tuition is subject to the general rules of the pool. Please read and obey the terms and conditions as well as general rules.
- By signature of this enrolment form, the parent/guardian of the pupil hereby exempts Annemie Bernardo from all and any liability of whatsoever nature for loss of property and /or physical injury of whatever kind by or to the pupil.
