Bellbird Junior Football Club Inc. Registration Terms and Conditions

By registering with Bellbird Junior Football Club Inc. (Bellbird Jnr FC) you (the **Member**) (and, if the Member is under 18 years of age, the Member's parent, or legal guardian) agree that the following terms apply in relation to your/the Member's participation in football:

Information you Provide

1. You warrant that the information provided in this registration form is current and correct.

Bellbird Jnr FC Rules and Regulations

2. You agree to comply with the Laws of the Game and the Bellbird Jnr FC's Competition Rules, regulations, and policies.

Use of your Image

- 3. Bellbird Jnr FC acknowledges and respects the sensitive nature of a Member's (particularly a child's) name, likeness, voice, quotes, comments, biographical information, and/or audiovisual images (Image). From time to time, Bellbird Jnr FC (Football Administrators) may use your Image for educational or game development purposes, or in order to promote and market the game of Football or Bellbird Jnr FC. Where the Member's Image is of a child, Bellbird Jnr FC will only record, and subsequently use, reproduce, publish or broadcast the Member's Image in accordance with the Football Australia (FA) Safeguarding Policy, in particular, sections 5.4 (Taking Images and Videos of a Child) and 5.5 (Use and Storage of Images and Videos of Children). A copy of the Safeguarding Policy is available at https://www.footballaustralia.com.au/governance/member-protection-framework.
- 4. You consent to Bellbird Jnr FC and their representatives, agents and assigns using, recording, reproducing, publishing and broadcasting your Image for the reasons described in clause 3, subject to the FA Safeguarding Policy and local laws. Further, you forever discharge and release Bellbird Jnr FC (including each of their directors, officers, employees, agents, contractors and assigns) from all liability related to the use of your Image in accordance with these Terms.
- 5. You acknowledge that copyright and all associated rights in any recording, reproduction, publication or broadcast contemplated by clauses 3 and 4 (**Recording**) is owned by Bellbird Jnr FC consent to Bellbird Jnr FC's editing, producing, amending and adapting such Recording, and agree that you will not enforce any moral rights that you may have in such Recording.

Risks of participating

- 6. You acknowledge and agree that there are inherent risks associated with participating in football that may result in personal injury and possible exposure to and illness from communicable diseases (including without limitation COVID-19) and you accept and agree to fully bear those risks.
- 7. You grant Bellbird Jnr FC and their staff and volunteers' permission to administer first aid to, and (if reasonably required) call an ambulance for you in the event of any personal injury during your participation in football and you undertake to pay or reimburse costs incurred for any such medical attention and ambulance transport.
- 8. You agree not to bring any claim or proceeding against any Bellbird Jnr FC (including each of their directors, officers, employees, agents, contractors and assigns) at any time for any damage, loss, injury, illness, disability, death or liability that you may suffer or incur in connection with or arising out of your participation in football. Except for liability that by law cannot be excluded, Bellbird Jnr FC excludes all liability to you in tort (including negligence), contract or otherwise for acts or omissions of Bellbird Jnr FC (including each of their directors,

officers, employees, agents, contractors and assigns).

Indemnity, Insurance and Limitation of Liability

- 9. You have read and understood the insurance benefits available through Northern NSW Football's (NNSWF) Sport Accident Insurance policy. Full Policy Disclosure Statements and Player Information detailing insurance coverage are available via https://www.northernnswfootball.com.au/resources/insurance or Gow Gates Northern NSW Football Insurance site: https://football-nthnsw.gowgatessport.com.au.
- 10. You agree to indemnify, and will continue to indemnify, hold harmless and defend Bellbird Jnr FC (including each of their directors, officers, employees, agents, contractors and assigns) from and against all actions, proceedings, suits, claims, liabilities, damage, costs and expenses that may be incurred or sustained by each of them arising out of any person commencing any proceedings against you for any assault, negligence and/or breach of the Football Australia Statutes, Laws of the Game and/or Bellbird Jnr FC's Rules, regulations or policies.
- 11. You acknowledge that if you suffer any injury (including illness, disability or death) whilst participating in football activities and a cause of injury was the negligence, assault or breach of other obligations imposed by laws, then the liability of Bellbird Jnr FC (including each of their directors, officers, employees, agents, contractors and assigns) is limited to the extent of any applicable insurance policy held by Northern NSW Football and the amount which such insurer pays under the policy or applicable statutory insurance scheme.

 12. You acknowledge and agree that Bellbird Jnr FC are not liable to you for any loss or damage you suffer as a result of Competitions or Matches being cancelled, postponed or changed.

Privacy and your Personal Information

- 13. You acknowledge that the personal information that Bellbird Jnr FC collects from you is used and disclosed for the purposes set out in the Bellbird Jnr FC Privacy Policy, including processing your registration, the organisation, conduct and promotion of Competitions and Matches, the provision of football-related information and offers from Bellbird Jnr FC, and information about our commercial partners, tickets and events as part of Bellbird Jnr FC. You further acknowledge that Bellbird Jnr FC may use third parties to collect your personal information or give them your information to help us run football or as required by law (such as IT providers, venue operators or ticketing operators). A copy of the Privacy Policy is available on www.bellbirdjuniorfootballclub.com.au. You may request access to your personal information that Bellbird Jnr FC holds by sending an email to bellbirdjfc@huntervalleyfootball.net.au.
- 14. You consent to the collection, use and disclosure of your personal information as described in clause 13. If you do not want to receive certain information from Bellbird Jnr FC (other than communications that are reasonably necessary for the administration of football) and their commercial partners, you will be given an opportunity to opt out of such communications.
- 15. You acknowledge that in addition to clause 13, Bellbird Jnr FC may also seek to gather more detailed information about Members in order to adopt a more needs-based approach to the development of the game of football.

Grievances in Football

16. You agree to submit exclusively to the jurisdiction of the Bellbird Jnr FC Grievance Procedure and to not attempt to resolve any dispute or grievance the subject matter of the Football Australia Statutes in a court of law or by any other method.

Period of Registration

- 17. You acknowledge and agree that registration is with the Club until the later of the end of the Season or the time as specified in the Competition Rules, which may be specified in PlayFootball.
- 18. You are expected to attend all training and playing events throughout the Period of Registration.

Fees

19. You agree to pay registration fees due to the Club prior to **training** or **playing**.

De-registration and Refunds

- 20. You acknowledge and agree that if you wish to cancel your registration, you must comply with the process outlined in the National Registration, Status and Transfer Regulations.
- 21. You acknowledge that all refunds are regulated by the National Registration Fee Refund Policy available here.
- 22. You acknowledge that cancelling your registration prior to the season commencement will result in Bellbird Jnr FC withholding a \$50 admin fee.
- 23. You acknowledge that cancelling your registration post season commencement will result in no refund being given.
- 24. You acknowledge and agree that Bellbird Jnr FC may de-register you at any time by notice in person or in writing to the address or email address provided as part of your registration, including in the event that you breach these Terms or do not comply with its incorporated documents, such as the Football Australia Statutes and Bellbird Jnr FC's Rules, regulations and policies.

Team Allocation

25. Allocation of players to teams will be at the discretion of the Club. Friendship requests will be considered but are NOT guaranteed.

Assisting with Club Management

26. You agree that over the course of the season, you will accept any requests to give time freely to activities such as the set-up of grounds, assisting with the canteen, assisting with the club barbeque, etc.

Participant Drop off, Collection and Transportation

27. You agree that if you are responsible for a Member who is under 18 years of age that you must not leave the facility after dropping off your child for an event.

Attendance of Events

- 28. You agree that you may be placed into competitions which may have matches scheduled outside of the Zone boundaries and also be administered by other Associations.
- 29. You agree that if a match is a considerable distance from your residence, then you will plan ahead of schedule allowing that match to proceed.

Active Kids Vouchers

- 30. If you are choosing to pay for registration partly with an Active Kids Voucher, you must have your Active Kids Voucher applied through registration.
- 31. Active Kids Vouchers will not be accepted post registration and cannot be refunded or cashed in.

Club Uniform and Equipment

- 32. You acknowledge that you must be in full Club Uniform (jersey, shorts, socks) when representing Bellbird Jnr FC on the field.
- 33. Players will need to purchase club shirt, shorts and socks to wear or use on matchday only.
- 34. **Training kits and gear bags** are wholly owned by Bellbird Jnr FC and must be returned to Bellbird Jnr FC upon either the completion of the season, or at a directed time and location post deregistration. Failure to return Club Uniform or Equipment will result in you being placed on the FA unfinancial list.

Codes of Conduct

35. You agree to adhere to the relevant Codes of Conduct for your registered role available at www.bellbirdjuniorfootballclub.com.au.

Interpretation

36. Capitalised words used in these terms and conditions have the meaning given to them in the Football Australia Statutes, unless the context requires otherwise or unless otherwise defined within these terms. A reference to "you" and "your" is to be interpreted to include the Member where the parent or legal guardian is registering a Member who is under 18 years of age.
