



WHAT IS ADVOCACY?



In the context of PTA, advocacy is supporting and speaking up for children — in schools, in communities, and before government bodies and other organizations that make decisions affecting children.

PTA speaks for every child with one voice. As the largest volunteer child advocacy organization in the nation, we are the conscience of the country for issues affecting children and youth. Each year National and state PTAs publish a public policy platform that outlines policy priorities and recommendations for Congress.

Across the country, our members devote time and resources to advocating on issues that help make every child's potential a reality. Their work affects legislative and/or regulatory policies on a state and/or local level. PTA advocacy efforts include working with multiple organizations or coalitions through grassroots collaboration, raising public awareness on critical issues and developing advocacy training for their membership to create a larger voice from the community to influence positive change.

Michigan PTA 2022 Advocacy Asks

- 1. **Support Increased School Funding.** Make needed investments in education for continued COVID relief to Michigan Schools to provide a safe environment and maximize education delivery for our children, teachers, and administrators across the state.
- 2. **Oppose the two Let MI Kids Learn Petitions.** If these petition campaigns are successful, Michigan PTA is asking Michigan legislators not to pass legislation to enact them into law.
- 3. **Support Seizure Safe Schools Bill HB4970.** Pass Seizure Safe Schools legislation to ensure that schools are well-equipped with the tools necessary to provide a safe and enriching environment for students living with epilepsy and seizure disorders.
- 4. **Support Increased School Safety.** Continue their commitment to Safe and Supportive Schools through legislation and funding, working on both prevention and treatment for all students.

Now is the time to meet with your state legislators about these "Asks" (and any other issues arising from your own school communities). Remember to include student members in these meetings wherever possible, and let them handle some of the communication.

Once you have had your conversations with your State Representative and/or State Senator, please send a quick report to childadvocacyvp@michiganpta.org about whom you met with and how it went.

After the legislative meetings are complete, we will hold a follow-up event – the **2022 Michigan PTA Advocacy Round-Up**, on **Wednesday**, **April 13th at 6:30 p.m.** This will be our opportunity to debrief the meetings that have been held around the state, give an update on the progress of specific legislation, and discuss any urgent action items that have been identified. We will also share how you can become involved in advocacy at the state level. Volunteers are always welcome!

Advocacy is a vital part of Michigan PTA, and all local PTAs are encouraged to make advocacy education and discussions part of their PTA meetings. Michigan PTA Advocacy Day Events

Given the current Covid-19 situation, we have converted our upcoming Michigan PTA Advocacy Day to a series of smaller virtual events, as follows:

Saturday, March 19, 2022 (10 a.m. - 12 p.m.): Advocacy Summit will include key Michigan stakeholders as speakers, present the Michigan PTA legislative "asks" for 2022, and provide legislative background and training. March 25, 2022 - April 11, 2022: The Summit is followed by a two-week window for members to meet with their legislators about the "asks." Legislators will be available in their home districts during this time that the Legislature is not in session.

April 13, 2022 (evening, TBD): Advocacy Round-Up will include a debrief of legislative meetings, share action items, and invite participation in advocacy at the state level

Federal Legislative Report

National Convention Celebrating 125 Years!

National PTA Convention Registration is NOW Open! Join us in Washington D.C. June 13-19, 2022 at the Gaylord National Resort & Convention Center, National Harbor, MD. This year the Legislative Conference will be part of Convention, with Hill Day happening on June 14th. Update on National PTA and Michigan PTA Federal Outreach

February 21-25, 2022 was Public Schools Week! We reached out to our federal officials asking them to join us in celebration of our school districts that educate 91% of K-12 children.

Working with the Newtown Action Alliance, Michigan PTA has been continuing to reach out to our federal House representatives to get sponsors for Ethan's Law, HR 748, a federal law requiring safe storage to keep minors from having unattended access to firearms. As of this writing, the Bill has 208 sponsors! Remember that once this bill reaches 218, a vote must occur in the House. In Michigan, we have not been able to increase the number of sponsors beyond the original seven yet, but we have been successful in setting up meetings with offices to discuss this important piece of child safety legislation.

Senator Stabenow's office has informed us that she is working to make sure that the USDA nutrition waivers, which allow for no-cost school meals, continue for the 2022/23 school year. Senator Stabenow is the Chair of the Agricultural Committee, and we appreciate her commitment to make sure all children have access to meals during the school day. In 2019 the National School Lunch debt was \$262 million nationwide, with 75% of school districts reporting families with outstanding payments. Continuing this program alleviates stress on families and allows for school districts to have more money to go toward other expenses. Please contact Senators Stabenow and Peters, and your federal House representatives to let them know how important these waivers are to our Michigan families.

National PTA had a call to action asking that the US House of Representatives support the STANDUP Act which focuses on suicide prevention training. This bill has already passed in the Senate. It is a continuation of National PTA's focus on student mental health in resources, knowledge, and funding. A Message From the President

The first quarter of each new year is always full of celebration with Founders Day events and award celebrations. This year we have added a celebration marking a quasquicentennial celebration. 125 Years of advocating for Children!

Continuing a timeline that extends as long as 125 years, PTA stays relevant by always staying focused on the mission:

To make every child's potential a reality by engaging and empowering families and communities to advocate for all children.

How do we keep the flame of the mission always burning? That is typically found in our innovation of how we deliver the mission. There are endless ways to engage families, empower children, and for all of us to play a role in advocacy.

It may seem very daunting for some of you to increase the flame right now. You may have just started to come out of two years of barriers and roadblocks where you have had to turn around and try again when events were delayed or canceled. It was exhausting.

Where do you start now?

Softly blow on the flame to give it oxygen. Consider the successful activities and events that occurred prior to 2019. What were those committees and events that always had your students and community talking? Which ones work best with your current team and volunteers? Don't create the expectation that everything must restart the way it always had been done before. Remember, if you blow on the flame too hard, you might extinguish it.

Share the flame by igniting someone else's. Now is a great time to consider events and opportunities your PTA community hasn't done before. Listen to new ideas from your volunteers, hand them their own torch to see the mission forward.

And finally build that community bonfire and brag! Share your activities, using the media that works best for YOUR community. I know I love to hear about what your teacher grants provide to your students. I enjoy hearing about fun runs, fundraisers, all the "nights" like Science, Math, Reading, Career, and more. Sharing your mission will make everyone's flame brighter for PTA.

Thank you for protecting the flame that burns for our mission. I appreciate the light that each of you brings.
