Vendor spots are 10' x 10'. Vendors must bring their own tent, tables, 25-lb weights for each tent leg, table coverings, chairs and electrical extension cords (if needed). Set-up begins at 8:30 a.m. with all Vendors setup no later than 11:30 a.m. Breakdown begins at 6:30 p.m. with all Vendors out of the park by 8:00 p.m.

VENDOR AGREEMENT AND SAFETY TERMS AND CONDITIONS

- Event occurs rain or shine. Please be prepared for wind, rain and/or heat/cold.
- No Refunds. All vendor payments are final.
- Loading/Unloading information will be provided two days before event.
- All Vendors must be setup by 11:30 a.m. and remain setup until 6:00 p.m.
- Electricity is available throughout the park; however, all vending spot may not have access to electrical outlets. Vendors must supply their own electrical extension cords (100 ft recommended).
- All Food vending must be accomplished inside the park. No Food Trucks allowed inside the park.
- Food Vendors Fees are applicable to all Vendors selling meals/entrees (Desserts and other food items pay only the retail fee).
- Food Vendors (Entrée- meals) must have appropriate food license and insurance coverage with them at all times during the event.
- Food Vendors cooking on-site are responsible for discarding used oil, trash, and leftover food. Food Vendors must provide a grease proof tarp/covering to avoid grease contamination and food spills on the ground. Food Vendors cooking with fire must possess a fire extinguisher at all times.
- All Vendors are responsible for the sale, distribution and protection of their products during the event. There is no guarantee of product sales.
- All Vendor booths must be staffed at all times during Bazaar hours.
- All Vendors agree to sell only the items listed on this contract.
- All tents must be 2 feet apart. Tampa Fire & Rescue Inspectors will strictly enforce this City of Tampa code.
- Parking in Ybor City on Sunday is FREE! There are several City of Tampa Parking lots across from the park and within 1-2 blocks of the park. **DO NOT LEAVE YOUR VEHICLE PARKED ON 9TH AVE, 18TH STREET, OR 19TH STREET AFTER UNLOADING OR YOUR VEHICLE WILL BE TOWED AT YOUR EXPENSE.**
- Reserved Parking directly next to the Park is available at an additional fee of \$10 (all day) and must be paid at the same time as Vendor fee is paid.
- All Vendors are responsible for the cleanup of their booth area after tear down.
- Boutique owners will have up to 15 minutes to showcase their fashions on the runway during the Bazaar. Boutique owners will provide their own models and announcers for the fashion showcase.
- This is a family fun-filled event, please refrain from offensive language or behavior inappropriate for children.
