Drawdown: Ron H, pg 10, Rooftop Solar Brett Moser at Advanced Energy Systems (AES), Eugene knows the details of different utilities and the available incentives and costs. An average residential solar system is 4.7 kW capacity, with an average total cost about \$11,000 after federal, state and utility incentives. The federal solar incentive will decrease somewhat at end of 2019. AES was recommended and used by Rouanna G. Systems are typically grid tied, so there are varying amounts of credit for electricity sent back to the grid during peak generation. The best is Pacific Power in parts of Lane county which gives full credit for the entire year. EWEB in Eugene is notably better than Springfield.

2) Merrily: On Jan. 13, 2019, the Register-Guard carried an article about the stalemate between Oregon Fish and Wildlife Commission and the four conservation groups trying to negotiate an Oregon Wolf Plan. The groups have been trying to update the plan since 2015 but "revisions became mired in argument and repeated delays ensued." The state hired a professional facilitator last year to oversee the 5 scheduled meetings beginning last August. "But all four conservation groups involved pulled out of the discussions just before the last meeting. The groups said the state failed to seriously consider their proposals."
