1. Mild
2. Hot
3. Traditional

### Presentation

1. Participants are to bring their chili in a covered container.
2. Participants' names and/or number printed clearly on the container.

### Performance / Scoring

1. Judges scoring sheets will not be viewed by anyone other than the judging committee.
2. If there is a tie, there will be a secondary testing to determine the winners.
