#### **Karaoke Rules and Regulations**

No Entry Fee for this contest. Prior registration is required.

- 1. All entries must be received by May 30, 2024
- 2. Winners must be present to win.
- 3. Solo performances only
- 4. Amateur contestants ONLY!
- 5. The order of performances will be up to the judging committee. Their decision is final.
- 6. One song per performance.
- 7. ABSOLUTELY no provocative or inappropriate lyrics. The judging committee has final decision and can eliminate contestant should it be necessary.
- 8. Participants under 18 must have waiver(s) signed by parent/guardian and parent/guardian must be present.

#### **Performance / Scoring**

- 1. Judges scoring sheets will not be viewed by anyone other than the judging committee.
- 2. Max points per judge is 100.
- 3. If there is a tie, we will have a "Sing-off".
- 4. There will be a First and Second place winner in each category.

#### **Categories:**

- a. 6-10 years of age
- b. 11-16 years of age
- c. 17 and above

#### Scoring criteria:

- A. Vocal Performance and Singing ability: (to include proper pitch, tone, and rhythm ect.)
- B. Stage Presence and Presentation: (Including Originality of movement, dance, appearance, and command of audience.
- C. Difficulty of the song.
- D. Audience reaction.
