1. No hands may be used.
 - a. Contestants will place their hands behind their backs during the competition.
2. Winner will be First done or nearest to being done, when time limit expires.
 - a. Judges will decide the level of completion.
3. In case of a tie, there will be an Eat off between the Contestants.
4. Contestants may not leave the table for any reason.
5. Visible signs of sickness will disqualify the contestant.
6. All Registration and Waivers must be signed PRIOR to the contest start.

There are three age categories: 1. 7-11
2. 12-15
3. 16 and above

All discrepancies will be decided by the judges and judging committee.
