No entry fee for this contest. Prior registration is required.

- 1. Age Groups for competition.
 - a. 8 to 12 yr. old
 - b. 13 to 16 yr. old
 - c. 17 and above
- 2. There will be a First and Second place award, in each group.
- 3. Amateur contestants only.
- 4. Contestants must arrive 30 min prior to the contest start time.
- 5. The contest will be timed: 3 minutes to finish eating your share of watermelon.
 - a. A whistle will end the contest.
- 6. If a participant cannot keep the watermelon down, they will be disqualified from winning.
- 7. In case of a tie: There will be an "tie breaker" between the contestants who tied.

All discrepancies will be decided by the judges/judging committee.


