

Wrobleski Party Rentals Terms and Conditions

1. This rental contract constitutes the entire contract between Wrobleski Party Rentals and the Renter and no modifications shall be valid unless written upon or attached hereto and same are approved in writing by an officer of Wrobleski Party Rentals.
2. Insurance, if desired by Renter, must be obtained by him/her at their own expense. Wrobleski Party Rentals assumes no risk; and by acceptance of this agreement, the Renter expressly releases Wrobleski Party Rentals of and from any and all liability for any damages, injury or loss to any person or goods which may arise from the rental and occupation of said tent by Renter and agrees to hold and save Wrobleski Party Rentals harmless of any and all loss or damage by reason thereof. Wrobleski Party Rentals assumes no responsibility whatsoever for any property placed in the tent and persons or property that may be sustained while in said tent, or at tent site.
3. By acceptance of this agreement, Renter agrees to assume all responsibility for damages to the tent or other rented equipment by reason of vandalism, negligence, theft or any and all similar causes during the entire time of the tent rental.
4. Wrobleski Party Rentals assumes no responsibility for damage or repairs to tent site including asphalt, lawns, shrubbery, septic tanks, sprinkler systems, etc., caused by tent stakes, poles or other rented equipment.
5. If delivery location is not easily accessible, is on a hazardous road, or in a location where large trucks do not usually go there can be an audit to the final price.
6. It is the responsibility of the Renter to secure all necessary permits, licenses, etc., for the erection and installation of the aforementioned tents, lights and dance floors, if any are required.
7. Renter acknowledges that in the course of installation or removal of said tent and equipment a vehicle may be required, at the discretion of Wrobleski Party Rentals representative, to operate on the site of such installation or removal and that Wrobleski Party Rentals shall not be held responsible for any damages which might occur.
8. The conditions, rules and regulations printed herein are made a part hereof and incorporated herein and the Renter agrees to be bound by each and every one of them and Wrobleski Party Rentals shall have full power in the matter of interpretation, amendment and enforcement of all said conditions, rules and regulations.
9. A 10 percent charge will be added to the cost of the total chairs and tables rental for the set up and/or take down of said chairs and tables. All tables and chairs must be stacked neatly for pickup in the manner that they were delivered, unless otherwise discussed, prior to pickup. All chairs must be stacked on the pallets they were dropped off on. White padded chairs are stacked in 25 and white plastic chairs are stacked in 50.
10. A 25 percent non-refundable deposit is due upon signing rental agreement with the remaining balance due the day of delivery or installation.

11. CANCELLATION POLICY

-25% deposit is non refundable after made.

-If cancelled within 20 days of the event, 50% of remaining balance will be due within 10 days of cancellation.

-If cancelled within 10 days of the event, 75% of remaining balance will be due within 10 days of cancellation.

-If truck is already loaded (trucks get loaded the night before) and any item, or whole order is cancelled – there is still a 100% charge.

We are promising this equipment to you, and missing out on the opportunity to rent it to someone else. Our charges are non negotiable.

12. Wrobleski Party Rentals will install and remove as his schedule and/or weather permits. In the unlikely event of exceptionally severe weather forecasts, Wrobleski Party Rentals reserves the right to return the deposit to the Renter and to not provide the items requested.
13. Tents and rented items are not intended to be used as a shelter from severe weather. Evacuate immediately if threatening weather occurs or is forecasted, or if any condition that arises concerning the safe use of rented items. Threatening weather includes electrical storm systems, moderate to high winds (excess of 20mph), heavy rains, snow, or any other condition that raises any doubt to the structural integrity of the tent or rented items.
14. If renter modifies the heaters in any matter, they need to be return in the same working condition as they were delivered upon pickup. If any or all parts, pieces or if the heater or heaters do not function upon time of pickup. It will be the renters responsibility to fix or replace said heaters.
