1. ACKNOWLEDGMENT OF RISK

The Customer acknowledges that the use of inflatable amusement devices, including moon bounces, involves inherent risks of injury, including but not limited to falls, collisions, improper use, weather-related incidents, and other accidents that may result in serious injury, disability, or death.

2. ASSUMPTION OF RISK

The Customer voluntarily assumes all risks associated with the use of the rented moon bounce and agrees to supervise all participants at all times during the rental period.

3. RELEASE OF LIABILITY

In consideration for the rental of the moon bounce, the Customer agrees to release, waive, discharge, and hold harmless Foundation Entertainment Mobile DJ, LLC, its owners, members, employees, contractors, agents, and representatives from any and all claims, demands, actions, causes of action, damages, losses, costs, expenses, or liabilities arising from or related to the use of the moon bounce, except in cases of gross negligence or willful misconduct.

4. CUSTOMER RESPONSIBILITIES

- Provide adequate adult supervision at all times.
- Follow all safety rules and operating instructions provided.
- Prevent roughhousing, flips, wrestling, or unsafe behavior.
- Ensure participants remove shoes, eyeglasses, jewelry, and sharp objects before entering.

- Not allow food, drinks, gum, pets, or silly string inside the inflatable.
- Not exceed the recommended capacity or weight limits.
- Keep the inflatable away from water unless specifically designed for water use.
- Immediately discontinue use during high winds, severe weather, lightning, or unsafe conditions.

5. EQUIPMENT DAMAGE

The Customer accepts responsibility for any damage to the inflatable caused by misuse, negligence, vandalism, unauthorized relocation, pets, fireworks, smoking, sharp objects, or failure to follow operating instructions. The Customer agrees to pay for repair or replacement costs resulting from such damage.

6. WEATHER POLICY

Foundation Entertainment Mobile DJ, LLC reserves the right to cancel or terminate the rental due to dangerous weather conditions, including high winds, thunderstorms, or other unsafe circumstances.

7. INDEMNIFICATION

The Customer agrees to indemnify and hold harmless Foundation Entertainment Mobile DJ, LLC from any claims, lawsuits, judgments, attorney fees, or expenses arising from the Customer's use of the inflatable.
