

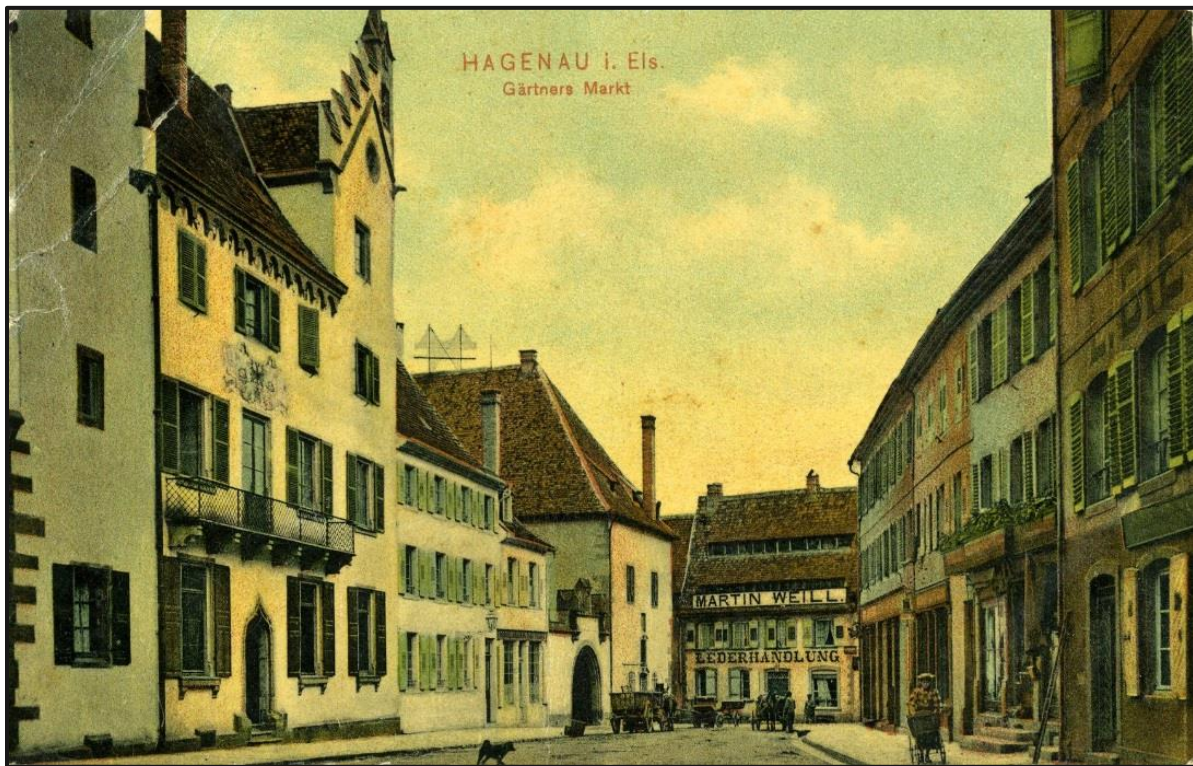

Documents Searched and Translated

All Soufflenheim records in the *Table générale* were viewed. Some mention Soufflenheim but do not give names. Others provide short lists. There is no list of all or most citizens. No fief land records listing adjacent owners were found. Fief's can also be a right to income from a function, such as provost of Soufflenheim (Schultheiss), or an amount of money due on a tax, such as the "dime" church tax.

Series	Date	Description
C 28 (12)	1496	Question between the city of Hagenau and Soufflenheim; letter sent: the palatine Elector Philippe to Jacques de Felckenstein, under bailiff, asking him to negotiate with the town of Hagenau concerning the grazing and the firewood ; quarrel on the subject between the city and the residents of Soufflenheim, asking namely that he "would release prisoners and give back the mortgaged horses". One Piece.

To my right honourable, respected Lord, Palatine Elector, this is a request sent by your very faithful servant : concerning the office of provost of Soufflenheim, you wrote some time ago that I should send a report concerning advantage and disadvantage to this ; I can just say that at this time Hans Jacob Knobloch is holding the office of provost of Soufflenheim, and has accepted it ; however in my opinion my function of under bailiff would authorize me to name a provost ; as the former provost Mathis Reinwalt has contested this nomination and pretends to come back to this function ; so this is my request that I am allowed to keep the man I named Hans Jacob Knobloch as a provost, as I am authorized as under bailiff to name him.

As I do not find advantage or disadvantage to this function of provost of Soufflenheim, my request to you is that I can decide about the function of the named Knobloch as provost in Soufflenheim, that his wages would be left at 2 Gulden for his function, and not advise him about this question, this is my humble request to you, written this 3rd Maÿ 1539 and signed. Passed in Hagenau 3rd March 1539 : signed Conrad von Rechberg, Under bailiff.

[Letter sent by Conrad de Rechberg, under bailiff to the palatine Elector, Louis, concerning the office of provost in Soufflenheim. Question of whether the provost is named by the Prefecture or by the community of Soufflenheim. Followed: Rights of several communities depending of the Prefecture of Hagenau in Soufflenheim, Kuttolsheim, Surbourg, Wingersheim, right to name the provost; rights and privileges of the Prefecture in this regard.]

LETTER BY THE PREFECTURE OF HAGUENAU TO DUKE MAXIMILIAN

14 February 1606 C50 (6) Two Pages. Completely Translated.

Gabriel Müller provost in Soufflenheim requests humbly that his horse that he has lost in the last time, would be replaced, and in consideration of his poor situation, that a sum allowing him to buy another one would be granted as needed for his function. This request has been transmitted by the officers of the bailliffrick of Hagenau to Maximilian of Austria. They add to this that ; in consideration of his good services, and that he was not cause that he lost the horse, but bad people had decided to do harm, on

the other side he is a rather poor man, and rather aging, with many children, so it would be fit to think of a better payment of his services, so that the officers suggest that only the horse should be replaced, but a larger sum granted to prove your appreciation and concern ; the officers are confident that your Highness will feel compassion with this good servant, and sign. Haguenau 14 February 1606. The bailiff, and counselors of Under Alsace: Rudolff Graf zu Zultz, Gerg Streinle.

[Letter sent by the court of Ensisheim to the Prefecture : asks permission to restitute a sum of 15 florins to Gabriel Müller, provost in Soufflenheim, to compensate his loss on an injured horse.]

DECISION ON GABRIEL MÜLLER

As our House has received the letter concerning Gabriel Müller, provost of Soufflenheim, Maximilian of Austria decides that as he Müller is a good obedient person, he has found interest in his letter and decided on the 28th of April to send the necessary amount of 15 Gulden which will authorize him Müller to buy a new horse as the first one has been killed by bad persons ; so the Emperor has followed the decision of the officers and this will be announced in our accounts. LETTER BY THE PALATINE ELECTOR FRÉDÉRIC, COUNT, TO HENRI DE FLECKENSTEIN

December 1551 C50 (8) Two Pages. Completely Translated.

Fredrich Graf Churfurst, sends his greetings to our dear faithful friend ; I did receive both your two letters concerning the present provost of Soufflenheim and your desire to change him for the one you have chosen for this office, among other requests, concerning the content of these letters after consideration my decision is the following : concerning the levee of troops and guards, that you should receive this amount in a few days, and this we have already ordered and also discussed that you will receive them and that their payment as you have proposed should range between five or six gulden, and concerning this exact amount you will have to contact our accouter (Zinsmeister) so that he also will receive cost and meals that will be needed ; you are also authorized to name a provost in Dangolsheim for a year ; third : you asked me concerning the present provost of Soufflenheim, Bernhart Vester, and that you want him dismissed of his functions. So I authorize you hereby to negotiate with Heinrich Schlupfer concerning his functions, and let known the decision to the Chancellor.

We have also decided that Bernhard Vester provost in Soufflenheim in his office there, as your intention is to have him dismissed ; we can authorize this but the legal way must be respected, and our discussion for the moment not opened to him nor anybody, so that it will only be on the right moment, when you have contacted Heinrich Schlupfer and discussed with him that this can be officialized in front of our Court (Canzlei) and that this will take the form of a decree decided by our authority and the dismissing will precede very soon the installation of the new provost, as from both your letters sent to me and to which I give the best attention and benevolent feeling. Written in Heidelberg, Thursday after Christmas day.

[Letter sent by the palatine Elector Frédéric, count, to Henri de Fleckenstein, concerning the levee of troops ; he also orders him to negotiate with Henri Schlupfer concerning the office of provost in Soufflenheim, and to advise the provost in charge that he is dismissed.]

LETTER TO THE PALATINE ELECTOR LUDWIG HERZOG IN BAYERN

Do not give any payment of wages to Hans Jacob Knobloch as provost, and decide yourself if you choose this Hans Jacob Knobloch or someone else as it is your privilege of bailiff to decide ; however I must say that a few days ago Mathis Reinwalt has come here, and has explained that he would not continue to be the provost of Soufflenheim as he feels that there is no advantage to this and has asked me to keep the named Knobloch as a provost in Soufflenheim as he would not that the place in question is not filled by some man, so I wished to mention this honestly ; you will also see that the new named provost will be a man you can trust and who is able to keep a promise, and be silent when necessary. You may also take contact with Heinrich Schlupfer who could eventually be named if you like. And inform in any case the chancellery of your decision. So that it will be confirmed ; Heidelberg, Thursday after Christmas 1551.

C 54 (4) 1608-1610 : Niedheimer Dispute

Thirty-six pieces. Bundle concerning the suit intended by family Niedheimer de Wassenbourg against the community of Soufflenheim concerning a district in the forest and ponds on the ban of Soufflenheim, this district has been plundered by the community of Soufflenheim who contests these rights to the family Niedheimer ; the court of Hanau Lichtenberg in Bouxwiller is asked to raise 500 florins on the community of Soufflenheim for the wood taken out and sold by Soufflenheim's community. The family of Niedheimer refuses the proposal of the community of Soufflenheim to offer a caution.

The Niedheimer family endowed with a fief in Soufflenheim ; several documents concerning the forest ; the damage to several trees and complaint about "those in Soufflenheim" (no names) signed by Johann Jacob Niedheimer de Wasenbourg.

So that we also have immediately ordered the necessary frames, wood, tiles and other material to bring very early solution and are waiting now for your authorization and more instructions on this matter. Passed in Hagenau the 14 December 1615. Signed Dinckel, renter, Jost Scholl; cashier.

Wilhelm Schelling as forester after his oath tells about facts occurred Friday 14th May, and reported to the town scribe, that on this day he had been in the forest of Soufflenheim on horseback, with companions, as they had heard that a man from Gries had been seen in the forest, so that he was accompanied by Hans Stäb and Simon in the forest ; on Saturday they went to a place named Remelshaus in the forest, where the named Meybeck told them he would be surprised that they would be there unguilty and so spoke the man from Gries ; and Hans Meybeck started to fight with them ; so that he Wilhelm has also started fighting and the other foresters ran after them. Hans Vetsch carried two deer's that had without doubt been shot in the forest of Soufflenheim. [End of First Page].

So we here mention what we know about this event of poaching in the forest of Soufflenheim and our behavior on this occasion.

[Report of the Receiver of the Prefecture concerning problem of poaching in the forest of Soufflenheim. Regarding this letter and its author, the translator says "This is not clear. I think the scribe wrote the letter in place of Willhelm Schelling. I made a complete transcription of the first page, and read the rest of the document without a complete transcription and translation. I have added the signature at the end when present. There is an extreme difficulty in reading and analyzing these letters, some of them very discouraging, and I am not a chartist by training". The document was rechecked and Wilhelm Schelling, Hans Stab, Simon, Hans Meybeck, and Hans Vetsch are believed to have lived in Soufflenheim.]

REPORT BY HANS STÄB AND SIMON, FORESTERS

03 January 1604 C88 (81) One Page. Completely Translated.

Hans Stäb and Simon, foresters, by oath have been asked how it happened on occasion when they accompanied Hans Meybeck, and that Claus the town guard was shot in the forest of Soufflenheim. Follows declaration by Hans Stäb: He says he saw Claus there. Simon Bieber: He says he saw Claus.

[Regarding this letter its author, according to the translator "The entire page was translated. This is a report by a scribe, in name of Hans Stäb and Simon, foresters, the authors of the letter but who addressed themselves to a scribe to write down in their name. No signature." The document was rechecked and Hans Stab, Simon Bieber, Hans Maybeck, and Claus (town guard) lived in Soufflenheim.]

LETTER BY JOHANNES MEYBECK, FORESTER

07 September 1605 C88 (84) Three pages. First page completely translated. Pages 2-3 an extract.

Letter to the count : written by Bernhard Katelshoffer, former forest-guard in Soufflenheim, concerning my payment as such in this function ; as the receiver Johann Georg Mahler has refused to pay me ten gulden on the proposed wages but declared that my function was that of a wood forester and paid at this rate by the receiver ; and this has been told this way to my wife by Dr. Misterspach, receiver of rents. I swear that I have been taken by oath as a forest guard and game guard, and not as a wood surveyor, so that I ask the proper payment and clothing of your Highness, and be maintained in the position in which I have been installed and not retrograded to the position the receiver pretends I am now standing.

[J. Meybeck, forester in Soufflenheim. letter to the Prefecture of Haguenau : Complains against the receiver of the Prefecture for nonpayment of wages. Written in German. According to the translator "I just translated page one, and read the others. There was no major information nor names of residents of Soufflenheim in any of the other two pages." The index in the archives describes the letter as: "Letter by Johannes Meybeck, forester". When I read the record, I see that it has been signed by Johannes Meybeck indeed, but starts with joined testimony in form of letter with words : Bernhard Katelshoffer "former forester" so prior to Johannes Meybeck to confirm what the position of forester in Soufflenheim really is, and that Johannes Meybeck is now denied, reason of his protest. As I did not translate the full 3 pages, I suppose it is made clearer in pages 2 and 3". This document was checked a second time to determine if J. Meybeck, was a forester in the forest of Soufflenheim or the village of Soufflenheim. After additional research, it was the opinion of the researcher that Johannes Meybeck was definitely a forester of the forest of Soufflenheim.]

LETTER BY PROVOST OF SOUFFLENHEIM CONCERNING HANS MEYBECK, FORESTER

To the Council and House of Austria. Sent by the provost of Soufflenheim. Concerning several persons of Haguenau who have mentioned that Hans Meyenbeck, our named game surveyor complains about his not having received the proper payment, and that he asks to be treated as on time of his engagement by the authority, and receive so the same payment, and so the provost of Soufflenheim has received a word that the named Hans Meyenbeck should receive this as normally.

Regarding this letter and who wrote it, according to the translator "The letter is sent by the provost, not named, of Soufflenheim, who does not sign, giving only his title of provost. I translated

The document was checked a second time to determine if Jean Meybeck is a resident of Soufflenheim: According to Peres "As it is the responsibility of the Provost (mayor) of Soufflenheim to pay Meybeck, and as the Provost is writing a letter on behalf of Meybeck, it would appear that Meybeck lived in Soufflenheim. After additional research, it was the opinion of the researcher that Johannes Meybeck was definitely a resident of Soufflenheim.]

HAGUENAU MUNICIPAL ARCHIVES

The oldest Soufflenheim records in the archives of the town of Haguenau are found in the *Ancient Archives* from 1334 to 1790.

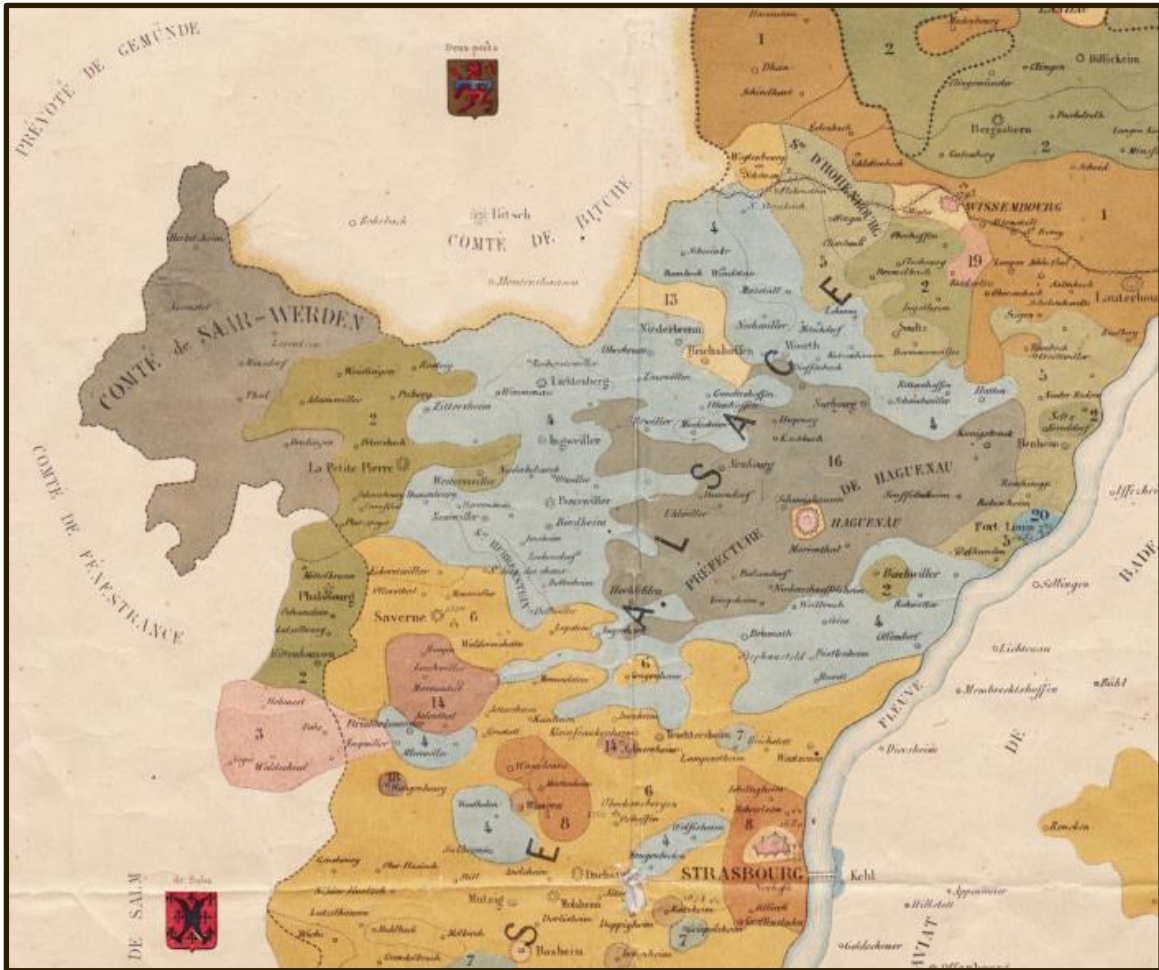
Haguenau, founded in the early 12th century, was given town rights in 1154, becoming an imperial city in 1257. It was the capital of the Landvogtei of Haguenau (later, the Baillage of Haguenau), of which the Prefecture of Haguenau was part, including Soufflenheim, and the seat of the Landvogt of Haguenau, the German imperial representative in Alsace. It housed the executive council of the Decapolis, a defensive association of ten Alsatian towns, and the Maitrise, the Lower Rhine Water and Forest Authority. The royal bailiff of the towns forming the prefecture had no jurisdiction over Haguenau.

Notary Records

Notary records are found in the *Ancient Archives*, Series JJ, Private and Foreign Affairs. There are 54 bundles of estate inventories, 13 of guardianship accounts, 29 bundles of acts by the city clerk, and 57 bundles of acts listed by individual notaries, described as "notaires, tabellions, and Schoeffenschreiber".
