

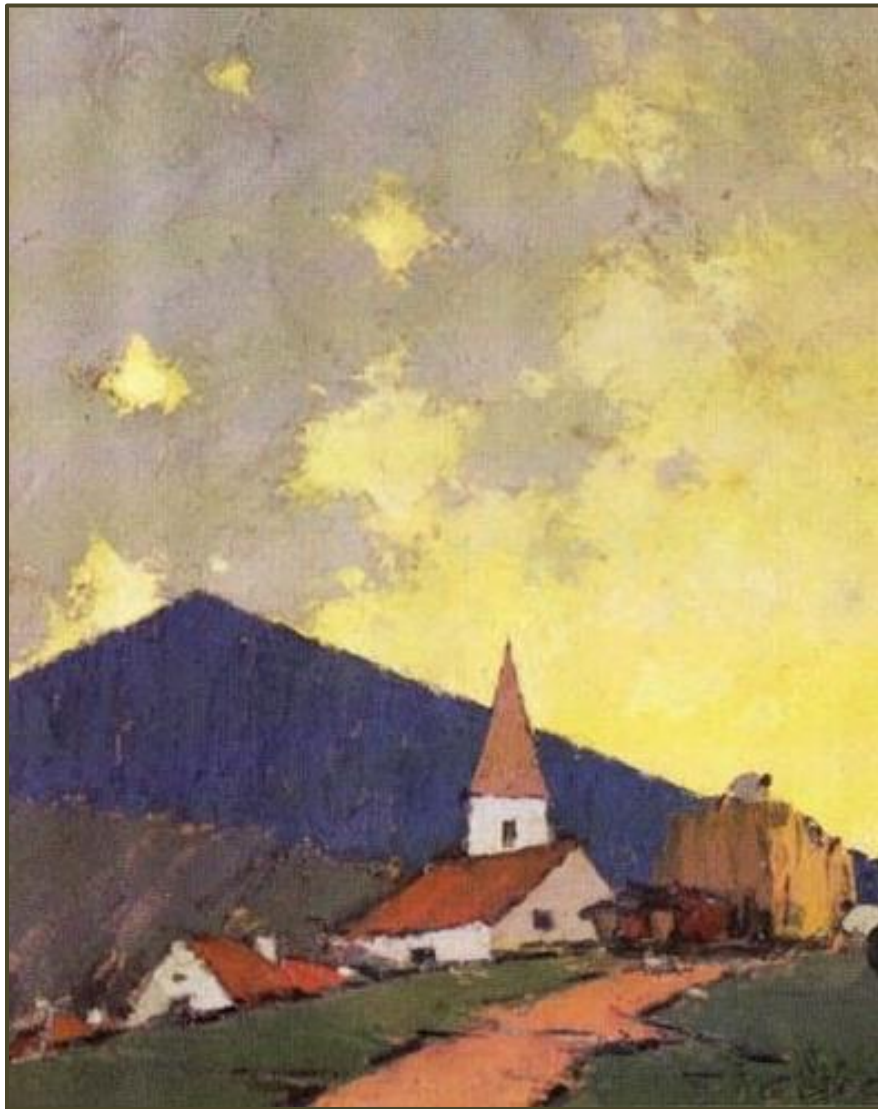

The church accounts of St. Michaels in Soufflenheim from 1691 to 1699 are found in series G6614 at the Archives of Bas-Rhin in Strasbourg. From 1701 onwards in series G6634. Year 1700 is missing.

Money in gulden, shilling and denier. Twelve deniers equal one shilling, ten shillings equal one gulden. Viertel and fiertel are one quarter of a larger unit. Pfenning zins is tax, rent, interest or tribute. Recess, or resting, is money remaining from the previous year. Totals, which can be incorrect, are listed as found.
