The Buyer understands that the deposit is NON-REFUNDABLE. Buyer will forfeit the deposit if:

- 1) Buyer decides he/she no longer wants the puppy.
- 2) Buyer does not make full payment to the Breeder and pick up the above puppy within one week of the release date (unless prior arrangements have been made).

Puppy must be picked up from the breeder in Lake Elsinore, California by 9 weeks of age unless other arrangements have been agreed upon by both parties. Buyer is responsible for all shipping/delivery/ or travel fees.

As the breeder, I agree to provide a healthy, socialized, AKC registrable, purebred Pembroke Welsh Corgi puppy, along with a 3-year health guarantee against congenital diseases. Puppy is guaranteed not to test as "AFFECTED BY" DM, vWd1 or EIC. My puppies go home current on vaccines and dewormings with a written health record. Puppies will be microchipped and vet checked before going home. Sample of their food, blanket and toy with mom's scent, AKC application, and 3 year Health Guarantee will be provided at the time puppy is picked up (health guarantee is available on my website to look over before pickup). Puppies are placed under limited AKC registration unless otherwise requested. (full registration is only needed if you're planning on breeding, pet homes who will be spaying/neutering will not require full AKC for any reason)
