

## Minutes of the 131st Annual General Meeting for the year 2019

#### **Council Attendance:**

- 1. Meeting was called to order at 12:30 pm with Pastor opening with devotions and a prayer.
- 2. The Agenda for the meeting was adopted.
- **3.** Motion for approval of the minutes of the 2018 meeting. Lorne Rueckwald moved, seconded by Lois.
- 4. Quorum was verified.
- 5. Chairperson's Report: Ryan
  - a. Ryan expressed his gratitude for the generosity of the congregation in support in volunteering, outreach and financial.

#### 6. Pastor's Report:

- a. Pastor indicated no plans to retire at this point.
- b. Pastoral home care is growing.

#### 7. Outreach Report:

- a) We focus on the food bank, but the community has great need for this support. Jeff thanked the congregation for their generosity. Jeff pointed out that the food bank accepts winter clothing. Again, we received the maximum grant from Synod for the Snack-Pak programme. Specific activities include:
  - Arnprior Food Bank (\$1000 in chickens),
  - Hospice Renfrew lots of support the St. James joint supper raised over \$1000
  - Operation Christmas Child 15 boxes
  - Big Give cleanup of Division Street. this year we're going to do a barbeque.
  - CLWR not a lot of focus last year due to schedules considering an event this year. Pastor mentioned a CLWR event in Pembroke at St. Timothy's with speaker Rev. Carla Blakely – March 28<sup>th</sup> 9:30 – 12:30.
  - Enid spoke about the process for distribution of work among world relief organizations.
  - Maureen thanked Jeff for his work.
- b) Lois thanked Jeff for all his work on outreach and as well, Dave for newsletter and Randy for all his variety of support for the church.

#### 8. Financial Report:

Randy thanked Alison and Cathy for the work in maintaining the congregational finances.

#### 2019 Actuals:

- a) Givings were on budget.
- b) We had significant other income last year, that won't repeat this year.

- c) The expense line was slightly under due to Pastor's LTD and lower costs for replacement Pastors.
- d) Randy thanked Dave for the music.
- e) Worship expenses lower due to lay worship leadership.
- f) Finished with a deficit of \$2,500. Extraordinary income more than offset the increased special expenses (roof).
- g) Randy noted that we are depending on donation of effort on music, accountant and cleaning. Deficit would be substantial if we had to pay for these.
- h) Randy commented on the large impact St. John's has on the community with its financial and volunteer contributions.

#### Budget 2020:

- a) The Givings budget set the same as last year.
- b) The budget is forecasting a \$6,000 deficit.
- c) Ongoing discussions needed on how to fund the special projects this year.
- d) Lois thanked Pastor Norine for her support and encouragement.
- e) Randy thanked Lorne Rueckwald for his support and efforts with tending to the church and for his pictures.

Randy moved to accept the budget with a deficit, but continuing with efforts to improve, Mel seconded. **CARRJED** 

#### 9. Property:

- a. Dave presented the issues with the basement floor and outlined a recommendation for replacement. Randy spoke about the town works project on Alica Street and the need to co-ordinate with them regarding our connection to the town storm sewers.
- a) Lynn motioned to only do the work outside before doing any inside work. Lorne seconded **CARRIED.**
- Cathy motioned to do the work outside, and remove existing floor then have meeting to make final decision on final floor treatment after we assess the situation. Alison seconded – CARRIED.
- c) Rough planning: we will dig outside in May, repair the drainage and install membrane on the exterior basement walls. We plan on starting to remove existing floor in April.
- d) Randy thanked all those that contributed to the property.

#### 10. Altar Guild:

Lone & Joanne, Keith & Beryl, and Barb and Gerald share the work. Pastor commented that everything always looks immaculate.

#### 11. PAR:

Cathy reported that PAR is working out well.

#### 12. Kitchen Report:

Debbie K. thanked the congregation for their generosity in provisioning the kitchen for socials. There are always people to pitch in on special events.

#### 13. Lutherlyn Report:

Alison spoke about new comfort station and the financial position of the Camp (positive). Pastor spoke about the Picnic Sunday being planned at the camp for an area service/day at the camp on September 13th

#### 14. New Business:

Randy mentioned the co-operation with other churches in the community – we're all trying to co-operate in supporting other events and the coordination of timing.

#### 15. 2020 - 2021 Council Nominations:

- a. Ryan thanked existing council for their efforts and noted Elmer's desire to step down.
- b. Jeff nominated Enid, who agreed to serve, Randy seconded. CARRIED

## **Chairperson's Report – January-June**

Unexpected events can set you back or set you up....it's all a matter of perspective.

This past year, 2020, started out much like the others with several social events planned to help us get through the long, cold Canadian winter. In January, we had a very well-attended "Thank You Breakfast" for the Congregation. In February, we had our annual Family Fun Day, followed the next day by our Annual General Meeting. Little did we know that these would be the last of large social gatherings for the year, as COVID-19 became a global pandemic. Initially, I think that many of us thought that the COVID situation would improve after a couple of weeks or, at the most, a couple months. Never did we think that the church doors would be closed for so many months or that we would be prevented from visiting our loved ones. And even nine months later, as 2021 starts, the situation is relatively unchanged from those weeks in March with much of the country locked down. As bad as it was, the people of St. John's Lutheran Church did not see the COVID situation as a complete setback; in fact, if one were to look for the silver lining, it was an opportunity for change.

And change we did. It did not take long to realize that pre-recording Sunday Services, posting them on YouTube and sharing on Facebook would reach a large proportion of our congregation, as well as those external to our church. The transition from an in-person Service to an electronic Service was by no means easy, but it was necessary. In addition, our Facebook page has never been more active, with several thought-provoking and inspiring posts each and every week. The leadership and the congregation of St. John's Lutheran Church should be commended for embracing such change so early during the pandemic.

## Chairperson's Report – July-December

Following the initial shutdown of in-person worship mandated by the Ontario Government in response to the COVID-19 outbreak, we had a huge task in developing a safe approach to resumption of in-person worship. With the support of the synod task force, our area dean - Rev. Bruce Thompson, our local health dept., and the hard work of our own task force, made up of Lorne, Aman, and Andy, we managed to complete all the requirements for safe resumption of in-person worship in October.

Additionally, we have successfully applied for, and received, almost \$5,700 in wage subsidies available under COVID-19 related assistance to employers. Due the generosity of our members and the successful grant submission to Synod, we have implemented a much-needed

technology upgrade led by Dave Burkett. The main features of this upgrade included: live transmission to internet made possible, improved video and audio capability and large screen tv for viewing hymns.

Dave's outstanding leadership and his commitment to excellence in the weekly production of our recorded and live transmission of worship services were well received by both members and friends of St. John's during the shutdown. It is apparent that this vehicle of communicating our weekly service should be on-going.

For those not on internet, we increased our outreach to members by delivering weekly worship scripts and periodic phone contact led by Enid.

Under Alison's leadership, we had another successful bazaar/bake sale this past fall even though we had to revise our processes due to the COVID-19 risk and restrictions.

There are some key annual savings that we have been realizing because of major volunteer efforts such as:

Cleaning (Barb and Gerald)	\$ 1	.,500
Accounting (Alison)	\$ 2	,400
Grass cutting (Rick & Cathy F)	\$	800
Snow shovelling	\$	800

The annual savings shown here represents either contractor costs we were paying previously or quoted costs from contractors to do the work.

A special thank you to Jeff and Ryan for their service on council. Even as they both continued with full time management positions in their work lives, they were always there when I, or anyone in the congregation, needed them. Working with both of you has been, and always will be, a pleasure. Your intelligence, commitment, leadership skills and humour helped keep church council meetings grounded.

I would also like to recognize Pastor Norine for her spiritual leadership during difficult times, her pastoral care for members in need and especially her efforts to make our online services successful.

Finally, my personal thanks to you, the dedicated and committed members of St. John's, who continue to amaze me with your generosity in giving of time, talent, and funds to support the ongoing work of the church.

## **Pastoral Report**

The year 2020 has taught us plenty. We have learned that we are not in control of all aspects of our lives and secondly that God is in the details. When our corner of the world went into

lockdown in March, it became immediately apparent that life within our churches would change dramatically.

I was able to attend the annual Bishop's Retreat for Pastors in February in Niagara Falls.

St. John's congregation had worship services including Ash Wednesday, their AGM for 2019, and installed new church council members in February. We worshipped and I was able to visit people until March 15, when the first Public Health Provincial Covid -19 lockdown occurred. At that moment we were placed on a high and fast learning curve to pre-record worship services for YouTube, and to deliver our weekly worship scripts to those who did not have internet. This included Services of Word & Prayer and Holy Communion. As face to face pastoral care was not allowed, many phone calls over this year have been made to those confined to home, our younger families, and to all the congregation's members. Church council members have also taken on this contact ministry.

ZOOM calls (an internet video/chat platform) was implemented for monthly meetings with the Bishop and colleagues. Church Council met over teleconferencing phone calls. Weekly calls were exchanged with our Dean, Rev. Bruce Thompson. All 3 national ELCIC conferences were cancelled for 2020. Pastor had one interview with Metroland newspaper.

July 16, 2020, Pastor Norine signed a new employment agreement with St. John's, Arnprior and a shared services agreement with St. James. Pre-recording services moved us back into the sanctuary in August and in September we had one outdoor service on the side lawn of the church. In person worship resumed in October, with public health protocols, and approximately 20 people worshipped every Sunday. Oct 25 a joint Reformation Service was held at St. John's with Captain, the Rev. Michael Hackbusch preaching. In November we moved again to live-streaming the services until Christmas Eve. Dec. 26, another provincial lockdown occurred which had us returning to YouTube services once again.

I am sincerely grateful for the support from our members for our ministries over this past year. Each of you have contributed time, talents and financial resources. We have been supported by a very dedicated Church Council and I am thankful for their partnership, support and encouragement. Their faith and their resilience has kept us moving forward, during these unprecedented times.

I pray that God graces us, walking into 2021 together, as we maintain hope in our faith, our common life together, and in our ministries.

## **Children and Family Activity Report**

At the start of 2020, we had many aspirations for what we could for the children and family programming at St. John's. We were contemplating another Vacation Bible School and ordered some excellent teaching resources. Our small, but mighty Sunday School, continued with songs, readings, and crafts. And although February was cold, we had a well-attended Family Fun Day at Zimmerling Free-Run Farms, where snowshoeing, skating, socializing, and holding newborn pygmy goats warmed our bodies and souls.

Several weeks later, the pandemic was in full swing and in-person children and family activities prohibited. But to the extent that it was possible, children still participated in the worship activities. Zach was a reader for the Service that coincided with Father's Day, and Kalin, Jacob and Sawyer were an instrumental part of the Camp Sunday Service. For the Christmas Eve Service, Thomas lit the advent candle, while Madeleine and Alistar placed baby Jesus and the shepherds in the creche. Shortly thereafter, a video of the Nativity Scene from the perspective of the animals was shown featuring the voices of Kalin, Zach, Blake, Nate and Clara.

Heading into 2021, we hope and pray for a return to a life prior to the pandemic. As hard as the pandemic has been on adults, we cannot easily imagine how difficult it has been for children; yes, they are adaptable, but they need to be children and that means socializing and playing

with each other. For those of kindergarten age, they have spent one-quarter of their young lives experiencing the pandemic restrictions.

Thinking of the children, St. John's was awarded a grant for a pilot project called UNPLUG that will give children of different age groups the opportunity to get outdoors and learn about all that nature has to offer us in 2021. A planning team, that includes parents and grandparents has been assembled, so stay tuned for more information about this exciting initiative over the coming months.

Christmas grocery packages were assembled "in house" by volunteers and distributed to registered families as they arrived at the Food Bank. I am pleased to say we exceeded all expectations this year by raising \$860.00 for the purchase of 43 organically grown, free range chickens from Ryan and Julie Zimmerling's family farm. One chicken was given to each family as part of the Food Bank Christmas package. Your financial donations in support of financially struggling families in our community is so very appreciated. Your generosity did not end here. Our Congregation also donated a grand total of \$1917.50 to the Arnprior and District Food Bank. These funds are used to purchase every day items such as milk, eggs, bread.

## **Re-opening Task Force Committee Report**

Team Members: Lorne Rueckwald, Aman Segu and Andy Kalnins

Our goal was to create a staged approach for the resumption of in-person worship while ensuring the safety of the congregation and community.

The committee worked with Synod, Public Health and other Eastern Synod congregations to brain storm and use lessons learned. The Team reviewed existing documentation and guidelines, (Public Health & Synod), to make specific recommendations to Council on what it would take St. John's to re-open. We constantly monitored the ongoing changes released by the government and new health notices as we all learned more about the Covid~19 virus. The Renfrew County Health Unit provided direction and limitations for us to which we had to adhere.

Information that we gathered was prepared and recommendations then passed to Church Council which we believed would ensure the safety of our membership to enable the Church reopening which commenced on Oct. 18, 2020 and continued until the latest provincial shutdown on Dec. 26, 2020.

Numerous changes that we've now become accustomed to are:

Posted essential signage to meet Covid~19 requirements detailing distancing protocols, hand washing procedures, mental health resources, screening requirements, etc. Physical Distancing Poster

Congregations are required to provide training in the following areas:

- Welcoming roles (screening, attendance record, masks, physical distancing and hand sanitizing).
- Communicate changes to entrances/exits and worship space.
- Facilitating movement throughout the service (eg. entry, Holy Communion, exit).

- Ensure that worship leaders will be able to have appropriate physical distance from each other
- Worshippers were encouraged to bring a minimum of personal belongings into the church and stipulated that all belongings must remain with the person at all times.
- All shared items such as brochures, hymnals, Bibles, other books, pew cards, busy bags, soft toys and pencils were removed from pews.
- Hymnals were assigned to members to bring to worship

Worship space was arranged to allow for the following:

- 2 metres of distance (360 degrees) between people/family groups
- Controlled access to facilitate staggered entry and exit.
- Seating restrictions (pews roped off to indicate physical distancing).

Housekeeping is accommodating disinfection of high-touch/shared surfaces before, between and after worship services.

Thank you all for your input and patience as together we safely move forward.

- ➤ Chats and sharing worship over the phone took place, as well as great efforts to ensure taped and live services might be shown in communal home settings.


- Dave Burkett and member reporters kept the Mustard Seed newsletter going and appreciated by many members (45 by email, 20 by hand) and by 'friends of St. John's' (37 by email).
- Technology became our friend, at times a frustrating one, but not a fearful one. The production of and resulting taped and live-streamed services posted on YouTube and with links on our website: stjohnsarnprior.com, featured P+Norine, our faithful readers, visiting pastors and Bishops, varied music with great visuals, and our 'free run' kids on Christmas Eve all thanks to pivoting and Dave's self-taught production and broadcasting skills. - Facebook was a big learning curve for a rare 'personal' poster to this site. Still learning! But, over 9 mo. St. John's Lutheran Church Arnprior page featured some 460 different posts, each generally reaching 10-17 faithful members and local and distant viewers. Posted: All our service texts and videos, solidarity/action items, prayers, photos, music, humour, kid-friendly posts, and news from the broader church, Lutheran World Federation, CLWR, and multifaith bodies.

## **Technology Report**

Immediately after the lockdown in the spring, we quickly scrambled to put together a mechanism to pre-record services, initially using a laptop in Pastor's Study, then gradually, we added more sophisticated equipment (2 video cameras, television, enhanced sound system, a new microphone and various software that lets us produce a quality pre-recorded or live stream of our service. The generosity of the congregation and the successful application for a Synod Technology Grant funded this project. The quality has continually improved over the year and will continue to do so with the addition of accent lighting.

The COVID lockdown for churches began on March 17<sup>th</sup>, 2020. We began producing prerecorded services on YouTube on April 5<sup>th</sup>. Since then, we produced 34 virtual services (combination of pre-recorded, and Live Streamed). On October 18<sup>th</sup> we resumed in-person worship, which ran for 11 Sundays, ending on Dec 24<sup>th</sup>). The average attendance (combined inperson and virtual) was 43, the peaks were: Palm Sunday and Easter, each at 80, Reformation Sunday at 68 and Christmas Eve at 64.



We electronically distribute the Newsletter, the link to the Live Stream or Pre-recorded video and the text of the service to 45 households who are members or frequent visitors. We also distribute to 37 households who are deemed friends of the church.

I would like to thank everyone for their patience, advice, and assistance with this important project.

## **Property Report**

Notwithstanding the lockdown from March until- October that impacted all in person worship services in Ontario we still had a number of completed activities for property related items. During the March shutdown, Paul Mainprize successfully debugged some intermittent telephone line issues. Later in the year, toilet repairs were completed by Gerald F. Rex Zimmerling installed new LED lights above the altar in support of online service viewing and rerouted the internet cable through the wall for our online production capability. Our internet was upgraded to Bell Fibre in support of our overall technology upgrade at no additional monthly cost.

Covid signage and distance markers were installed prior to our first in person worship service in October to comply with local Health Unit guidelines for worship. Additionally, as part of our compliance effort we competed a Covid 19 cleaning policy and procedure for our custodial volunteers and purchased all required special cleaning supplies, disposable gowns and gloves. Special thanks to Gerald and Barbara F. for their continued attention to detail in their cleaning effort.

A number of annual and bi-annual regular maintenance inspections were performed along with any required maintenance including:

- organ inspection and tune-up
- chair lift compliance and maintenance inspection.
- furnaces -annual inspection and recommendation to replace at least 1 furnace over the next 2 years.
- fire extinguishers and emergency lights(replacement of 2 additional sets of lights suggested).
- Two other important pieces of documentation have been created that will require further work and enhancement:
- critical supplier list(internal and external list) with contact information .
- draft emergency evacuation procedure

We have decided to delay future work on the basement foundation water proofing and any inside basement floor renovations until 2022.

## **PAR – Pre-Authorized Remittance Report**

St. John's now has nine families/households signed up for pre-authorized remittance. Once a month their offering is automatically withdrawn from their bank account and deposited into the church's account.

#### This means:

- Especially now, during this time of COVID-19, it reduces unnecessary travel for all members and minimizes risk for volunteers associated with counting activity.
- They no longer need to prepare and bring a completed offering envelope to church each Sunday.
- They do not need to be concerned if they are away on vacation offerings will continue to be received by the church.
- Special offerings, such as Lent or Christmas chickens, can still be given either by etransferring money directly from your bank account to <u>siltreasurer@outlook.com</u> or using a regular envelope and writing your PAR number on it.

- Offerings can be designated to Current, Benevolence or Other (Food Bank, CLWR, etc.) you decide what is best for you.
- There is less cash and cheques for the counters to handle each week.
- Helps council budget and forecast revenues.

If this is something you are interested in, please speak to Randy or me. There is a form to fill out and we require a copy of a voided blank cheque.

Other paperless ways to donate are by e-transferring money to <u>siltreasurer@outlook.com</u> or registering and donating through canadahelps.org. We have accepted money this way for chickens, technology upgrade, current, etc. You can designate where the money is to be spent.

## **Financial Reports**

## **2020 Financial Report**

We have much to be thankful for in our financial results of 2020. Despite the pandemic, where we could not have services in person for a large part of the year, we ended with a surplus of \$3,027 in a year where we had expected a deficit.

That surplus is due to:

- The wonderful generosity of our members and friends in their givings.
- Government grants wage subsidies of about \$5,000. These more than offset the lost fund raising income of \$2,500 compared to 2019.
- Interest of over \$2,000 on investments of our operating reserve with the Evangelical Lutheran Foundation of Eastern Canada.
- Expenses were ~\$4,200 below budget with a reduction in church music, church property and savings in conference fees and other expenses for the Pastor.

St. John's was able to exceed our 2020 commitment to Benevolence by \$201.

Lastly, the item of TR Designated speaks to tax-receipted designated givings for special purposes. The \$2,930 includes special donations for Technology of \$1,810, \$860 for chickens for the Food Bank (see the Outreach report) and \$200 for a new snow blower.

#### 2020 Audit Letter

Jan. 25, 2021

#### To whom it may concern:

The financial review of the income statement and balance sheet for the fiscal year 2020 for St. John's Lutheran Church Arnprior was completed on Jan. 25<sup>th</sup>. Our review this year included auditing 100% of the income from all sources and 92.5% of the value of the total expenditures. In addition, we reconciled and verified the major donation categories to the donation (Donarius) reports. The review included auditing the bookkeeping transactions, and verifying cheques, direct expenses, and deposits to the actual bank statements for the month for which they were incurred. Based on this extensive review and verification, we believe the financial statements to be a fair reflection of the activities related to St. John's Lutheran Church for the year 2020.

#### Observations and Recommendations:

During 2020, the COVID impact changed the business practices and approach to internal controls in several areas. In addition to regular donations via envelopes, members were provided with opportunities to donate by:

- Pre-Authorized Remittance (PAR)
- Bank e-transfer
- Canada Helps

Government COVID subsidies were also applied for and received.

No errors were noted in either the donations recorded or the accounting with respect to the existing methods (envelopes) or new donation vehicles. Both the accountant and the financial secretary are to be congratulated for their attention to detail and accuracy during a difficult period.

While there was not a specific emphasis placed on reviewing internal controls as part of this financial review, there are two observations to be noted:

- During the period from March 15<sup>th</sup> Oct.8<sup>th</sup>, there was only one person (the treasurer) who
  counted and recorded all the donations received at the church and did the bank deposits.
  Normally this function should be performed by two individuals independent to the financial
  activity. 100 percent of these transactions were reviewed and verified as deposits to the bank,
  accounting records, and donation summaries.
- No physical inventory in support of the furniture and equipment value listed on the balance sheet could be found at the time of this review.

#### It is recommended that:

- Wherever possible, two persons not associated with the financial authorizations, accounting, or donation recording, count the offering, prepare the offering summary and do the bank deposits.
- 2. A current inventory be performed, and values be reassessed during 2021.

## **2021 Budget Overview**

#### **Expenses**

- Pastoral Ministry costs increase by 4.4%. That includes:
  - Compensation with a 2.25% cost of living plus an increase of 1% for now serving 15 years of ministry per Synod guidelines.
  - The church Extended Health Plan was re-done, due to significant claims in prior years; they set 3 tiers of possible benefit for congregations to offer, with corresponding deductibles and maximums. We elected to provide Pastor with the middle level (Green); cost for that plan is 5% higher than we paid in 2020.
  - A modest increase in Shared Mileage and other pastoral costs to include paying for the cost of Pastor using a data plan on her phone; that's become a necessary part of the role especially with COVID.
- There are 3 proposed new initiatives in 2021
  - Technology for Worship: This budget includes licence fees for playing the recorded music and 40 weeks for an AV Director @ \$40/ week; these costs are split 85% St. Johns and 15% St. James. Technology brought value in 2020 to the worship experience, not only during while we were closed, but also for in-person services after re-opening. It's become apparent that the workload and stress of running the communications equipment for live streaming is too onerous for church volunteers; an AV Director, hopefully a young, local person, will be a valuable assistant.
  - Youth Ministry: St. John's was very fortunate to receive the full grant requested to run a 6-month pilot back-to-nature worship program (Unplugged) for youth in the greater Arnprior area. Over and above the grant, our 2021 budget includes a continuation of the program with 1 paid part-time staff member for October to December (\$1,045).
  - A program to promote our church to families in the new housing developments in Arnprior (\$500).
- Property expenses (utilities) are expected to revert to more normal levels in 2021.

#### Income

- Income from fund raising is expected to be modest with the continuing pandemic with a budget of \$2,750 the Christmas Bazaar, a fall Spaghetti supper, and another event.
- The budget includes a possible 1 month emergency wage subsidy.
- Member giving's the "ask" is for a 3% increase in giving's to Current and 2.4% to Benevolence for 2021.

#### **Net Income**

With the above assumptions, we anticipate a deficit budget of just under \$2,500, but are hopeful that we may find ways to improve that as the year goes along. At some appropriate point in the year, a nicely worded message will be put on our worship service, with information on how donations can be made by those worshipping "from afar".
