About the Humboldt and Pershing County Courthouses

The Humboldt County and Pershing County Courthouses were both designed by **Frederic Joseph DeLongchamps** (June 2, 1882 – February 11, 1969). He was one of Nevada's most prolific architects yet is notable for entering the architectural profession with no extensive formal training.

The Pershing County Courthouse is believed to be the last round courthouse still in use today. It remains in use despite regular jests about the odds of getting a square deal in a round courthouse. The building has a colorful past, dating back to Feb. 25, 1919, when a bill was introduced by Assemblyman Crofton Uniacke to incorporate Lovelock as the seat of a new county. At the time, Lovelock and what today is Pershing County were part of Humboldt County.

Half a year before, on July 20, 1918, the old Humboldt County Courthouse in nearby Winnemucca burned down. The Humboldt County Courthouse was erected between 1920 and 1921 to replace the original 1874 county courthouse, which had burned. The new courthouse occupies the same site as its predecessor facing Bridge Street, one of the city's first arterials. The interior of the building is the most monumental of DeLongchamps's commissions in Nevada, featuring a sweeping marble staircase and a two-story atrium with iconic columns and a leaded glass ceiling

Many of DeLongchamps' works have been listed on the National Register. DeLongchamps also designed courthouses in Carson City (Ormsby County), Clark County, Douglas County, Washoe County, and Lyon County,

DeLongchamps died in Reno, Nevada on February 11, 1969. He was survived by his son, Galen (08 Aug 1916-22 Jul 2001). He was the father-in-law of the noted poet and artist Joanne de Longchamps (that is how she spelled the name), who married DeLongchamps's adopted son Galen.






