From the Pastor's Pen



I will be continuing my series "Created in God's Image" through February as we look at our Conference's goals for 2020 to encourage that racism is incompatible with God's Teaching. I will then transition in March with the "Created in God's Image" series with a focus on the LGBTQ+ issues that have been controversial within our denomination. We'll be looking to hear from our congregation on these issues by holding a Round Table Discussion Time, following our Worship Service, on March 22. We will meet in the *Prince of Peace Church* Fellowship Hall where a light lunch will be served as we begin discussions. With our Round Table discussion groups, we will be using an approach called World Café. This is a "structured conversational process for knowledge sharing in which groups of people discuss a topic at several tables, with individuals switching tables periodically". I hope people will make this time a priority, because we would like to hear from as many of our members in this experience as possible.

What's Up With the Building? <u>February</u>

We finally got both of the structural engineers that said they would work with us to look at the sanctuary and give us tentative approaches. Briefly, one would utilize pillars, the other would add a large beam anchored to the south wall with more and larger rods going across. Both would start with jacking up the ceiling which would, hopefully, pull in the wall. Both seem to be affordable at least as far as making it safe and sound. The Engineering & Contracting Group will be meeting to discuss all this during the last week in January and pick from the two approaches. From there we hope to consult with the whole Building Committee and the Conference Committee to reach a consensus of how to proceed. As this goes on through the levels of approval, we hope to, at least, get the process going to lift the ceiling back in place as the engineer with the accepted approach prepares the final drawings and specifications.
