NEW BARRHAVEN SENIORS' CENTER - COMMITTEE REPORT NOV. 12, 2025

One major step towards the building of the New Barrhaven Seniors' Center: in late July, Councillor Hill advised us that the City of Ottawa approved the purchase of "1.7-hectare parcel of vacant land located northwest of the future Chapman Mills Drive and Riocan Avenue" and that "the project will include a 15,000 sq. ft. cultural centre with performance and event space, a 3,000 sq. ft. seniors' space, a library branch, a councillor ward office and an urban plaza with a possible water and ice feature."

Targeted Completion date: 2030

- RFQ issued to identify and select a consulting firm that would write the RFP for the design of the Barrhaven Civic Centre closed on July 25th, 2025. It was estimated that it would take app. 2 months to complete the selection process.
- Geotechnical and feasibility studies are on-going.

We met with Councillor Hill and City representatives on July 25th to get an update on the project and followed up with Councillor Hill's office on the following points:

<u>Parking</u>: initial plans/budget for the site include app. 130 parking spots. Covered Parking:

There was a debate for introducing a new covered parking not included in the budget:

- Covered parking will require on-going maintenance costs to be transferred to users through parking fee collection.

We have communicated our concerns with regards to paid parking:

- Paying parking fees for those who regularly attend Seniors' activities would act as a deterrent to participation.
- We noted that the Kanata Seniors Centre, the Nepean Seniors' Centre and our current Ken Ross Building provide free parking.

PLEASE NOTE: no decision was made as the City is waiting for geotechnical analysis results to determine if ground can support such a structure.

Proximity of the proposed LRT station

Close proximity of the LRT station causes concerns that parking spots will be filled by LRT users, thereby limiting access to parking for those wanting to use the facilities of the New Barrhaven City Center and the new Barrhaven Seniors' Center.

We have requested more information as to the location of the proposed LRT station vis-à-vis the New Barrhaven City Centre and, particularly the New Barrhaven Seniors' Centre.

- We want to ensure we have the parking needed for our members.
- We feel it is important that seniors do not get caught in high volume of rushed pedestrian traffic at high level traffic time

As of November 10th, we have not received any information addressing any of the concerns above.

Notes to the Financial Statements

For the Period Ended October 31, 2025

1. Overview

The Barrhaven Seniors' Council continues to operate in a stable financial position with total assets of \$37,416 and no outstanding liabilities as of October 31, 2025. The year-to-date results show a small surplus of \$684. This is in large part from a special pricing received for renting the Ken Ross Building.

2. Understanding the Budget vs. Actual Report

- · Income includes canteen sales, corporate and individual donations, and interest on investments.
- Expenses include activity costs, room rentals, insurance, computer and website expenses, and supplies used to operate programs.
- Budget figures represent planned amounts approved at the beginning of the year, while Actual figures show what has occurred to date.

3. Understanding the Balance Sheet

- Assets represent what the Council owns primarily cash in the bank and GIC investments.
- Liabilities represent what the Council owes this year there are none, showing strong financial health
- Equity (Retained Earnings) represents the Council's accumulated surplus over time and is the result of prudent financial management.

4. Future Outlook

The Council will be applying for The Seniors Community Grant Program from the Government of Ontario before November 30, 2025. If approved, the \$15,000 grant will enable the Barrhaven Seniors' Council to expand the number of services it provides free of charge to seniors in the Barrhaven community. This funding will strengthen the Council's ability to continue offering accessible, community-based programs that promote inclusion, health, and social engagement among seniors.

The board is actively looking at additional services that can be provided and will restricted by the ability to find additional volunteers to run new programs.

5. Summary

The Barrhaven Seniors' Council remains financially sound and well-positioned for 2026. Through continued community support, careful financial management, and renewed grant funding, the Council will maintain and expand the free programs and services that have made it a valued part of Barrhaven's senior community.
