Definition

FAR 61.1.b Cross-country time means:

61.1.b.i Time acquired during flight

61.1.b.i A Conducted by a person who holds a pilot certificate

61.1.b.ii.B That includes a point-of-landing that was at least a straight-line distance of **more** than 50nm from the original departure point

61.1.b.ii.C That involves the use of dead reckoning, pilotage, electronic navigation aids, or other navigation systems to navigate to the landing point
