





A RESOLUTION AUTHORIZING THE MAYOR AND FISCAL OFFICER TO ENTER INTO AN AGREEMENT WITH ROD MCNUFF TO PROVIDE SNOW REMOVAL AND DEICING SERVICES FOR THE VILLAGE OF WAYNE LAKES, DARKE COUNTY, OHIO THRU DECEMBER 31, 2019 AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Wayne Lakes desires to enter into an agreement with ROD MCNUFF for the purpose of snow removal and deicing services for the Village of Wayne Lakes, Darke County, Ohio; and


NOW, THEREFORE, BE IT RESOLVED by the Council for the Village of Wayne Lakes, Darke County, Ohio as follows:

SECTION ONE: The contract for snow removal and deicing services to ROD MCNUFF (as per the attached Exhibit "A") is hereby approved and accepted as stated in the attached proposal.

SECTION TWO: The Mayor and Fiscal Officer are hereby directed and authorized to enter into an agreement with the ROD MCNUFF. (Per the attached Exhibit "A".) The term of this contract shall be for a period of one year from the date first above written.


