WHEREAS, the Council of the Village of Wayne Lakes desires to enter into an agreement with an outside pest control company to provide chemicals, labor, and equipment to help control the mosquitos within the village; and

WHEREAS, the Council of the Village of Wayne Lakes is in receipt of proposed contract from the Bug-A-Boo Pest Control Company for the 2022 year; and

NOW, THEREFORE, BE IT RESOLVED by the Council for the Village of Wayne Lakes, Darke County, Ohio as follows:

SECTION ONE: The contract for the Bug-A-Boo Pest Control (as per attached Exhibit "A") is hereby approved and accepted in the amount of Three hundred ten dollars and no cents (\$310.00) per treatment (May through September).

SECTION TWO: Council declares this to be an emergency measure immediately necessary for the preservation of the public health, safety, and welfare of the Village of Wayne Lakes arising out of the necessity of trying to control the mosquitos within the Village and shall go into effect and be in force from and after the earliest period allowed by law.

MOSQUITO CONTROL CONTRACT / ESTIMATE 2022

AGREEMENT: This estimate is made by and between Village of Wayne Lakes (hereinafter referred to as "City") and Bug A Boo Inc, (hereinafter referred to as "Contractor"), For the year as follows:

SERVICES: Contractor agrees to provide chemicals, labor, and equipment for the fogging of designated areas to Control mosquitos. This service will be provided by Contractor in a safe, expeditious and workmanlike manner, solely as an independent contractor.

DURATION OF CONTRACT: All of the provisions of this contract shall be and remain in full force and effect on an "as needed" basis during the mosquito season (May through September).

COMPENSATION: The total cost of fogging services including labor and all chemicals will be \$310.00 per application.

SCHELUDE: The city shall provide contractor with minimum of 24-hour notice of where and when to render fogging services and Contractor shall provide said services. Service and scheduling are done as requested by city during the hours after dusk and are subject to weather and wind conditions. Fogging is rendered when it is dry and have less wind than 10 mph.
