## **Dear Misty:**

Beginning October 11, 2021, the district starts the re-ratification process of the Darke County Solid Waste District's Updated Plan. This plan update is due to the Ohio EPA at the end of October of this year. An explanation for the re-ratification is in the lower portion of this letter.

This Solid Waste Management Plan Update was prepared by the Darke County Solid Waste Management District Policy Committee to satisfy the requirements of the Ohio Revised Code, the State Solid Waste Management Plan and the Ohio Environmental Protection Agency. In order to prepare this plan, the Darke County Solid Waste Management District Policy Committee evaluated the facilities and programs that the District uses to manage solid waste and to facilitate waste reduction and recycling. This updated plan sets forth a schedule of the facilities and programs that will be used to meet the District's waste management and waste reduction needs for the fifteen-year period from 2022 through 2036.

A draft of this Plan Update was reviewed by Ohio EPA which provided detailed comments. The District Policy Committee reviewed those comments and made appropriate changes in the Plan. Following a public review and comment period (May 21 through June 19, 2021), the District Policy Committee adopted the Plan which is being presented to all entities (the Darke County Commissioners, cities and townships) for ratification.

Each political jurisdiction must vote on the plan by means of a resolution or ordinance. A copy of this plan can be found on the district website at:

After being acted upon, copies of the resolution or ordinance must be delivered to the District's office. Please note the new address: 684 Wagner Avenue, Suite C, Greenville, OH 45331.

The ratification period is 45 days. It begins on October 11, 2021 and ends on November 25, 2021. It is very important that you vote in a timely manner. Failing to vote on the plan within the 45-day period must be counted as "disapproving" the plan.

Key Communities or Townships failure to respond to the first ratification period has led the districts need to ratify the plan again. In order to avoid costly legal fees and having the Ohio EPA write another Darke County Solid Waste District Plan, we ask that you please approve the attached resolution.

In order to be approved the plan update must be approved by the Darke County Commissioners, the City of Greenville (the largest municipality in the jurisdiction of the District), and the legislative authorities of townships and municipalities representing at least 60 percent of the total population in the District's jurisdiction.
