from the Mayor's desk – last from the current mayor, thanks to everyone for a great 9 months. Every Newsletter since April, I've tried to share positive aspects of life in Wayne Lakes, which are many, and the work everyone does to move forward with 'good things continue'; positives regarding the recent acts of vandalism and theft within the Village: Sheriff patrols have been doubled until further notice, an online neighborhood watch group has formed, there should be increased awareness that bad things can still happen in a good place.

The most positive thing that we all can do is **report to the Sheriff office, 548-2020**, any time day or night and as often as needed about everything that has occurred recently or does occur out of normal; dog barking continuously that typically doesn't, security lights come on, car alarm goes off, unusual activities including seeing people out walking around at odd times and cars sitting in unusual places. The Sheriff department has said they would rather come on several calls for nothing than miss the one time to stop criminal activity. For everyone who has been reporting on Facebook, please also make a call to the Sheriff office - today.

At the December meeting, Council elected Linda Clark to be the new President of Council. Effective January 1, 2020, the mayor term I agreed to serve out will end, and so Linda also will serve as Acting Mayor and will facilitate Council meetings beginning with the January 13, 2020 meeting. My thanks to Linda for taking on this interim responsibility, eases my stepping out to know she will be ready to step right in. At the next regular election in November 2020, the Wayne Lakes mayor position will be on the ballot.

At the January 2020 Council meeting, two Council seats will be available for appointment by Council (4-year term for each seat). Anyone willing to serve on Council should attend the January meeting.

The Neave Township Trustees notified us after the December Council meeting, after their meeting scheduled for the same night had ended, that they have decided to not propose a contract for a Village payment to the Township related to the Transfer Station. The Trustees also have stated that they have "no plans but to continue operating the transfer station for the fore-seeable future." Appreciated is the thoughtful consideration the Trustees gave to the subject and their understanding of the duty of the Village administration to be fiscally responsible on behalf of the Village taxpayers.

Council approved a group of volunteers to manage the pop machines, with proceeds to benefit the Village. **The pop machines were vandalized Friday night, 12/13**. Please call the Sheriff if you saw anything related to this incident.

Wayne Lakes Community - Sewer Project Information meeting - Tuesday, December 17, 7:00 pm at the Community Building. The meeting will be hosted by Access Engineering Solutions. Brice Schmitmeyer, president of Access, will provide an update to the community for current status of the project and plans for funding applications and other next steps, including initial billing to begin in 2020. All property owners and residents are encouraged to attend. There will be a summary of what was discussed posted on the Village website, **villageofwaynelakes.com**, after the meeting. If you cannot attend and have questions about the sewer project that you would like to have addressed at the meeting, please email those to mayorwaynelakes@gmail.com. Since the first Wednesday in January 2020 is New Year's Day, the next **FoWL** meeting will be Wednesday, January 8, 7:00pm, at the Community Building. Starting in February **FoWL** meetings will again be the first Wednesday of each month. Donations to **FoWL** directly benefit the Village, can be designated specifically to go to the Village for Village projects, and due to FoWL 501(c)(3) non-profit status can be claimed as a tax deduction.
