"What is going on with the fur barn?"

In January, after having looked for fourteen months for a suitable space for the running of the village, I decided to approach Jim Anderson and see if anything was possible. This was the tentative plan we worked out. Remember, this is NOT what we committed the Village to, this was only what was discussed. **This is not what we did.**

Rent for eight months at \$500 a month with an agreement that the village would attempt to buy between now and Nov. 1st. If by Nov. we had not been able to secure the funds, or a better location was found we were not obligated to buy. Jim just wanted to know our intentions were to attempt to buy, if possible. He was willing to take the building off the market for this time period. If we did not buy the building by Nov. he would resume his business at that time and we would vacate the building. He was also willing to give us a credit of \$300 a month back for part of the down payment. This building is only six years old, is completely up to code, handicap accessible, energy efficient, perfectly located for the village use, grandfathered in for septic at this time, has overhead storage in garage. restroom and two profitable pop machines. He was willing to allow us to take over the contract for those machines. It is reasonably priced at \$129,900. There is space for council meetings to be conducted in comfort and without the acoustic problem (hearing over the fan) with room for more than fifty people. There is space for an office for the mayor and room for the fiscal officer. There is space for meeting rooms. There is a working, heated restroom. The utilities are very low. It is perfect for the village needs for right now and for forty years from now or more. I can see how we would soon be able to utilize all the space. It has a lot in the front that once the sewer is in, if the Village owned the land, could be sold off for a good amount of money. I thought this deal was incredible.

I have asked no less than seven people to consider renting us space for just an office for me. It has never worked out. Jim had worked with me on every point. The garage and the beach have not worked well. Both were only ever to be temporary. Now, we have rented the garage space to the Wayne Lakes Bait Shop to be opened by Bob Weaver in March. He will be selling passes starting then. Stop in and say hello. This is a great advancement for the village. I still need to vacate the beach for spring hopefully so it can be used for its proper purpose. This leaves the only village owned building I have not tried is the clubhouse. I cannot see the clubhouse working in a duel capacity, as it is our most utilized building. I would have no access any time the building was rented. It may also be difficult to keep it secure as many people go in and out at various times often unsupervised. (Cont'd on pg. 2)

Keep in mind we will be having an audit sometime soon. The auditors require a space where they can spread out our papers and still keep them secure. When this happens, they will leave the paperwork out for up to several months. The clubhouse would not be able to be rented during this time. Carolyn, our fiscal officer has been through many audits before. If they do not have a proper facility, they remove your records to an offsite space. She said this makes her job very difficult and she would have a hard time with this.

Most of the responses I have had have been positive. There have been concerns I will try to address here. As mayor, I try to do my due diligence for whatever we are attempting to accomplish. I **always** check everything out with my fiscal officer. Carolyn has had years of experience in this capacity. She is the one, when this first came up, who devised a financial game plan to make it work. She determines if we can manage financially what the mayor and council bring to her. She is in agreement we desperately need an administrative building. We were able to appropriate the funds to get this project started. That is to set up a reasonable way to pay for the renting and the possible buying at a later date of the building.

First, spending money for an administrative building is a "good and proper" use of village funds according to the bank, the bond company and the auditors. We will not have findings from the auditors for buying or renting a facility. We will have a space for Carolyn and me to straighten out 2017 and get all our records in one place. This is one of our findings for 2015-16 audit. Being able to get the records in order will save us money. Right now, these records are all over my house as I have been trying for months to right them and have not had the space to do it.

Second, Carolyn and I both by rights, are allowed to charge for phone, internet and space if we have no office available. Neither one of us has charged a penny. Nor do we intend to. We are allowed to charge a fee for mileage. I have not charged one mile in fourteen months. Although we will in March, when we attend a training conference in Columbus. Carolyn has not paid a single late fee since she took office. We have saved hundreds of dollars just for that.

Third, I have been working on recovering the money owed to the village since the fine for the findings in 2014-15 audit were charged. Tammy Barger our previous fiscal officer and Hylant Insurance were able to come to an agreement of Tammy paying half and Hylant paying Gary Young's half in order for us to recover \$4,210. We have received this check. If I had not pursued this it would still be hovering over our heads, possibly for years. The Attorney General's office would have taken a 20% cut of any money trickling in. This money could be set aside for eight months to pay for the rental of the building without coming out of any regular revenue.

Fourth, we must accumulate all income from the income tax to pay for the Preliminary Engineering Report for the sewer. \$35,000 will be due to Access Engineering if council does not vote the sewer in this Nov. We cannot spend, by law, any of the income tax collected before we have \$35,000 in savings. This is why no progress was made on the sewer last year. We had no way to pay the bill. Now that the income tax has passed, Access has made progress in hiring a boring company to test soils. (We are still looking for one more resident to be in on the talks for the sewer. This will require a bimonthly meeting an hour before council meetings. If you are interested, please call me.) We cannot spend this money on anything else until we have that amount accumulated. In Nov. at the latest, council will vote, and that money will become available to the village if we accept the sewer. The amount needed to pay Access will be rolled into the EPA grants and loans. If the sewer is not accepted, the money saved will be used to pay that loan and we would then vacate the fur barn. Regional Income Tax Agency, the agency collecting our tax, has predicted the first year we will see approximately \$40,000 to \$45,000. My point being that even if it is there, we cannot spend it on anything until Nov. In Nov., it will be too late for the drains or the chemicals or the beach to benefit this year from the income. Next year in 2020 we will not only be seeing an increase in income for the tax up to \$80,000 predicted for second year, we will also have the levy increase (1%) coming in. It was this that made me think we could handle in Nov. the buying of the building, as we would have more than enough for a down payment in the \$35,000 already accumulated. We would have the discount from the renting of the space, and we would be able to "try before we buy" the space. This solves all the pressing problems at a reasonable rental cost without any of the obligation to buy if we cannot afford it in Nov. Plus it is big enough to grow with us. It will be an administrative building not just a temporary office. It will be another asset for the Village. Real estate is one of the only things that usually appreciates in value.

Council decided that they wanted a more conservative approach. The compromise that was made was we would rent the building with a clause of a two month notice on both party's side to vacate if either party wanted to vacate for any reason. Jim then said he could not take the building off the market if we could not commit to at least attempting to buy it in November. Right now, we are only committed to renting this building for two months at a time.

While the timing for the village is somewhat difficult financially, need wise we were in desperate straits for this exact building. This legitimizes us as a government entity, as well as meeting all our needs now and in the future. I know this seems sudden, but I have been trying for fourteen months with no luck for places that were barely suitable. We must "strike while the iron is hot". We must not lose this as an opportunity.

I would like villagers to let your council and myself know what you are thinking.

The March council meeting will be held at the fur barn, 7:00 p.m. There will be a sewer meeting at 6:00 p.m. for all those on this committee.

Cindy Plock is willing to teach a birding class at the fur barn, April 4th at 7:00 p.m. If you are interested, please let me know, sign up at the council meeting, or contact Cindy at 547-0397.

We are still looking for any village resident interested in renting or volunteering to help this spring at the beach. Mayor Ellen Brown

WHAT IS THE NEAVE TOWNSHIP TRANSFER STATION?

The transfer station is where township residents, which includes the homes in Wayne Lakes, are able to take trash 2 times per month for disposal **at no cost.** Neave Township picks up the bill.

When?: The SECOND & LAST Saturday of each month, 8:00 a.m. until NOON.

Where?: Located on St. Rt. 121 just south of Ft. Jefferson on the east side of the road. Follow the vehicles up the lane just to the right of the cemetery to the garbage truck. You can stay in your vehicle and the workers will retrieve the trash for you. All trash is to be bagged.

This is a trash station only, not recycling. Contact RUMPKE for recycling in Darke County.

Wayne Lakes community trash barrels are not for home trash.


