Physiatrist's Role

Physiatrists develop a detailed individualized plan of care that establishes functional goals, provides medical management related to rehabilitation diagnoses, minimizes risk of secondary complications, and works to efficiently and safely transition patients to the most appropriate care setting or community re-integration.



Physiatrists assess patient needs, providing interventions for medical and functional barriers, including:

- DME (Durable Medical Equipment), prosthetic and orthotics evaluations
- Nutrition assessments for optimal blood glucose levels
- Treating depression, pain, spasticity, and tone
- Troubleshooting offloading techniques and adaptive equipment
- Wheelchair modifications (tilt and space use)
- Una boots, compression therapy, lymphedema management
- Gait training, skin checks, bowel and bladder management



Patient Evaluations

Our physiatrists consult within post-acute care settings.

Types of Service Locations:



Skilled Nursing/Assisted Living Facilities

Overseeing functional & medical care, collaborating with the existing interdisciplinary team, with 2-3 patient visits per week as required.



Home Health Care Consultations

Clinical documentation to support therapy, audits, and surveys. Peer-to-peer reviews for insurance denials, home health, and equipment orders.



Prosthetic and Orthotic Evaluations

Ensuring precise documentation and timely PnO services. Patients are continuously monitored for gait training, skin assessments, and resources or additional therapy.



Rehabilitation Outpatient Clinics

Offering joint and trigger point injections to reduce pain and medication use. Providing on-site evaluations for complex patients and promoting evaluations with the rehab team.

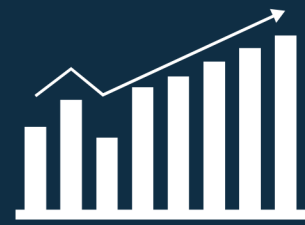

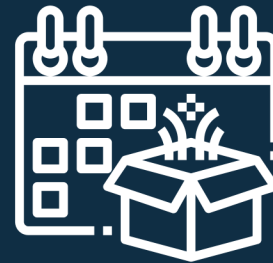
