#### Statement of Intent

The Clinton County Weed Commissioner will function in accordance with the lowa Noxious Weed Law Chapter 317, Code of lowa, 2009, to organize, supervise and coordinate a noxious weed control plan for all properties of Clinton County.

It is the duty of the Clinton County Weed Commissioner to make reasonable inspections on land within the boundaries of Clinton county.

#### Noxious Weed Enforcement

Notification of Property owners failing to control weeds.

Property owners may be given notice personally, by certified mail, by county sheriff, or any other reputable delivery service with conformation of delivery or return delivery receipt, that the weeds deemed noxious must be controlled. If the notice is refused for delivery or remains undeliverable the weed commissioner is authorized to perform the weed destruction on said property. The notice shall include the specific actions required to control weeds found on the property and a specific time frame for completion. If no action is taken to remedy the situation the weed control will be preformed by the county weed commissioner or weed control agency and all costs associated will be billed to property owner pursuant to lowa Code Chapter 317.

When noxious weeds are found these are the steps that will be taken to remedy the situation. A tetter to comply will be sent to the property owner stating the time table for the weed destruction and the steps to control the weeds. If there is failure to comply with the first letter, a second letter will be sent out stating Official Weed Destruction Notice and a time frame with required steps to control the weeds, plus the costs of serving the notice. If there again is failure to comply the Clinton County Weed Commissioner or an agency contracted with the weed commissioner will do the weed control. If the property owner doesn't adhere to the control recommendations set forth by the weed commissioner, the property owner will be sent a letter to abide to the recommendations of the weed commissioner, or the weed commissioner will enter the property to control the noxious weeds. Penalties and costs for failure to comply will be imposed pursuant to towa Code Chapter 317.

#### Weed Control Service Area

Any individual, corporation, municipality, governmental agency, or organization, leasing, or confrolling a property may request the services of the Clinton County Weed Commissioner.

Property owners are encouraged to participate in the weed control process by locating, identifying, and controlling specific infestations on their individual properties.

Clinton County Roadside Management will conduct a roadside noxious weed management control program. The methods of control include, but are not fimited to, spraying, mowing, burning and seeding native grasses where the methods and sites are appropriate. All persons employed by the Roadside Management Department are under the supervision of the Weed Commissioner.

#### NOTICE TO ALL PROPERTY OWNERS AND MANAGERS

#### WEED NOTICE!

Pursuant to the provisions of Chapter 317, Code of Iowa, it is ordered by the Dallas County Board of Supervisors:

That each owner and each person in the possession or control of lands in Dallas County, shall cut or otherwise control all noxious weeds thereon, as defined in this chapter, at such time in each year and in such manner as shall prevent said weeds from blooming or coming to maturity.

That it is recommended that noxious weeds be cut or otherwise controlled on or before the following dates and as often thereafter as is necessary to prevent seed production throughout the growing season. Complaints will be handled as follows: The complaint will not have to be signed and may be phoned at the number below. State the reason for the complaint, the general location of the property, the legal description of the property, the owners of the land and the tenants or persons in control of the land. Forms are available at the Weed Commissioner's office and will be mailed on request.

#### Notice to the Public Noxious Weeds Must Be Destroyed

Notice is hereby given this 23<sup>rd</sup> day of June 2009 pursuant to the 2007 Code of Iowa, Chapter 317, Weeds. BE IT RESOLVED by the Board of Supervisors for Hardin County, lowa: That pursuant to the provisions of Chapter 317, 2009 Code of lowa, it is hereby ordered:

1. That each owner and each person in the possession or control of any land in Hardin County shall control all noxious weeds thereon, as defined in this chapter at such time each year and in such manner as shall prevent said weeds from blooming or coming to maturity, and shall keep such lands from such growths of the weeds as shall render the streets or highways adjoining said lands unsafe for public travel. Noxious weeds shall be cut or otherwise controlled as often as is necessary to prevent seed production. Noxious weeds are:

**PRIMARY NOXIOUS WEEDS:** Quack Grass, Perennial Sow Thistle, Canada Thistle, Bull Thistle, Field Bindweed, Horse Nettle, Leafy Spurge, Hoary Cress (Perennial Pepper-grass), Russian Knapweed, Tall Thistle, Musk Thistle, and Buckthorn.

**SECONDARY NOXIOUS WEEDS**; Wild Mustard, Velvetleaf (Butterprint), Cocklebur, Wild Carrot, Shattercane, Buckthorn Plantain, Red (Sheep) Sorrel, Curly Dock, Smooth Dock, Poison Hemlock, Multiflora Rose, Wild Sunflower, Teasel, Purple Loosestrife, Puncture Vine.

- 2. That each owner and each person in the possession or control of any lands in Hardin County infested with primary noxious weeds shall adopt a program of weed control described by the Weed Commissioner which in five years may be expected to control and will immediately keep under control such infections of said noxious weeds.
- 3. That if owners or persons in possession or control of any lands in Hardin County shall fail to comply with the foregoing orders, the Weed Commissioner shall cause this to be done and the expense of said work including the costs of serving notice and other costs, if any, to be assessed against the real estate on which noxious weeds are controlled.
- 4. That the County Auditor be and is hereby directed to cause notice of the making and entering of the foregoing order by one publication in each of the official newspapers of the county.

#### PROCEDURES FOR INCIDENTS OF NOXIOUS WEED CONTROL FOR HARDIN COUNTY

It is the responsibility of the Weed Commissioner each spring to give to each of the official newspapers of the county a notice of a program of weed control (Code of Iowa, Chapter 317.14).

After a problem with noxious weeds has been identified, contact will be made by the Hardin County Weed Commissioner by phone or face to face with the landowner or person in control of land that has noxious weeds growing in it. The Weed Commissioner will discuss ways that control can be achieved. The landowner will then have approximately ten days to take measures that will correct the problem.

If there has been no action taken after that time, the Weed Commissioner will issue a letter advising the landowner <u>and</u> the person in charge of the land to control the noxious weeds as discussed within ten days. Also a similar letter may be issued the following year without verbal contact if the noxious weeds are a chronic problem and no subsequent actions have been taken to control the situation.

If no attempt to control noxious weeds has been made after ten days, a certified letter will be sent to the landowner containing a notice that if after five days of the certification date there has been a substantial failure of the landowner to control the noxious weeds, the weed commissioner shall hire done the actual work of controlling the noxious weeds (Code of Iowa, Chapters 317.6 and 317.16). The costs of labor and material will be taxed against the real estate on which the noxious weeds are growing. To the total of all sums expended, an amount equal to twenty-five per cent will be added thereof to compensate for the cost of supervision and administration (Code of Iowa, Chapter 317.21).

In the case of noxious weeds on Conservation Reserve Program (CRP) lands, fines will be assessed by the Farm Service Agency (FSA) office in Newton. In all cases, the weeds will still have to be destroyed.
- 4. The Jasper County Auditor is directed to publish this notice in each of the official newspapers in the county.

You are hereby notified to destroy or cause to be destroyed and, as often as necessary, to control the growth, all noxious weeds growing upon your property located within Muscatine County, Iowa, on or before the dates fixed for the destruction of each group of noxious weeds, as stated herein, and that unless you do destroy or cause the same to be destroyed, the Board of Supervisors of Muscatine County, Iowa, will cause said weeds growing upon said lands to be destroyed and the cost thereof to be taxed against said land as provided in Chapter 317.21 of the Code of Iowa and amendment thereto.

The County will spot spray county roadside areas except where there are signs posted that say "DO NOT SPRAY". It will then be the responsibility of the adjacent property owners to destroy said weeds in the posted area.

- June 1, 2009 for Canada thistle, Russian knapweed, buckhorn perennial, wild mustard annual, horse nettle, and teasel biennial.
- 3. June 7, 2009 for field bindweed, wild carrot biennial, and quack grass.
- 4. June 14, 2009 for butterprint annual, puncture vine annual, and cocklebur annual.
- 5. July 12, 2009 for wild sunflower annual and poison hemlock.
- 6. October 4, 2009 all thistles in the rosette stage.

BE IT FURTHER RESOLVED AND ORDERED that all weeds on county trunk and local roads and between the fence lines of such roads, whether they be noxious weeds or other weeds, shall be cut or otherwise destroyed, to prevent seed production, by the owner of the land adjoining the road on or before June 21, 2009.

BE IT FURTHER RESOLVED that weeds that are not destroyed in compliance with the above order may be destroyed by the Weed Commissioner, and the costs of destruction by the Weed Commissioner, including the cost of serving notice, plus a penalty of twenty-five percent of total costs shall be assessed against the property upon which the weeds were destroyed, in the case of private lands, or against the adjoining land, in the case of weeds on county roads. Landowners are to contact Weed Commissioner and notify him if there are areas that should not be sprayed with herbicides.

- 3. This resolution shall also pertain to all state and primary roads and railroad right of way.

If the owner or person in control of any real estate fails to comply with the foregoing order, the Weed Commissioner shall cause this to be done and the expense of said work including costs of serving notice and other costs, if any, shall be taxed against the real estate on which the noxious weeds are destroyed.

The County Auditor is hereby directed to cause notice of the making and entering of the foregoing order to be published once in each of the official newspapers of the County.

This is my annual report written each year for the State of Iowa and Page County Board of Supervisors. This report is to present information on the noxious weed situation in Page County. A copy of this report will also be sent to the state office.

This year I responded to a lesser number of complaints as compared to the last several years. I sent out 6 letters of non-compliance (compared to 13 in 2008, 16 in 2007, and 19 in 2006). One of the six letters was mailed to a first time offender since I have become weed commissioner. I talked to approximately 5 individuals about weed problems that were taken care of without further problems.

Musk Thistles, Canadian Thistles, Sunflowers, Tall Thistle, and Bindweed are noxious weeds that were reported by myself, or a complaint given to me. Musk Thistle and Canadian Thistle were the most common and most complained about. Teasel was first discovered in the county three years ago and these areas have been reduced in size and are currently being managed. Townships in which I had weed complaints were Colfax, Amity, Fremont, Tarkio, Douglas and Harlan.

In closing, I would like to comment that I try very hard to get problems identified early in the season. Watch repeat offenders very closely, and get compliance letters out as soon as possible before weeds become a big problem. I believe that the earlier I get notification out to offenders and the earlier I take care of a problem then the better chance the landowner/renter has at succeeding in taking care of the problem and the more time I have to spray my own weeds in the critical time of the year. Overall, I feel the weed problem has improved greatly over the past 10 years.

- Group 2: June 15, 2009 for Canada Thistle, Russian Knapweed, Buckthorn, Wild Mustard, Multiflora Rose and Teasel.

Group 3: July 15 for European Morning Glory or Field Bindweed; Wild Carrot Biennial, also known as Queen Anne's Lace; Poison Hemlock and Multiflora Rose.

Group 4: July 15 for Horse Nettle; Perennial Sow Thistle; Quack Gras; Butterprint Annual; Cocklebur; Bull Thistle; Wild Sunflower Annual; Teasel Biennial; Puncture Vine Annual; Shattercane Annual and all other species of thistles belonging in genera of Cirsium and Carduus.

- 2) That each owner and each person in the possession or control of land including right of way in Sioux County infested with any noxious weeds listed above shall adopt a program of weed destruction described by the Weed Commissioner which in five years may be expected to destroy and will immediately keep under control such infestations of said noxious weeds.
- 3) That if the owners or persons in possession or control of any land including right of way in Sioux County fail to comply with the foregoing orders, the Weed Commissioner shall cause this to be done and the expense of said work, including cost of serving notice and other costs, if any, to be assessed against the real estate.
- 4) Sioux County has discontinued the Annual Spot Spraying Program of noxious weeds and other weed types growing in Sioux County Secondary Road ditches. It will be the responsibility of each owner and each person in the possession or control of land to destroy said weeds in Sioux County Secondary Road Ditches.
- 5) That the County Auditor be and is hereby directed to cause notice of the making and entering the foregoing order by one publication in each of the official newspapers of the County.

# PUBLIC NOTICE TO ALL JOHNSON COUNTY PROPERTY OWNERS

#### **DESTRUCTION OF NOXIOUS WEEDS**

The Johnson County Weed Commissioner announces that the deadline for destruction of Noxious weeds is **June 1**st, **2019**, so as to prevent the production of seed by all varieties of listed Noxious weeds. This includes weeds on farmlands, Conservation Reserve Program (CRP) lands, properties within city limits, and all lands within the limits of the County. Those persons not controlling their weeds in compliance with Iowa's Weed Law, Code of Iowa Chapter 317 Noxious Weeds, and Iowa Dept. of Agriculture & Land Stewardship Administrative Rules Chapter 58 Noxious Weeds will be notified to use appropriate methods to eradicate or control the weed problem. Failure to do so can incur penalties including, but not limited to, daily fines for non-compliance, and the Weed Commissioner or Deputies entering upon the land to control the weed problem, with all costs, including fines and administrative costs, levied against the landowner. Iowa law provides these assessments can be attached to the real estate tax of the land for collection. Weed eradication/control will still be required to be implemented in all cases where penalties are assessed

The following weeds have been declared Noxious:

Class A Noxious Weeds for Eradication: Palmer Amaranth (*Amaranthus palmeri*) Class B Noxious Weeds for Control:

- a. Canada Thistle (*Cirsium arvense*)
- b. Teasel (Dipsacus spp.) biennial
- c. Leafy Spurge (Euphorbia esula)
- d. Bull Thistle (Cirsium vulgare)
- e. Multiflora Rose (Rosa multiflora)
- f. European Morning Glory or Field Bindweed (Convolvulus arvensis)
- g. All other species of thistles belonging in the Genus of Carduus

At all times: Palmer amaranth must be eradicated. Each owner and each person in possession or control of any lands in Johnson County shall seek cooperation with the United States Department of Agriculture, which may include the department's farm service agency office for that county, the farm service agency's state office, or any other office or official designated by the department, if Palmer Amaranth (*Amaranthus palmeri*)is found on lands enrolled in the conservation reserve program as described in 7 C.F.R. pt. 1410

#### **Notice of Destruction of Noxious Weeds**

To All Property Owners in Mahaska County, IA

You are hereby notified that in accordance with the provisions of Chapter 317 of the Code of Iowa, Chapter 58 of the Iowa Department of Agriculture and Land Stewardship Administrative Code, and amendments thereto; the Board of Supervisors and the appointed Weed Commissioner of Mahaska County, Iowa declare that owners or persons in control of real estate within said county shall **eradicate** all Class A noxious weeds and **control** all Class B noxious weeds

The following recommended dates are guidelines only. All Class A noxious weeds to be eradicated and all Class B noxious weeds to be controlled from Chapter 58 of the Iowa Department of Agriculture and Land Stewardship Administrative Code, 21-58.4(317) are listed below. Measures of control shall take place at such time, in each year, and in such a manner as shall prevent such weeds from blooming or coming to maturity throughout the growing season. Weather conditions may cause weeds to mature several weeks ahead of normal and consequently require control measures prior the listed dates. Any landowner with property under CPR contract with the USDA is encouraged to consult with their local office and must abide by contract requirements.

#### Priority Weed Species as specified by IDALS Admin. Code 58 (2018)

Class A Noxious Weeds for eradication include: May 15, 2019 –Palmer Amaranth

#### Class B Noxious Weeds for control include:

**Group 1:** May 15, 2019 – Musk Thistle and Leafy Spurge

Group 2: June 15, 2019 – Canada Thistle, Common Teasel, and Multiflora Rose

Group 3: June 30, 2019—Field Bindweed, Bull Thistle, and Plumeless Thistle

Other Noxious Weed Species listed in Chapter 317.1(A) to be controlled are:

Quack Grass, Perennial Sow Thistle, Horse Nettle, Perennial Peppergrass, Russian Knapweed, Buckthorn, Butterprint, Cocklebur, Wild Mustard, Wild Carrot, Buckhorn Plantain, Sheep Sorrel, Sour Dock, Smooth dock, Poison Hemlock, Wild Sunflower, Puncture Vine, Shattercane

In case of landowners and tenants failing to comply with an order to destroy weeds made pursuant to Chapter 317, Chapter 58 of the Iowa Department of Agriculture Administrative Code, and amendments thereto, the Weed Commissioner or Deputies assigned by the Weed Commissioner may enter private lands five days after serving a destruction notice in order to conduct control on any weed infestation. The cost of this destruction, the cost of serving notice, and other related costs will be billed. If the bill is not paid, the cost of said destruction will be assessed to the tax roles of the weed violator. Also, the weed commissioner may pose a fine for each day of non-compliance up to ten days at the rate of ten dollars per day.

## NOTICE TO ALL PROPERTY OWNERS AND MANAGERS WEED NOTICE!

Pursuant to the provisions of Chapter 317, Code of Iowa, and Chapter 58 of the Iowa Department of Agriculture and Land Stewardship Administrative Code, it is ordered by the Dallas County Board of Supervisors:

That each owner and each person in the possession or control of lands in Dallas County, shall eradicate all Class A noxious weeds listed in Chapter 58 of the Department of Agriculture and Land Stewardship Administrative Code, 21-58.4(317); and control all Class B noxious weeds thereon, as defined in this chapter, at such time in each year and in such manner as shall prevent said weeds from blooming or coming to maturity.

That it is recommended that all Class A weeds, listed below, be eradicated. All Class B noxious weeds, listed below, shall be controlled before the following dates and as often thereafter as is necessary to prevent seed production throughout the growing season. However, the following dates are guidelines only. Weather conditions may cause weeds to mature several weeks ahead of normal and consequently require control measures prior to the listed dates.

Class A Noxious Weeds: Palmer Amaranth

#### Class B Noxious Weeds:

GROUP 1: May 15, 2018-Musk Thistle

GROUP 2: May 22, 2018-Leafy Spurge

GROUP 3: May 31, 2018-Canada Thistle, Multiflora Rose

**GROUP 4:** June 30, 2018-Field Bindweed, Teasel, Bull Thistle, Plumeless Thistle

That if the owners or persons in possession or control of any land in Dallas County fail to comply with the foregoing orders, the Weed Commissioner shall cause this to be done and the expense of said work including costs of serving notice and other costs, if any, to be assessed against the real estate.

Complaints will be handled as follows: The complaint will not have to be signed and may be phoned in at the number below. State the reason for the complaint, the general location on the property, the legal description of the property, the owners of the land and the tenants or persons in control of the land. Forms are available at the Weed Commissioner's office and will be mailed on request.
