RIDER/PARTICIPANT LIABILITY WAIVER RELEASE FORM

I expressly agree to indemnify and hold Michele Freeman / Hoof to Heart harmless against any and all

claims, demands, damages, rights of action, or causes of action, of any person or entity, that may arise

from injuries or damages sustained by me.

Have been told of the inherent risks of Equestrian sports, activities and

recreation. I understand that I am of my own reasoning engaging in the equine sport and recreation and

activities of my choice currently.

This Massachusetts law provides that an equine activity sponsor, and equine professional, or any other

person shall NOT be liable for an injury to or the death of a participant resulting from the inherent risks

of equine activities an no participant nor participant's representative shall maintain an action against

the equine activity sponsor. The statute sets out several definitions related to equine activities, but

specifically notes that the term "engage in an equine activity" shall not include being a spectator at an

equine activity or event. Except in cases where the spectator places themselves in an unauthorized area

or in immediate proximity to the equine activity. Liability is NOT limited by this statute where the equine

professional knowingly provided faulty tack or equipment, failed to make reasonable and prudent

efforts to determine the ability of the participant to engage safely in the equine activity, owns or

otherwise is in lawful possession of the land or facilities upon which the participant sustained injuries

because of known, dangerous latent conditions, or if they commit an act of omission that constitutes

willful or wanton disregard for the safety of the participant or intentionally injures the participant. The

statute also requires visible displaying of warning signs that alert participants to the limitation of liability

by law.
