SPARTANBURG WINS STATE HIGH SCHOOL TEAM CHAMPIONSHIP AGAIN

Spartanburg High School gave up only one draw in winning their ninth S. C. team Championship in Camden. After the winners'  $7\frac{1}{2}-\frac{1}{2}$  score came Camden and Irmo (6-2), Clover  $(4\frac{1}{2}-3\frac{1}{2})$ , Pacolet (2-4), and Lewisville Middle and Clover Middle (each 1-7). 

CONSTITUTION AND BYLAWS OF THE SOUTH CAROLINA CHESS ASSOCIATION Incorporating Amendments of November, 1973

ARTICLE I - NAME

The name of this organization shall be the South Carolina Chess Association, hereinafter abbreviated SCCA.

ARTICLE II - PURPOSE

The SCCA is an organization of chess players and those interested in chess who reside in the State of South Carolina, and non-residents declared to be members by the Secretary-Treasurer. The purpose of the SCCA is to encourage and foster the playing of chess in South Carolina through tournament and match competition, assistance in local organization, publication of a periodical, and by all other feasible means.

ARTICLE III - MEMBERSHIP AND DUES

A. Any person is eligible to become a member of the SCCA upon application. There shall be no bar to membership for reasons other than immoral character or abuse of membership privileges.

B. 1. There shall be two classes of members, Junior and Senior, both of whom shall have voting privileges. Junior members shall consist of those 18 years of age and younger.

2. Dues for each class of member shall be established by majority vote of those members present at an annual business meeting, and may be altered by a similar vote at any subsequent annual meeting.

ARTICLE IV - GOVERNMENT

A. The government of the SCCA shall be vested in an Executive Committee: a President, a Vice-President, a Secretary, a Treasurer, and the Editor of the SCCA NEWS. Their duties shall be those usual to their offices and any additional duties prescribed herein.

B. Except for the Editor of the SCCA NEWS, who is appointed by the President, the length of term for officers shall be one year. Officers are elected by referendum from the members nominated at the annual business meeting. (Article V) Should the office of President become vacant, the Vice-President assumes the office of President. Vacancies in other offices will be filled by appointment of the President for the unexpired portion of the term only.

C. Any member of the SCCA eligible to vote is eligible to serve as an officer, elected or appointed.

ARTICLE V - MEETINGS .

A. A business meeting of the SCCA shall be held on one of the days the annual closed tournament is being played. The time, place and agenda of the meeting shall be furnished all members a reasonable length of time in advance of the meeting.

B. A special meeting of the organization may be called by the President, provided that each member is notified by mail at least thirty days in advance of the stated time of the meeting.

C. A quorum for SCCA meetings shall consist of fifteen members.

CONSTITUTION AND BYLAGS (OU TIMUED)

D. The rules contained in Robert's <u>Rules of Order</u> shall govern the organization in all cases in which they are not inconsistent with the Constitution and Bylaws of the SCCA.

ARTICLE VI - TOURNAMENTS AND MATCHES

A. The SCCA shall sponsor a closed tournament each year and such other tournaments the organization may decide are practicable.

1. The closed tournament shall be limited to residents of South Carolina; temporary residence, such as that at an educational institution or a military base will qualify a player in this category. The winner of the closed tournament shall be declared South Carolina chess champion. If two or more players tie for first place, they shall be declared co-champions.

B. In keeping with the purpose of the SCCA, the officers of the organization shall be alert and responsive to opportunities and desires for additional tournaments, such as speed tournaments, team tournaments and junior tournaments; interstate and interclub matches, chess exhibitions and chess instruction.

C. The Executive Committee is authorized to arrange dates, locations, schedules, entry fees, prizes, and special conditions for all tournaments, matches, and exhibitions sponsored by SCCA, not inconsistent with Section A.

D. In conducting a SCCA sponsored tournament, the tournament director shall have full charge. He shall be governed by the Laws of Chess of the Federation Internationale des Echecs (FIDE) and of the United States Chess Federation (USCF), except as amended by him and announced to all the players in a meeting in advance of play. In all disputes his decision shall be binding providing it is upheld by a majority of the tournament committee.

E. The tournament director shall have the power to disqualify from the tournament any player, or expel from the playing site any non-player, who violates tournament rules and regulations; interferes in any way with the normal conduct of games in which he is not a contestant; uses the tournament for purposes other than chess, such as solicitation of business; or refuses to abide by the decisions of the tournament director.

F. The director shall appoint an adjudication committee and a tournament committee and explain their duties before play begins.

1. The rate of play for all SCCA tournaments shall be determined by vote prior to beginning of play.

2. No tie-breaking system shall be used to determine final ranking of players in SCCA tournaments, although tie-break points may be used by the tournament director himself and may be used with the published results.

ARTICLE VII - PUBLICATION

A. The SCCA shall publish a periodical at least three times a year. It shall contain announcements, results of chess events, dates for meetings, news items, articles, editorials, games and other material on chess. The publication shall be named SCCA NEWS.

ARTICLE VIII - AFFILIATION

A. The SCCA shall be a franchised affiliate of the United States Chess Federation.

B. USCF membership shall be required of each entrant in a tournament, match or exhibition sponsored or co-sponsored by the SCCA.

ARTICLE IX - AMENDMENT

This Constitution and Bylaws may be amended by a two-thirds vote of the members present at any annual meeting held in accordance with the provisions of Article V.

# EDITORIAL COMMENT

Above are presented our Constitution and Bylaws as compiled by SCCA Secretary Braun following the 1973 annual meeting. Although the amendments at that meeting substantially eliminated obsolete provisions, a few more have turned up and are worth noting.

Article F(1) appears obsolete since time limits are now generally advertised in advance of the event. This rule has generally been ignored and should be removed.

Article VIII. B. has not generally been followed in the case of the High School Team championship, although it was this year. If sponsorsnip of this event is to be continued, it would seem necessary either to require USCF membership or change this rule.

Also, oddly, no provision is made for requiring all participants to be SCCA as well as USCF members. We have also not provided for selecting our USCF Directors, a matter which is now generating much controversy. (See Below)

USOF CONSTITUTION AND BYLAWS COMMITTEE REPORTS

In a newsletter issued last month by the USCF Business Office, the long-awaited report of the USCF Bylaws Revision Committee was presented to the State and Regional USCF officers. The report, which calls for a substantial restructuring of the USCF government, aroused some immediate opposition; two private mailings have so far been sent out in opposition.

The Committee's proposal includes the establishment of a Policy Board composed of six officers; these would be elected for three-year terms on a staggered basis, with two elected each year. Presently the Policy Board consists of three elected officers, the Immediate Past President, and the Executive Director who is a hired staff officer. The proposal also would eliminate the office of Regional Vice-President on the rather also would eliminate the office is mainly titular. The proposal also recognizes the State chess organizations as Chapters of the USCF, and establishes the offices of Secretary and Treasurer as appointive offices similar to that of Executive Director. Opposition to the proposals has concentrated on the following points: (1) That the proposals dilute the power of the offices of President and Vice-President. As this is obviously true and intended, the argument quickly boils down to the question of how many elected officers are desirable.

(2) That direct election of USCF Directors is impractical. It is now impossible, but it appears that with enough work it can be done, by the time of the 1975 election. It will be argued whether the goal justifies this effort and associated expense.

(3) Considerable and rather surprising opposition has arisen to the concept of an appointed Secretary. The stated grounds are that this concentrates too much power in an appointed official. Since these duties are largely mechanical and since the USCF has already seen fit to put great power in the hands of its Executive Director, this argument is hard to credit on its face. It appears more likely that this represents an attack on USCF Secretary Morrison, who also served as Chairman of the Bylaws Revision Committee and who would be the most likely candidate for an appointed Secretary.

The area that is potentially most inflammatory hasn't received much comment yet; this is the relationship of the USCF and its State Affiliate Chapters. The status of the various state affiliates range all the way from very weak to very strong; the SCCA, with somewhat less than half the resident USCF members enrolled, is perhaps on the stronger side relative to the national average. In such important states as California and New York, however, the state organization is rather weak. The committee proposals would give state chapters considerable legitimacy, which some of them do not now enjoy; on the other hand the USCF would assume much more control over them and would eliminate their privilege of naming USCF Directors. This would pass to the USCF members within the state, rather than to the state organization and its members. On balance, it is not likely that most State Affiliates will be anxious for such changes.

USCF members interested in details of the proposals may obtain Policy Board Newsletter #4 from the USCF Business Office. SCCA officers empowered to vote on the proposals include Mssrs. Smith, Millen, and Hyder; they may give proxies if unable to attend the USCF Directors' Meeting.

### CORRESPONDENCE

In light of the above it may be particularly appropriate to excerpt two letters received from Mr. John Roberts of Lexington.

"The individual state affiliations are, in my opinion, the arganizations which should be the backbone of all chess events and matters concerning chess in the state. I agree with the SCCA that state memberships should be required. However, what I am sugresting will be (as far as the chess world is concerned) something out of the year 2001. I would like to see the individual clubs of different areas under control of a state body. Each individual affiliate would pay an annual tithe of some prescribed amount to the state. The state organization would then take this fund and use it to establish regional playing or meeting halls about the state. These nalls would ce, for lack of a better description, chess country
