| Review Only | \$350 Flat Fee | |

*Please note that there is a 3.5% processing fee for all credit or debit card payments.

**Please note that if your County requires payment of a filing fee for QDROs that fee will be in addition to the flat fee rate quoted above. (Dorchester and Beaufort Counties require an additional \$25 filing fee.)

***Please note that the flat fee does not include calculations. Therefore, if your order does not identify the exact \$ amount, %, or formula that is to be included in the QDRO, we charge an additional \$300 per hour for such work. We will inform all parties if your case requires this additional work prior to beginning additional work. Military Orders will usually require additional work and/or calculations.
