Prompted by the bequest of Mr. Blair Coiner and gifts of other generous members of the church, the Session of Tinkling Spring Presbyterian Church established the Tinkling Spring Church Scholarship Fund to assist young people in furthering their education. A bequest of Mr. Paul Simmons has increased the amount of scholarship money available for distribution annually. Disbursements from this fund are available for any post-high school education (including vocational schools, nursing schools, graduate study, etc.). Selections of recipients each year are made by a committee approved by the Session. All scholarship money will be given in the form of a check to the student (rather than the college, university, etc.) and each student is expected to report this scholarship on any of the financial aid application forms which he/she submits. If you are selected as a scholarship recipient for 2024-2025, your notification will be in the mail by August 1, 2024.

Application forms and instruction sheets are now available in the office hallway on the church information board and on the church's website.

All applicants must have official sealed transcripts mailed directly to the Selection Committee from their school's guidance office or registrar's office. No student copies or grade reports will be accepted. Transcripts that are hand-delivered or submitted with the application will not be accepted.

Official transcripts for all applicants must be postmarked by June 30, 2024. Completed applications must be postmarked or placed in the Scholarship mailbox by 6:00 p.m. on July 1, 2024. Late applications and/or official transcripts will not be considered.

Applicants are encouraged to check with Youth and Young Adult Ministries Director, John Dull (540-421-0736), at any time to verify receipt of completed application and transcripts to avoid any errors.

Public announcement will be made of the name of each recipient and of the institution in which he/she plans to attend. No amounts will be announced by the Selection Committee and those receiving scholarships are requested not to reveal the amount. The Selection Committee will decide on who will be assisted and the amount to be given to each. Scholarship checks for 2024-2025 will be sent out as soon as the selected recipients provide written proof of college enrollment to the Treasurer of the Scholarship Fund, Lyle Moffett.
