AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to financial condition and utility billings that we communicated to District management and the Board of Commissioners in a letter dated December 19, 2023. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Dallesport Water District from January 1, 2021 through December 31, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts receivable billing, adjustments, and collections
- Cash receipting voids and adjustments
- Accounts payable general disbursements
- Software conversion utility billing module
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE DISTRICT

The Dallesport Water District, formed in August 2009, provides water services to the Dallesport and Murdock communities in Klickitat County.

An elected, three-member Board of Commissioners governs the District. At the District's December 8, 2010, meeting an agreement was signed transferring ownership of Murdock Water and Mountain View Water Associations to the District. The systems will be owned, managed and operated by the District as individual systems, with independent budgets, improvements and Small Water System Plans. The agreement not only allows the District to aid these systems in seeking water system and fire protection improvements, but also puts the District in a better position for receiving funding that could benefit the entire Dallesport/Murdock peninsula.

The District had total revenues of approximately \$358,105 and \$332,067 in 2021 and 2022, respectively. The District is funded primarily through water sales and services.
