

## DEBRA P. JACKSON TRIBUTE

Channel Marker's beloved Executive Director, leader, visionary, and friend, Debbye Jackson passed away in June 2020 after a long illness. She worked at Channel Marker for more than 35 years in a variety of capacities and was named Executive Director in 2003. A selfless leader and the heart and soul of our Channel Marker family, Debbye instinctively knew the best way to ensure the Mid-Shore's mentally ill population is wellserved was by nurturing a strong and dedicated staff.

A devoted wife and mother who adored her two grandchildren, Debbye was deeply committed to the Waterfowl Festival, co-founded by her father in



1970. She volunteered with the organization since childhood, serving as President, a member of the Board of Directors, and chairing the Festival's Carving Exhibit, among other roles.

Debbye began work at Channel Marker in 1985, working as a unit coordinator, Talbot County coordinator, case management resource coordinator, and program director before being named executive director.

Board member Senator Addie Eckardt said "Debbye led a culture of dedication and loyalty that made her 'a champion.' Her style has been very much one of team leadership, a shared authority and responsibility from the board to the staff to the foundation. Channel Marker is one of the soundest organizations I've worked with that did an amazing turnaround over time."

As she fought through her illness, Debbye soldiered on to pursue a dream of expanding the Caroline County campus to better accommodate youth services. "She was a warrior through that illness and through all things Channel Marker," said Cathy Cassell. "Her work was as important to her as anything in her life."

Our Channel Marker family is fortunate to have had someone as special as Debbye in our lives, and grateful to have shared some of her most inspiring, and selfless moments. Debbye's presence and guidance will be sorrowfully missed by our clients, staff, board of directors, and community.

Channel Marker is grateful for all of the donations and gifts received in Debbye's memory. We will use the donations for a special tribute to honor her life and legacy.

### CASSELL NAMED EXECUTIVE DIRECTOR

The Board of Directors of Channel Marker, Inc., together with the Channel Marker Foundation, is pleased to announce the appointment of 29-year employee Cathy Cassell to Executive Director.

"Cathy has been a leader in the organization for numerous years and has the unanimous support of the Board. Her appointment is part of a succession plan developed by the Board of Directors and Executive Director Debbye



Jackson several years ago," said John McQuaid, President of the Board. "Cathy's understanding of the service delivery system, strong relationships within the statewide advocacy network, and passion for our clients and the agency is making for a smooth transition."

"Cathy was – and is – an integral part of the team that helped build Channel Marker to where it is today. It is only fitting that she continue the legacy of compassion and care for those whom the organization serves," says Tolbert Rowe, Executive Director of Channel Marker Foundation. "Her institutional knowledge is a perfect fit to guide the organization through the challenges the future of mental health care will face."

"The opportunity to lead Channel Marker is very exciting to me; this agency has been my life's work and passion and Debbye taught me so much during my 29 years here," Cassell said. "I can't think of a more critical time when mental health and wellness have become so important. We have a strong team, and I believe that together we can lead the agency through the next challenges and opportunities presented in our profession."

Replacing long-time former Executive Director Debbye Jackson who passed away in June of 2020, after a courageous battle with cancer, Cassell, LCSW-C, began her relationship with Channel Marker in 1991. Since 2002, Cassell has served as Program Director for the agency, where she was responsible for the development and clinical oversight of all behavioral health programming components. She has been instrumental in taking a lead role as the organization earned national accreditation through the Commission on Accreditation of Rehabilitation Facilities, implementation of an electronic health record and data sources to enhance outcome-driven service delivery, and with developing community partners to improve behavioral health integration with physical health care.

Cassell recently completed a four-year term as a member of the Board of Directors for Community Behavioral Health Association of Maryland (CBH) and served on the Executive Committee for CBH. She is a 2011 graduate of Shore Leadership as well as Shore Leadership 2.0, where she also serves on the program committee and was a previous member of the Shore Leadership Executive Committee from 2011–2017. Cassell received her BA in Psychology from Salisbury University and her MSW from the University of Maryland. She is a lifelong resident of Talbot County and lives in Easton with her husband Marty Cassell and their four sons. YOUTH SERVICES RECOGNITION

The pandemic has created challenges in reaching and providing services to clients. As therapist. l've found that the a strong collaboration with Channel Marker over the last helped me stay connected with the families I work has year, with. Our kids are isolated here in Dorchester County, some don't have technology available for consistent telehealth sessions. In those cases, the PRP staff at Channel Marker have gone out to the home to maintain continuity of care, to create plans to overcome barriers to treatment, provide resources, and most importantly, to connect with our most isolated clients, even if it is socially distancing in the client's yard. They've gone the extra mile to find creative ways to help kids manage their stress while at home; dropping off journals and art supplies to my clients to give them an outlet to express themselves. We've all been forced to redefine our role and how we serve our clients, your staff has risen to challenge.

### CHANNEL MARKER PRESENTS THE KEVIN HINES STORY


On September 19, 2019, Channel Marker presented The Kevin Hines Story, an evidenced-based suicide prevention, free-speaking engagement that was open to the public at the Chesapeake College Todd Performing Arts Center. Kevin Hines is a national suicide survivor, public speaker, award-winning documentary filmmaker, and best-selling author.

In the Year 2000, Kevin attempted to take his life by jumping off the Golden Gate Bridge. Many factors contributed to his miraculous survival including a sea lion, which kept him afloat until the Coast Guard arrived. Kevin now travels the world sharing his story of hope, healing, and recovery while teaching people of all ages the art of wellness and the ability to survive pain with true resilience.
